2	(a) 4.; and <i>to create</i> $30.681(1)(b)$ 3. and $30.80(6)(a)$ 4. of the statutes; relating
3	to: raising the age of those persons who may not drive or operate an all-terrain
4	vehicle, motorboat or snowmobile with any alcohol in their blood to the legal
5	drinking age and providing a penalty.
	The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
6	SECTION 1. 23.33 (4c) (a) 3. of the statutes is amended to read:
7	23.33 (4c) (a) 3. (title) 'Operating with alcohol concentrations at specified
8	levels; below age 19 <u>the legal drinking age</u> .' If a person has not attained the age of
9	19 legal drinking age, as defined in s. 125.02 (8m), the person may not engage in the
10	operation of an all-terrain vehicle while he or she has an alcohol concentration of
11	more than 0.0 but not more than 0.1.
12	SECTION 2. 23.33 (13) (b) 4. of the statutes is amended to read:

1	23.33 (13) (b) 4. A person who violates sub. (4c) (a) 3. or (4p) (e) and who has
2	not attained the age of 19 <u>legal</u> drinking age, as defined in s. 125.02 (8m), shall forfeit
3	not more than \$50.
4	SECTION 3. 30.681 (1) (b) 3. of the statutes is created to read:
5	30.681 (1) (b) 3. If a person has not attained the legal drinking age, as defined
6	in s. 125.02 (8m), the person may not engage in the operation of a motorboat while
7	he or she has an alcohol concentration of more than 0.0 but not more than 0.1.
8	SECTION 4. 30.80 (6) (a) 4. of the statutes is created to read:
9	30.80 (6) (a) 4. A person who violates s. 30.681 (1) (b) 3. or 30.684 (5) and who
10	has not attained the legal drinking age, as defined in s. 125.02 (8m), shall forfeit not
11	more than \$50.
12	SECTION 5. 350.101 (1) (c) of the statutes is amended to read:
13	350.101 (1) (c) (title) Operating with alcohol concentrations at specified levels;
14	<i>below age 19 <u>the legal drinking age</u>.</i> If a person has not attained the age of 19 <u>legal</u>
15	drinking age, as defined in s. 125.02 (8m), the person may not engage in the operation
16	of a snowmobile while he or she has an alcohol concentration of more than 0.0 but
17	not more than 0.1.
18	SECTION 6. $350.11(3)(a) 4$. of the statutes is amended to read:
19	350.11 (3) (a) 4. A person who violates s. 350.101 (1) (c) or 350.104 (5) and who
20	has not attained the age of 19 <u>legal drinking age, as defined in s. 125.02 (8m),</u> shall
21	forfeit not more than \$50.
22	SECTION 7. Initial applicability.
23	(1) This act first applies to offenses committed or refusals occurring on the
24	effective date of this subsection, but does not preclude the counting of other
25	convictions, suspensions or revocations as prior convictions, suspensions or

1 revocations for purposes of determining the prohibited alcohol concentration,

2 administrative action by the department of transportation, sentencing by a court or

- 3 revocation or suspension of operating privileges.
