## ASSEMBLY AMENDMENT 3, TO 1997 ASSEMBLY BILL 426

January 8, 1998 – Offered by Representative HANDRICK.

1	At the locations indicated, amend the bill as follows:
2	<b>1.</b> Page 12, line 19: delete lines 19 to 22 and substitute:
3	"SECTION 40g. 30.66 (3) (a) of the statutes is amended to read:
4	30.66 (3) (a) Except <u>as provided</u> under s. 30.69 (3) (d), no person may operate
5	a motorboat within 100 feet of any dock, raft, pier or buoyed restricted area <u>or any</u>
6	shoreline on any lake at a speed in excess of slow-no-wake speed. <u>This paragraph</u>
7	does not apply to personal watercraft.
8	<b>SECTION 40r.</b> 30.66 (3) (b) of the statutes is amended to read:
9	30.66 (3) (b) No Except as provided under s. 30.69 (3) (d), no person may operate
10	a personal watercraft at a speed in excess of slow-no-wake within 100 200 feet of any
11	<u>dock, raft, pier or buoyed restricted area or</u> other boat <u>or any shoreline on any lake</u> .
12	This paragraph does not apply if s. 30.69 (3) (a), (c) or (d) applies to the operation of
13	the personal watercraft.".

4	and that is towing <del>persons <u>a person</u> engaged in water skiing, aquaplaning or similar</del>
5	activity may operate the motorboat within 100 feet of any occupied anchored boat,
6	any personal watercraft or any marked swimming area or public boat landing.
7	<b>SECTION 44h.</b> 30.69 (3) (am) of the statutes is created to read:
8	30.69 (3) (am) No person operating a personal watercraft that is towing a
9	person engaged in water skiing, aquaplaning or similar activity may operate the
10	personal watercraft within 200 feet of any occupied anchored boat, any other
11	personal watercraft or any marked swimming area or public boat landing.
12	<b>SECTION 44p.</b> 30.69 (3) (c) (intro.) of the statutes is amended to read:
13	30.69 (3) (c) (intro.) No person may operate a personal watercraft within $100$
14	<u>200</u> feet of any of the following:
15	<b>SECTION 44t.</b> 30.69 (3) (d) of the statutes is amended to read:
16	30.69 (3) (d) Paragraphs Section $30.66$ (3) (a) and (b) and paragraphs (a) to (c)
17	do not apply to pickup or drop areas that are marked with regulatory markers and
18	that are open to operators of personal watercraft and to persons and motorboats
19	engaged in water skiing.".
20	<b>3.</b> Page 21, line 6: after "30.66 (3) (a)" insert "and (b)".
21	<b>4.</b> Page 21, line 7: after "(bn)," insert "30.69 (3) (a), (am), (c) (intro.) and (d),".
