ASSEMBLY AMENDMENT 2, TO ASSEMBLY SUBSTITUTE AMENDMENT 1, TO 1997 ASSEMBLY BILL 426

March 24, 1998 - Offered by Representative BAUMGART.

1	At the locations indicated, amend the substitute amendment as follows:
2	1. Page 9, line 6: delete lines 6 to 9 and substitute:
3	"SECTION 28b. 30.66 (title) of the statutes is amended to read:
4	30.66 (title) Speed <u>and location</u> restrictions.
5	SECTION 28f. 30.66 (3) (a) of the statutes is renumbered 30.66 (3) and amended
6	to read:
7	30.66 (3) (title) Prohibited operation; motorboats other than personal
8	WATERCRAFT. Except under as provided in s. 30.69 (3) (d), no person may operate a
9	motorboat within 100 feet of any <u>shoreline</u> , dock, raft, pier or buoyed restricted area
10	on any lake at a speed in excess of slow-no-wake speed. <u>This subsection does not</u>
11	<u>apply to personal watercraft.</u>

1	SECTION 28j. 30.66 (3) (b) of the statutes is renumbered 30.66 (3m) (b) and
2	amended to read:
3	30.66 (3m) (b) No Except as provided in s. 30.69 (3) (d), on a lake that is more
4	than 300 acres in size, no person may operate a personal watercraft at a speed in
5	excess of slow-no-wake within 100 feet of any other boat. This paragraph does not
6	apply if s. 30.69 (3) (a), (c) or (d) applies to the operation of the personal watercraft
7	or within 100 feet of any shoreline, dock, raft, pier or buoyed restricted area.
8	SECTION 28m. 30.66 (3m) (title) of the statutes is created to read:
9	30.66 (3m) (title) PROHIBITED OPERATION; PERSONAL WATERCRAFT.
10	SECTION 28p. 30.66 (3m) (a) of the statutes is created to read:
11	30.66 (3m) (a) No person may operate a personal watercraft on any river or on
12	any lake that is 300 acres or less in size.".
13	2. Page 10, line 9: after that line insert:
14	"SECTION 32m. 30.69 (3) (d) of the statutes is amended to read:
15	30.69 (3) (d) Paragraphs Section 30.66 (3) and (3m) (b) and pars. (a) to (c) do
16	not apply to pickup or drop areas that are marked with regulatory markers and that
17	are open to operators of personal watercraft and to persons and motorboats engaged
18	in water skiing.".
19	3. Page 16, line 16: delete "30.66 (3) (a)" and substitute "30.66 (title), (3) (a) and
20	(b) and (3m) (title) and (a)".
21	4. Page 16, line 16: before "30.80 (6) (c)" insert "30.69 (3) (d),".
