**SENATE AMENDMENT 3,
TO 1997 ASSEMBLY BILL 631**

April 28, 1998 – Offered by Senator C. POTTER.

1 At the locations indicated, amend the bill, as shown by assembly substitute
2 amendment 1, as follows:

3 **1.** Page 2, line 25: after that line insert:

4 “**SECTION 4m.** 118.40 (1m) (b) 14m. of the statutes is created to read:

5 118.40 **(1m)** (b) 14m. The rights and responsibilities of the parties to a charter
6 school contract if the charter school contract is revoked under sub. (5).”.

7 **2.** Page 3, line 5: after that line insert:

8 “**SECTION 5m.** 118.40 (2r) (b) of the statutes, as created by 1997 Wisconsin Act
9 27, is amended to read:

10 118.40 **(2r)** (b) The common council of the city of Milwaukee, the chancellor of
11 the University of Wisconsin–Milwaukee and the Milwaukee area technical college
12 district board may establish by charter and operate a charter school or, on behalf of
13 their respective entities, may initiate a contract with an individual or group to

1 operate a school as a charter school. A charter shall include all of the provisions
2 specified under sub. (1m) (b) 3. to 14. A contract shall include all of the provisions
3 specified under sub. (1m) (b) 1. to ~~14.~~ 14m. and shall specify the effect of the
4 establishment of the charter school on the liability of the contracting entity under
5 this paragraph. The contract may include other provisions agreed to by the parties.
6 The chancellor of the University of Wisconsin-Milwaukee may not establish or enter
7 into a contract for the establishment of a charter school under this paragraph
8 without the approval of the board of regents of the University of Wisconsin System.

9 **SECTION 5r.** 118.40 (3) (b) of the statutes, as affected by 1997 Wisconsin Act 27,
10 is amended to read:

11 118.40 (3) (b) A contract under par. (a) or under subs. (2m) or (2r) may be for
12 any term not exceeding ~~5~~ 2 school years and may be renewed for one or more terms
13 not exceeding ~~5~~ 2 school years. The contract shall specify the amount to be paid to
14 the charter school during each school year of the contract.”.

15 **3.** Page 4, line 7: after that line insert:

16 “(2m) The treatment of section 118.40 (1m) (b) 14m. and (3) (b) of the statutes
17 first applies to charter school contracts that are entered into, extended, modified or
18 renewed on the effective date of this subsection.”.

19 **4.** Page 4, line 10: after “(3)” insert “(b) and”.

20 **5.** Page 4, line 10: delete “statutes takes” and substitute “statutes and SECTION
21 9 (2m) of this act take”.
