***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

14 **SECTION 1.** 15.377 (1) of the statutes, as affected by 1997 Wisconsin Act 27, is  
15 amended to read:

16 15.377 (1) COUNCIL ON THE EDUCATION OF THE BLIND. There is created in the  
17 department of public instruction a council on the education of the blind consisting  
18 of 3 members, who shall ~~be visually handicapped~~ have a visual impairment and shall  
19 have a recognized interest in and a demonstrated knowledge of the problems of the  
20 ~~visually handicapped children who have visual impairments~~, appointed by the state  
21 superintendent of public instruction for staggered 6-year terms. “~~Visually~~  
22 handicapped” “Visual impairment” means having a) a visual acuity equal to or less  
23 than 20/70 in the better eye with correcting lenses, or b) a visual acuity greater than

1 20/70 in the better eye with correcting lenses, but accompanied by a limitation in the  
2 field of vision such that the widest diameter of the visual field subtends an angle no  
3 greater than 20 degrees.

4 **SECTION 2.** 15.377 (4) of the statutes, as affected by 1997 Wisconsin Act 27, is  
5 repealed and recreated to read:

6 15.377 (4) COUNCIL ON SPECIAL EDUCATION. There is created in the department  
7 of public instruction a council on special education to advise the state superintendent  
8 of public instruction about the unmet educational needs of children with disabilities,  
9 in developing evaluations and reporting on data to the federal department of  
10 education, in developing plans to address findings identified in federal monitoring  
11 reports, in developing and implementing policies relating to the coordination of  
12 services for children with disabilities and on any other matters upon which the state  
13 superintendent wishes the council's opinion; and to comment publicly on any rules  
14 proposed by the department of public instruction regarding the education of children  
15 with disabilities. The state superintendent of public instruction shall appoint the  
16 members of the council for 3-year terms, and shall ensure that a majority of the  
17 members are individuals with disabilities or parents of children with disabilities and  
18 that the council is representative of the state population, as determined by the state  
19 superintendent. The council shall be composed of individuals who are involved in,  
20 or concerned with, the education of children with disabilities, including all of the  
21 following:

22 (a) Teachers of regular education and teachers of special education.

23 (b) Representatives of institutions of higher education that train special  
24 education and related services personnel.

25 (c) State and local education officials.

1 (d) Administrators of programs for children with disabilities.

2 (e) Representatives of agencies other than the department of public instruction  
3 involved in the financing or delivery of related services to children with disabilities.

4 (f) Representatives of private schools and charter schools.

5 (g) At least one representative of a vocational, community or business  
6 organization that provides transition services for children with disabilities.

7 (h) Representatives from the department of corrections.

8 (i) Parents of children with disabilities.

9 (j) Individuals with disabilities.

10 **SECTION 3.** 20.255 (1) (d) of the statutes is amended to read:

14          state may contract public debt in an amount not to exceed \$7,367,700 for this  
15          purpose.

25          charge tuition for children served in the model school. Tuition charges made under

5 (3) "Child" means any person who is at least 3 years old but not yet 22 years  
6 old and who has not graduated from high school.

7 (4) "Child caring institution" means a child welfare agency licensed under s.  
8 48.60.

9 (5) (a) "Child with a disability" means a child who, by reason of any of the  
10 following, needs special education and related services:

- 11 1. Cognitive disabilities.
- 12 2. Hearing impairments.
- 13 3. Speech or language impairments.
- 14 4. Visual impairments.
- 15 5. Emotional disturbance.
- 16 6. Orthopedic impairments.
- 17 7. Autism.
- 18 8. Traumatic brain injury.
- 19 9. Other health impairments.
- 20 10. Learning disabilities.

21 (b) "Child with a disability" may, at the discretion of the local educational  
22 agency and consistent with department rules, include a child who, by reason of his  
23 or her significant developmental delay, needs special education and related services.

24 (6) "Division" means the division for learning support, equity and advocacy in  
25 the department.

1           **(7)** “Free appropriate public education” means special education and related  
2 services that are provided at public expense and under public supervision and  
3 direction, meet the standards of the department, include an appropriate preschool,  
4 elementary or secondary school education and are provided in conformity with an  
5 individualized education program.

6           **(8)** “Hearing officer” means an independent examiner appointed to conduct  
7 hearings under s. 115.80.

8           **(9)** “Individualized education program” means a written statement for a child  
9 with a disability that is developed, reviewed and revised in accordance with s.  
10 115.787.

11           **(10)** “Local educational agency”, except as otherwise provided, means the  
12 school district in which the child with a disability resides, or the department of health  
13 and family services or the department of corrections if such department is  
14 responsible for providing a free appropriate public education to the child.

15           **(11)** “Native language”, when used with reference to an individual of limited  
16 English proficiency, means the language normally used by the individual.

17           **(12)** “Parent” means a biological parent; a husband who has consented to the  
18 artificial insemination of his wife under s. 891.40; a male who is presumed to be the  
19 child’s father under s. 891.41; a male who has been adjudicated the child’s father  
20 under subch. VIII of ch. 48, under ss. 767.45 to 767.51, by final order or judgment of  
21 an Indian tribal court of competent jurisdiction or by final order or judgment of a  
22 court of competent jurisdiction in another state; an adoptive parent; a legal guardian;  
23 a person acting as a parent of a child; a person appointed as a sustaining parent  
24 under s. 48.428; or a person assigned as a surrogate parent under s. 115.792 (1) (a)  
25 2. “Parent” does not include any person whose parental rights have been terminated;

1 the state or a county or a child welfare agency if a child was made a ward of the state  
2 or a county or child welfare agency under ch. 880 or if a child has been placed in the  
3 legal custody or guardianship of the state or a county or a child welfare agency under  
4 ch. 48 or ch. 767; or an American Indian tribal agency if the child was made a ward  
5 of the agency or placed in the legal custody or guardianship of the agency.

6 **(13)** “Person acting as a parent of a child” means a relative of the child or a  
7 private individual allowed to act as a parent of a child by the child’s biological or  
8 adoptive parents or guardian, and includes the child’s grandparent, neighbor, friend  
9 or private individual caring for the child with the explicit or tacit approval of the  
10 child’s biological or adoptive parents or guardian. “Person acting as a parent of a  
11 child” does not include any person that receives public funds to care for the child if  
12 such funds exceed the cost of such care.

13 **(14)** “Related services” means transportation and such developmental,  
14 corrective and other supportive services as may be required to assist a child with a  
15 disability to benefit from special education, including speech–language pathology  
16 and audiology services; psychological services; physical and occupational therapy;  
17 recreation, including therapeutic recreation; social work services; counseling  
18 services, including rehabilitative counseling; orientation and mobility services;  
19 medical services for diagnostic and evaluative purposes only; and the early  
20 identification and assessment of disabling conditions in children.

21 **(15)** “Special education” means specially designed instruction, regardless of  
22 where the instruction is conducted, that is provided at no cost to the child or the  
23 child’s parents, to meet the unique needs of a child with a disability, including  
24 instruction in physical education.

1           **(16)** “Supplementary aids and services” means aids, services and other  
2 supports that are provided in regular education classes or other education-related  
3 settings to enable a child with a disability to be educated with nondisabled children  
4 to the maximum extent appropriate.

5           **(17)** “Transition services” has the meaning given in 20 USC 1401 (30).

6           **115.762 Division for learning support, equity and advocacy. (1)**

7           APPOINTMENT OF ADMINISTRATOR. The state superintendent shall appoint the  
8 administrator of the division.

9           **(2) STAFF.** Subject to the approval of the state superintendent, the  
10 administrator of the division shall appoint qualified staff necessary to perform the  
11 duties required of the division.

12           **(3) DIVISION DUTIES.** The division is responsible for all of the following:

13           (a) Ensuring that all children with disabilities, including children who are not  
14 yet 3 years of age, who reside in this state and who are in need of special education  
15 and related services are identified, located and evaluated.

16           (am) Ensuring that a free appropriate public education is available to all  
17 children with disabilities who reside in this state, including such children who are  
18 suspended or expelled from school.

19           (b) Developing and implementing a practical method to determine which  
20 children with disabilities are receiving special education and related services.

21           (c) Complying with the requirements of this subchapter and applicable federal  
22 law, including 20 USC 1415 (k).

23           (d) Coordinating and supervising the provision of all publicly funded special  
24 education and related services for children with disabilities in this state and  
25 ensuring that such education and services meet the educational standards of the

1 department, including any criteria established by the department relating to  
2 enrollment.

3 (e) Pursuant to s. 115.77 (4), approving the plan for the provision of all special  
4 education and related services provided by a local educational agency.

5 (g) Monitoring and enforcing local educational agency and child caring  
6 institution compliance with this subchapter and applicable federal law, including 20  
7 USC 1415 (k).

8 (h) Maintaining current information on all publicly funded special education  
9 and related services within this state and making this information public.

10 (i) Coordinating a comprehensive system of personnel development that is  
11 designed to ensure an adequate supply of qualified special education, regular  
12 education and related services personnel and that meets the requirements of  
13 applicable federal law, including participation, as appropriate, by institutions of  
14 higher education, state and local agencies and other public and private  
15 organizations.

16 (j) Examining data to determine if significant discrepancies are occurring in  
17 the rate of long-term suspensions and expulsions of children with disabilities among  
18 local educational agencies or compared to such rates for nondisabled children within  
19 such agencies. If such discrepancies are occurring, the division shall review and, if  
20 appropriate, revise or require the affected local educational agency to revise its  
21 policies, procedures and practices relating to the development and implementation  
22 of individualized education programs, the use of behavioral interventions and  
23 procedural safeguards to ensure that such policies, procedures and practices comply  
24 with this subchapter.

1           **(4) LIMITATION.** Nothing in this subchapter requires that special education and  
2 related services be provided to a child with a disability who is at least 18 years old  
3 but not yet 22 years old and who, in the child’s educational placement before his or  
4 her incarceration in a state prison, was not identified as a child with a disability or  
5 for whom an individualized education program was not developed.

6           **115.77 Local educational agency duties. (1)** In sub. (1m) (a) to (d), except  
7 as provided in s. 118.51 (12) (a) and (b) 2., if a child with a disability is attending a  
8 public school in a nonresident school district under s. 118.51, “local educational  
9 agency” means the school district that the child is attending.

10           **(1m)** A local educational agency shall demonstrate to the satisfaction of the  
11 division that it does all of the following:

12           (a) Identifies, locates and evaluates all children with disabilities who are in  
13 need of special education and related services, including such children who are not  
14 yet 3 years of age. A local educational agency may provide special education and  
15 related services to children with disabilities who are not yet 3 years of age under an  
16 interagency agreement with a county agency responsible for the early intervention  
17 program under s. 51.44.

18           (b) Makes available a free appropriate public education to children with  
19 disabilities as required by this subchapter and applicable state and federal law.

20           (bg) Includes children with disabilities in statewide and local educational  
21 agency-wide assessments, with appropriate modifications where necessary, or in  
22 alternative assessments for those children who cannot participate in statewide or  
23 local educational agency-wide assessments.

24           (c) Ensures that children participating in early intervention programs under  
25 s. 51.44 who will participate in preschool programs assisted under this subchapter

1 experience a smooth and effective transition to those preschool programs and that,  
2 by the 3rd birthday of such a child, an individualized education program has been  
3 developed and is being implemented for the child. The local educational agency shall  
4 participate in transition planning conferences arranged by the county  
5 administrative agency, as defined in s. HFS 90.03 (10), Wis. adm. code.

6 (d) Ensures that children with disabilities who are enrolled in private schools  
7 and facilities are provided special education and related services, in accordance with  
8 individualized education programs, at no cost to them or to their parents, if such  
9 children are placed in, or referred to, such schools or facilities by a local educational  
10 agency to satisfy the requirements of this subchapter or applicable federal law.

11 (e) To the extent consistent with the number and location of children with  
12 disabilities residing in the local educational agency who are enrolled by their parents  
13 in private elementary and secondary schools, ensures that those children have an  
14 opportunity to participate in special education and related services and that the  
15 amount spent to provide those services by the local educational agency is equal to a  
16 proportionate amount of federal funds made available under this subchapter.

17 (f) Establishes written policies and procedures for implementing this  
18 subchapter and applicable federal law.

19 (g) Makes available to any person, upon request, all documents relating to the  
20 agency's eligibility for funds under this subchapter.

21 (h) Regularly publicizes information regarding its special education  
22 procedures and services.

23 **(2)** The local educational agency shall provide the division with information  
24 necessary to enable the division to carry out its duties under this subchapter and  
25 applicable federal law.



1           **(3)** Any state or federal aid that is made available to a local educational agency  
2 for special education and related services shall be used by the local educational  
3 agency to comply with this subchapter.

4           **(4)** A local educational agency shall submit to the division, pursuant to a  
5 schedule and instructions established and published by the division, the agency's  
6 plan, including a program narrative, for the provision of special education and  
7 related services that includes all of the following:

8           (a) The extent to which special education and related services is or is not  
9 organized around particular disabilities.

10          (b) The licensure and other preparation or experience of special education staff.

11          (c) The age ranges of pupils who are children with disabilities.

12          (d) The range of severity of disability among children with disabilities.

13          (e) The ratio of pupils to full-time equivalent staff, including both the ratio of  
14 pupils assigned to special education instructional and related services staff and to  
15 total special education instructional, support and administrative staff.

16          (f) The way parents participate in the development and review of the plan.

17          (g) The extent to which children with disabilities receive special education or  
18 related services beyond the school term.

19          (h) The way the local educational agency provides for a continuum of  
20 alternative placements that addresses the unique needs of children with disabilities  
21 and ensures that such children receive their educational programming in the least  
22 restrictive environment, including the agency's use of placements out of the agency  
23 and out of the state and private placements.

1 (i) The local educational agency’s plan for employing qualified special  
2 education and related services staff, evaluating its staff’s special education  
3 in-service needs and the plan for meeting those needs.

4 (j) The local educational agency’s plan for evaluating its system for the design  
5 and delivery of special education and related services and for addressing any needs  
6 that are identified by the evaluation, including all of the following:

7 1. The local educational agency’s graduation rate for children with disabilities  
8 and how the rate compares to the agency’s graduation rate for nondisabled children.

9 2. The local educational agency’s rate of suspension and expulsion of children  
10 with disabilities and how the rate compares to the agency’s rate of suspension and  
11 expulsion of nondisabled children.

12 3. The local educational agency’s overall incidence rate of children with  
13 disabilities and the agency’s incidence rates of particular disabilities.

14 4. The rate of participation of the local educational agency’s children with  
15 disabilities in statewide and local educational agency-wide assessments and the  
16 results of those assessments.

17 5. The rate of participation of the local educational agency’s children with  
18 disabilities in alternative assessments and the results of those assessments.

19 6. The number of referrals under s. 115.777 and the percentage of those  
20 referrals resulting in the provision of special education and related services.

21 7. The number of children with disabilities placed in appropriate, interim,  
22 alternative educational settings under 20 USC 1415 (k) (1) (A) (ii).

23 8. General information about the satisfaction of parents of children with  
24 disabilities and adult pupils who are receiving special education and related services  
25 with special education and related services.

1           9. General information about persons who no longer attend high school and  
2 who received special education and related services provided by the local educational  
3 agency, such as whether they are employed, are living independently and are  
4 enrolled in postsecondary education.

5           10. If the local educational agency is a school district, the number of children  
6 with disabilities who attend the school district under s. 118.51, the disability of each  
7 such child and the special education or related services received by each such child.

8           (k) A roster of all of the agency's special education and related services staff,  
9 their function, their social security numbers and their special education licensure.

10          (L) Statements of assurance as required by applicable federal law.

11          (m) Information relating to access of private school pupils to the local  
12 educational agency's special education and related services.

13          (n) Any other information the division requires to permit its review and  
14 approval of the plan.

15          **(7)** Annually, the local educational agency shall provide a special education  
16 performance report to all parents of children enrolled in the local educational agency  
17 and to the division that includes the local educational agency's performance with  
18 regard to the factors referenced in the agency's evaluation of its plan under sub. (4)  
19 (j) as well as the statewide average with regard to factors in sub. (4) (j) 1. to 5.

20          **(8)** The local educational agency shall serve children with disabilities who are  
21 attending a charter school under contract with the local educational agency under  
22 s. 118.40 in the same manner as it serves children with disabilities attending schools  
23 of the local educational agency, and shall provide funds under this subchapter to such  
24 charter schools in the same manner as it provides funds under this subchapter to  
25 schools of the local educational agency.

1           **(9)** The local educational agency shall exercise its authority in compliance with  
2 20 USC 1415 (k).

3           **115.777 Special education referrals.** **(1)** (a) A physician, nurse,  
4 psychologist, social worker or administrator of a social agency who reasonably  
5 believes that a child brought to him or her for services has a disability shall refer the  
6 child to the local educational agency. If the local educational agency to whom the  
7 referral is made is the school district in which the child resides but the child is  
8 attending a public school in a nonresident school district under s. 118.51, the school  
9 board of the school district in which the child resides shall provide the name of the  
10 child and related information to the school board of the school district that the child  
11 is attending.

12           (b) A person who is required to be licensed under s. 115.28 (7), who is employed  
13 by a local educational agency and who reasonably believes a child has a disability,  
14 shall refer the child to the local educational agency. If the local educational agency  
15 to whom the referral is made is the school district that the child is attending but the  
16 child is a nonresident attending a public school in that school district under s. 118.51,  
17 the school board of the school district that the child is attending shall provide the  
18 name of the child and related information to the school board of the child's school  
19 district of residence.

20           (c) Any person other than those specified under par. (a) or (b) who reasonably  
21 believes that a child is a child with a disability may refer the child to a local  
22 educational agency. If the local educational agency to whom the referral is made is  
23 the school district in which the child resides but the child is attending a public school  
24 in a nonresident school district under s. 118.51, the school board of the school district

1 in which the child resides shall provide the name of the child and related information  
2 to the school board of the school district that the child is attending.

3 (2) (a) All referrals shall be in writing and shall include the name of the child  
4 and the reasons why the person believes that the child is a child with a disability.

5 (b) Before submitting a referral to a local educational agency under sub. (1) (a)  
6 or (b), a person required to make a referral under sub. (1) (a) or (b) shall inform the  
7 child's parent that he or she is going to submit the referral.

8 (3) A local educational agency shall do all of the following:

9 (a) Establish written procedures for accepting and processing referrals.

10 (b) Document and date the receipt of each referral.

11 (c) Provide information and in-service opportunities to all of its licensed staff  
12 to familiarize them with the agency's referral procedures.

13 (d) At least annually, inform parents and persons required to make referrals  
14 under sub. (1) (a) about the agency's referral and evaluation procedures.

15 **115.78 Individualized education program team; timeline. (1)**

16 DEFINITION. In this section, for a child who is attending a public school in a  
17 nonresident school district under s. 118.51, "local educational agency" means the  
18 school board of the school district that the child is attending.

19 (1m) APPOINTMENT OF TEAM. The local educational agency shall appoint an  
20 individualized education program team for each child referred to it under s. 115.777.

21 Each team shall consist of all of the following:

22 (a) The parents of the child.

23 (b) At least one regular education teacher of the child if the child is, or may be,  
24 participating in a regular educational environment.

1 (c) At least one special education teacher who has extensive and recent training  
2 and experience related to the child's known or suspected disability as specified in s.  
3 115.76 (5) (a) or, where appropriate, at least one special education provider of the  
4 child.

5 (d) A representative of the local educational agency who is qualified to provide,  
6 or supervise the provision of, special education, is knowledgeable about the general  
7 curriculum and is knowledgeable about and authorized to commit the available  
8 resources of the local educational agency.

9 (e) An individual who can interpret the instructional implications of evaluation  
10 results, who may be a team participant under pars. (b) to (d) or (f).

11 (f) At the discretion of the parent or the local educational agency, other  
12 individuals who have knowledge or special expertise about the child, including  
13 related services personnel as appropriate.

14 (g) Whenever appropriate, the child.

15 **(2) DUTIES OF TEAM.** The individualized education program team shall do all of  
16 the following:

17 (a) Evaluate the child under s. 115.782 to determine the child's eligibility or  
18 continued eligibility for special education and related services and the educational  
19 needs of the child.

20 (b) Develop an individualized education program for the child under s. 115.787.

21 (c) Determine the special education placement for the child under s. 115.79.

22 **(3) TIMELINE.** (a) The local educational agency shall notify the parents of the  
23 educational placement of their child within 90 days after the local educational  
24 agency receives a special education referral for the child under s. 115.777 or initiates  
25 a reevaluation of the child under s. 115.782 (4).

1 (b) Before the expiration of the 90-day period, if a local educational agency  
2 needs an extension, it shall inform the child's parent of the need and reasons for an  
3 extension and request the child's parent to agree in writing to a specific extension of  
4 time beyond the 90-day period.

5 (c) If the parent does not agree to an extension, the local educational agency  
6 may request an extension from the division. The local educational agency shall  
7 inform the division of the reasons for the request. The division may grant a specific  
8 extension of time beyond the 90-day period if the local educational agency shows that  
9 it has acted in good faith and that there is good cause to grant the extension. If the  
10 division grants an extension, it shall notify the parent of the extension and the  
11 reasons for granting it.

12 (d) Subject to pars. (a) to (c), if the parents of the child or the local educational  
13 agency staff determines at any point during the process of the evaluation,  
14 development of the individualized education program or placement of the child that  
15 additional time is needed to permit meaningful parental participation, the local  
16 educational agency shall provide it.

17 (4) INFORMATION. At the beginning of any meeting to address the evaluation,  
18 individualized education program or placement of a child, the local educational  
19 agency staff shall inform the child's parents of their right to be provided with  
20 additional time under sub. (3) (d) and their right to a copy of the evaluation report  
21 under s. 115.782 (3) (b) or (c).

22 **115.782 Evaluations. (1) NOTICE; CONSENT.** (a) The local educational agency  
23 shall notify the parents of the child, in accordance with s. 115.792, of any evaluation  
24 procedures the agency proposes to conduct, the qualifications of the individuals who  
25 will conduct the evaluation and their names, if known.

1 (b) The local educational agency proposing to conduct an initial evaluation  
2 shall obtain informed consent from the child's parent before the evaluation is  
3 conducted. Parental consent for the evaluation does not constitute consent for  
4 placement for receipt of special education and related services. If the child's parents  
5 do not consent to the evaluation, the local educational agency may continue to pursue  
6 an evaluation by using the procedures under s. 115.797 or 115.80.

7 (2) CONDUCT OF EVALUATION. (a) In conducting the evaluation, the  
8 individualized education program team shall not use any single procedure as the sole  
9 criterion for determining whether a child is a child with a disability or for  
10 determining an appropriate educational program for the child. The individualized  
11 education program team shall do all of the following:

12 1. Use a variety of assessment tools and strategies to gather relevant functional  
13 and developmental information, including information provided by the child's  
14 parent, that may assist in determining whether the child is a child with a disability  
15 and the content of the child's individualized education program, including  
16 information related to enabling the child to be involved in and progress in the general  
17 curriculum or, for preschool children, to participate in appropriate activities.

18 2. Use technically sound instruments that may assess the relative contribution  
19 of cognitive and behavioral factors, in addition to physical or developmental factors.

20 3. Ensure all of the following:

21 a. That tests and other evaluation materials used to assess a child under this  
22 section are selected and administered so as not to be racially or culturally  
23 discriminatory and are provided and administered in the child's native language or  
24 other mode of communication, unless it is clearly not feasible to do so.



1           b. That any standardized tests that are given to the child have been validated  
2 for the specific purpose for which they are used, are administered by trained and  
3 knowledgeable personnel and are administered in accordance with any instructions  
4 provided by the producer of such tests.

5           c. That the child is assessed in all areas of suspected disability.

6           d. That assessment tools and strategies that provide relevant information that  
7 directly assists persons in determining the educational needs of the child are used.

8           (b) As part of an initial evaluation of a child and as part of any reevaluation of  
9 a child under sub. (4), the individualized education program team and other qualified  
10 professionals, as determined by the local educational agency, shall do all of the  
11 following:

12           1. Review existing evaluation data on the child, including evaluations and  
13 information provided by the child's parents, previous interventions and the effects  
14 of those interventions, current classroom-based assessments and observations, and  
15 observations by teachers and related services providers.

16           2. On the basis of that review and information provided by the child's parents,  
17 identify the additional data, if any, that are needed, and the qualifications of the  
18 evaluators that are needed, to determine all of the following:

19           a. Whether the child has a particular category of disability or, in case of a  
20 reevaluation of a child, whether the child continues to have such a disability.

21           b. The present levels of performance and educational needs of the child.

22           c. Whether the child needs special education and related services, or in the case  
23 of a reevaluation of a child, whether the child continues to need special education and  
24 related services.

1           d. Whether any additions or modifications to the special education and related  
2 services are needed to enable the child to meet the measurable, annual goals  
3 specified in the child's individualized education program and to participate, as  
4 appropriate, in the general curriculum.

5           (c) The local educational agency shall administer such tests and other  
6 evaluation materials as may be needed to produce the data identified under par. (b)  
7 2.

8           (d) If the child being evaluated is attending a public school in a nonresident  
9 school district under s. 118.51, as part of its initial evaluation of the child and as part  
10 of any reevaluation of the child under sub. (4), the individualized education program  
11 team shall collaborate with appropriate personnel designated by the school board of  
12 the child's school district of residence.

13           (e) Each individualized education program team participant who administers  
14 tests, assessments or other evaluation materials as part of an evaluation or  
15 reevaluation of a child under this section shall prepare and make available to all  
16 team participants at a team meeting a written summary of the participant's findings  
17 that will assist with program planning.

18           **(3) DETERMINATION OF ELIGIBILITY FOR SPECIAL EDUCATION.** (a) Upon the  
19 completion of the administration of tests and other evaluation materials, the  
20 individualized education program team shall determine whether the child is a child  
21 with a disability. The individualized education program team may not determine  
22 that a child is a child with a disability solely because the child has received  
23 insufficient instruction in reading or math or because the child has limited  
24 proficiency in English.

1 (b) If the individualized education program team determines that a child is a  
2 child with a disability, the team shall prepare an evaluation report that includes  
3 documentation of determination of eligibility. The local educational agency shall ask  
4 each individualized education program team participant if he or she wants a copy of  
5 the evaluation report or additional time before the individualized education program  
6 team develops the child's individualized education program. If any individualized  
7 education program team participant requests a copy of the evaluation report at any  
8 point in the process of developing the child's individualized education program or  
9 considering the child's educational placement, the local educational agency shall  
10 give a copy of the report to each individualized education program team participant  
11 before continuing with the process. If no individualized education program team  
12 participant requests a copy of the evaluation report, the local educational agency  
13 shall give a copy to the child's parents with the notice of placement under s. 115.792  
14 (2).

15 (c) If the individualized education program team determines that a child is not  
16 a child with a disability, the team shall prepare an evaluation report. The report shall  
17 identify any educational needs of the child and any services offered by the local  
18 educational agency from which the child may benefit and shall include information  
19 about any programs and services, other than those offered by the local educational  
20 agency, that may benefit the child. The local educational agency shall give a copy of  
21 the evaluation report to the child's parents with the notice under s. 115.792 (1) (b).

22 **(4) REEVALUATIONS.** (a) A local educational agency shall ensure that the  
23 individualized education program team does all of the following:

24 1. Evaluates a child with a disability in accordance with this section before  
25 determining that the child is no longer a child with a disability.

1           2. Reevaluates a child with a disability in accordance with this section if the  
2 local educational agency determines that conditions warrant a reevaluation or if the  
3 child's parent or teacher requests a reevaluation, but at least once every 3 years.

4           (b) The local educational agency shall obtain informed consent from the child's  
5 parent before reevaluating a child with a disability, except that such consent need  
6 not be obtained if the local educational agency has taken reasonable measures to  
7 obtain such consent and the child's parents have failed to respond.

8           (c) If the individualized education program team and other qualified  
9 professionals, as determined by the local educational agency, find under sub. (2) (b)  
10 2. that no additional data are needed to determine whether the child continues to be  
11 a child with a disability, the local educational agency shall notify the child's parents  
12 of that finding and the reasons for it and the right of the child's parents to request  
13 an assessment to determine whether the child continues to be a child with a  
14 disability. The local educational agency is not required to conduct such an  
15 assessment unless the child's parents request it.

16           **115.787 Individualized education programs. (1) REQUIREMENT THAT**  
17 **PROGRAM BE IN EFFECT.** At the beginning of each school year, each local educational  
18 agency shall have in effect, for each child with a disability, an individualized  
19 education program.

20           **(2) REQUIRED COMPONENTS.** An individualized education program shall include  
21 all of the following:

22           (a) A statement of the child's present level of educational performance,  
23 including how the child's disability affects the child's involvement and progress in  
24 the general curriculum or, for a preschool child, as appropriate, how the disability  
25 affects the child's participation in appropriate activities.

1 (b) A statement of measurable annual goals for the child, including  
2 benchmarks or short-term objectives, related to meeting the child's needs that result  
3 from the child's disability to enable the child to be involved in and progress in the  
4 general curriculum, and to meeting each of the child's other educational needs that  
5 result from the child's disability.

6 (c) A statement of the special education and related services and  
7 supplementary aids and services to be provided to the child, or on behalf of the child,  
8 and a statement of the program modifications or supports for school personnel that  
9 will be provided for the child to do all of the following:

10 1. Advance appropriately toward the annual goals.

11 2. Be involved and progress in the general curriculum in accordance with par.

12 (a) and participate in extracurricular and other nonacademic activities.

13 3. Be educated and participate with other children with disabilities and  
14 nondisabled children in the activities described in this subsection.

15 (d) An explanation of the extent to which the child will not participate with  
16 nondisabled children in regular classes, in the general curriculum and in  
17 extracurricular and other nonacademic activities.

18 (e) 1. A statement of any individual modifications in the administration of any  
19 statewide or local educational agency-wide assessment of pupil achievement that  
20 are needed for the child to participate in the assessment.

21 2. If the individualized education program team determines that a child will  
22 not participate in a particular statewide or local educational agency-wide  
23 assessment of pupil achievement, or part of such an assessment, a statement of why  
24 that assessment is not appropriate for the child and how the child will be assessed  
25 through alternative means.

1 (f) The projected date for the beginning of the services and modifications  
2 described in par. (c) and the anticipated frequency, location and duration of those  
3 services and modifications.

4 (g) 1. Beginning when the child attains the age of 14, and annually thereafter  
5 until the child is no longer eligible for special education and related services, a  
6 statement identifying the courses of study needed to prepare the child for a  
7 successful transition to his or her goals for life after secondary school, such as  
8 participation in advanced placement courses or a vocational education program.

9 2. Beginning when the child attains the age of 16, or earlier if that is  
10 determined to be appropriate by the individualized education program team, and  
11 annually thereafter until the child is no longer eligible for special education and  
12 related services, a statement of the needed transition services of the child, including,  
13 when appropriate, a statement of the interagency responsibilities or any cooperative  
14 arrangements between and among persons.

15 3. Beginning at least one year before the child attains the age of 18, and  
16 annually thereafter until the child is no longer eligible for special education and  
17 related services, a statement that the child has been informed of the parental rights  
18 that will transfer to the child on reaching the age of 18 under s. 115.807.

19 (h) A statement of all of the following:

20 1. How the child's progress toward the annual goals described in par. (b) will  
21 be measured.

22 2. How the child's parents will be regularly informed, at least as often as  
23 parents are informed of their nondisabled children's progress, of their child's  
24 progress toward the annual goals and the extent to which that progress is sufficient

1 to enable the child to achieve the goals by the end of the effective period of the  
2 individualized education program.

3 **(3) DEVELOPMENT.** (a) In developing each child's individualized education  
4 program, the individualized education program team shall consider the strengths of  
5 the child, the concerns of the child's parents for enhancing the education of their child  
6 and the results of the initial evaluation or most recent reevaluation of the child.

7 (b) The individualized education program team shall do all of the following:

8 1. In the case of a child whose behavior impedes his or her learning or that of  
9 others consider, when appropriate, strategies, including positive behavioral  
10 interventions, and supports to address that behavior.

11 2. In the case of a child with limited English proficiency, consider the language  
12 needs of the child as such needs relate to the child's individualized education  
13 program.

14 3. In the case of a child who is visually impaired, provide for instruction in  
15 Braille and the use of Braille unless the individualized education program team  
16 determines, after an evaluation of the child's reading and writing skills, needs and  
17 appropriate reading and writing media, including an evaluation of the child's future  
18 needs for instruction in Braille or the use of Braille, that instruction in Braille or the  
19 use of Braille is not appropriate for the child.

20 4. Consider the communicative needs of the child, and, in the case of a child who  
21 is hearing impaired, consider the child's language and communicative needs,  
22 opportunities for direct communications with peers and professional personnel in  
23 the child's language and communicative mode, academic level and full range of  
24 needs, including opportunities for direct instruction in the child's language and  
25 communicative mode.

1           5. Consider whether the child requires assistive technology devices and  
2 services.

3           (c) The regular education teacher of the child, as a participant on the  
4 individualized education program team, shall, to the extent appropriate, participate  
5 in the development of the individualized education program of the child, including  
6 the determination of appropriate positive behavioral interventions and strategies  
7 and the determination of supplementary aids and services, program modifications  
8 and support for school personnel.

9           (d) If a child is attending a public school in a nonresident school district under  
10 s. 118.51, the individualized education program team for the child shall develop the  
11 child's individualized education program in collaboration with appropriate  
12 personnel designated by the school board of the school district in which the child  
13 resides.

14           (e) The local educational agency shall give a copy of the child's individualized  
15 education program to the child's parents with the notice of placement under s.  
16 115.792 (2).

17           **(4) REVIEW AND REVISION.** (a) The individualized education program team shall  
18 do all of the following:

19           1. Review the child's individualized education program periodically, but at least  
20 annually, to determine whether the annual goals for the child are being achieved.

21           2. Revise the individualized education program as appropriate to address all  
22 of the following:

23           a. Any lack of expected progress toward the annual goals and in the general  
24 curriculum.

25           b. The results of any reevaluation conducted under s. 115.782.



1 c. Information about the child provided to or by the child's parents, as described  
2 in s. 115.782.

3 d. The child's anticipated needs.

4 e. Other matters.

5 (b) The regular education teacher of the child, as a participant on the  
6 individualized education program team, shall, to the extent appropriate, participate  
7 in the review and revision of the individualized education program of the child.

8 **(5) FAILURE TO MEET TRANSITION OBJECTIVES.** If a participating agency, other than  
9 the local educational agency, fails to provide transition services in accordance with  
10 sub. (2) (g) 2., the local educational agency shall reconvene the individualized  
11 education program team to identify alternative strategies to meet the transition  
12 objectives for the child set out in the individualized education program.

13 **(6) CHILDREN WITH DISABILITIES IN STATE PRISONS.** (a) 1. The requirements  
14 relating to participation of children with disabilities in general assessments under  
15 sub. (2) (e) do not apply to a child with a disability who is convicted of a crime under  
16 state law and incarcerated in a state prison.

17 2. The requirements relating to transition planning and transition services  
18 under sub. (2) (g) 1. and 2. do not apply with respect to a child with a disability who  
19 is convicted of a crime under state law and incarcerated in a state prison and whose  
20 eligibility under this subchapter will end, because of his or her age, before he or she  
21 will be released from prison.

22 (b) If a child with a disability is convicted of a crime and incarcerated in a state  
23 prison, the child's individualized education program team may modify the child's  
24 individualized education program or placement notwithstanding the requirements  
25 of sub. (1) and s. 115.79 (1) if the department of corrections has demonstrated a bona

1     vide security or compelling penological interest that cannot otherwise be  
2     accommodated.

3           **(7) CONSTRUCTION.** Nothing in this section requires the individualized  
4     education program team to include information under one component of a child's  
5     individualized education program that is already contained under another  
6     component of the individualized education program.

7           **115.79 Educational placements.** Each local educational agency shall ensure  
8     that all of the following occur:

9           **(1)** An evaluation is conducted under s. 115.782 before special education and  
10     related services are provided to a child with a disability.

11           **(2)** An educational placement is provided to implement a child's individualized  
12     education program. Except as provided in s. 118.51 (12) (a) and (b) 2., if a child with  
13     a disability is attending a public school in a nonresident school district under s.  
14     118.51, the school board of the school district that the child is attending shall provide  
15     an educational placement for the child and shall pay tuition charges instead of the  
16     school district in which the child resides if required by the placement.

17           **(3)** To the maximum extent appropriate, a child with a disability, including a  
18     child receiving publicly funded special education in a public or private institution or  
19     other care facility, is educated with nondisabled children.

20           **(4)** Special classes, separate schooling or other removal of a child with a  
21     disability from the regular educational environment occurs only when the nature or  
22     severity of the child's disability is such that education in regular classes with the use  
23     of supplementary aids and services cannot be achieved satisfactorily.

24           **115.791 Reimbursement for private school placement.** **(1)** If the parents  
25     of a child with a disability who previously received special education and related

1 services under the authority of a local educational agency enroll the child in a private  
2 elementary or secondary school without the consent of or referral by the local  
3 educational agency, a court or a hearing officer may require the local educational  
4 agency to reimburse the parents for the cost of that enrollment if the court or hearing  
5 officer finds that the local educational agency had not made a free appropriate public  
6 education available to the child in a timely manner before that enrollment.

7 (2) The cost of reimbursement described in sub. (1) may be reduced or denied  
8 if any of the following applies:

9 (a) At the most recent individualized education program meeting that the  
10 parents attended before removal of the child from the local educational agency, the  
11 parents did not inform the individualized education program team of their concerns,  
12 their rejection of the placement proposed by the local educational agency to provide  
13 a free appropriate public education to their child and their intent to enroll the child  
14 in a private school at public expense; or at least 10 business days, including any  
15 holidays that occur on a business day, before the removal of the child from the local  
16 educational agency, the parents did not give written notice to the local educational  
17 agency of their concerns, their rejection of the placement and their intent to enroll  
18 the child in a private school at public expense.

19 (b) If, before the parents' removal of the child from the local educational agency,  
20 the local educational agency notified the parents under s. 115.792 of its intent to  
21 evaluate the child, including a statement of the purpose of the evaluation that was  
22 appropriate and reasonable, but the parents did not make the child available for the  
23 evaluation.

24 (c) A court finds the parents' actions unreasonable.

1           **(3)** Notwithstanding the notice requirement in sub. (2) (a), the cost of  
2 reimbursement may not be reduced or denied for failure to provide such notice if any  
3 of the following apply:

4           (a) The parent is illiterate and cannot write in English.

5           (b) Compliance with sub. (2) (a) would likely result in physical or serious  
6 emotional harm to the child.

7           (c) The local educational agency prevented the parent from providing such  
8 notice.

9           (d) The parents had not received notice, pursuant to s. 115.792, of the notice  
10 requirement in sub. (2) (a).

11           **(4)** Subject to s. 115.77 (1m) (d) and (e), this section does not require a local  
12 educational agency to pay the cost of education, including special education and  
13 related services, of a child with a disability at a private school or facility if the local  
14 educational agency made a free appropriate public education available to the child  
15 and the child's parents elected to place the child in a private school or facility.

16           **115.792 Procedural safeguards. (1) SAFEGUARDS ENSURED.** (a) The local  
17 educational agency shall establish and maintain procedures to ensure all of the  
18 following:

19           1. That the parents of a child may examine all records relating to the child and  
20 may participate in meetings about the identification, evaluation and educational  
21 placement of the child, and the provision of a free appropriate public education to the  
22 child, and may obtain an independent educational evaluation of the child.

23           2. That a child's rights are protected by the assignment of an individual, who  
24 shall not be an employe of the department, the local educational agency or any other  
25 agency that is involved in the education or care of the child, to act as a surrogate for

1 the child's parents whenever the child's parents are not known; the local educational  
2 agency cannot, after reasonable efforts, locate the child's parents; or the child is a  
3 ward of the state.

4 3. That a child's parents are offered an opportunity to use mediation under s.  
5 115.797.

6 (b) The local educational agency shall establish and maintain procedures to  
7 ensure that a child's parents are provided prior written notice whenever the local  
8 educational agency proposes to initiate or change, or refuses to initiate or change, the  
9 identification, evaluation or educational placement of the child, or the provision of  
10 a free appropriate public education to the child. In this paragraph, "local educational  
11 agency" includes the nonresident school district that a child is attending under s.  
12 118.51.

13 **(2) NOTICE.** The notice required under sub. (1) (b) shall be in the native  
14 language of the child's parents unless the local educational agency determines that  
15 it clearly is not feasible to do so and shall include all of the following:

16 (a) A description of the action proposed or refused by the local educational  
17 agency.

18 (b) An explanation of why the local educational agency proposes or refuses to  
19 take the action.

20 (c) A description of any other options that the local educational agency  
21 considered and the reasons why it rejected those options.

22 (d) A description of each evaluative procedure, test, record or report that the  
23 local educational agency used as a basis for the proposed or refused action.

24 (e) If the notice proposes to evaluate or reevaluate the child, the qualifications  
25 of the evaluators and their names, if known.

1 (f) A description of any other factors that are relevant to the local educational  
2 agency's proposal or refusal.

3 (g) A statement that the parents of a child with a disability have procedural  
4 safeguards under this section and, if this notice is not an initial referral for  
5 evaluation, or reevaluation, or a notice of an individualized education program  
6 meeting, the way in which the parents may obtain a description of the procedural  
7 safeguards under sub. (3).

8 (h) Sources for parents to contact to obtain assistance in understanding this  
9 subchapter.

10 (i) The rights specified in s. 115.78 (4).

11 **(3) PROCEDURAL SAFEGUARDS NOTICE.** (a) In this subsection, "local educational  
12 agency" includes the nonresident school district that a child is attending under s.  
13 118.51.

14 (b) The local educational agency shall give to the parents of a child with a  
15 disability, upon the child's initial referral for evaluation, upon each notification of an  
16 individualized education program meeting and upon reevaluation of the child, a full  
17 explanation written so as to be easily understood by the general public, and in the  
18 native language of the child's parents unless it clearly is not feasible to do so, of the  
19 procedural safeguards available under this section and under applicable federal law  
20 relating to all of the following:

- 21 1. Independent educational evaluation.
- 22 2. Prior written notice.
- 23 3. Parental consent.
- 24 4. Access to educational records.
- 25 5. Opportunity to present complaints.

1           6. The child’s placement during pendency of due process proceedings.

2           7. Procedures for pupils who are subject to placement in interim alternative  
3 educational settings under 20 USC 1415 (k).

4           8. Requirements for the unilateral placement by parents of pupils in private  
5 schools at public expense.

6           9. Mediation.

7           10. Hearings under s. 115.80.

8           11. Civil actions.

9           12. Attorney fees.

10          **115.797 Mediation. (1) DEFINITIONS.** In this section:

11           (a) “Dispute” means any disagreement between parties concerning the  
12 proposal or refusal to initiate or change the evaluation, individualized education  
13 program or educational placement of a child with a disability or the provision of a free  
14 appropriate public education to such a child. “Dispute” includes any such  
15 disagreement between parties in which other processes, including a hearing under  
16 s. 115.80 or litigation, have been requested or commenced.

17           (b) “Mediation” has the meaning given in s. 802.12 (1) (e).

18           (c) “Party” means a competent adult pupil or the parent of a child or  
19 incompetent adult pupil who is the subject of a dispute, and the local educational  
20 agency.

21           **(2) REQUEST FOR MEDIATION, CONSENT OF PARTIES.** (a) The division shall establish  
22 a program for the mediation of disputes between parties. A party may request the  
23 division to arrange for mediation of a dispute at any time. The request shall be in  
24 writing, shall briefly describe the dispute and shall identify both parties. Both  
25 parties may jointly request mediation.

1 (b) If only one of the parties requests mediation, within 5 business days after  
2 receiving the request the division shall notify the other party in writing of the request  
3 for mediation. The notice shall include all of the following:

4 1. An explanation of mediation and its advantages.

5 2. A statement that participation in mediation is voluntary and that agreement  
6 or refusal to participate will not affect the resolution of the dispute in any pending  
7 or potential adjudicative process, or the timing of that process, unless the parties  
8 agree otherwise.

9 3. A request that the party notify the division within 5 business days after  
10 receiving the notice regarding the party's consent or refusal to participate in  
11 mediation.

12 (c) If the division does not receive timely response under par. (b) 3. or if the other  
13 party notifies the division under par. (b) 3. of its refusal to participate in mediation,  
14 the division shall so notify the party that requested mediation.

15 **(3) APPOINTMENT OF MEDIATOR.** (a) A party that requests mediation may  
16 nominate a mediator from the roster under sub. (4). If a party nominates a mediator,  
17 the division shall include in the notice under sub. (2) (b) the name of the nominated  
18 mediator.

19 (b) 1. If both parties nominate the same person as mediator, the division shall  
20 appoint that person as mediator if he or she is on the roster under sub. (4) and  
21 available to mediate.

22 2. If both parties request mediation but neither party nominates a mediator,  
23 the division shall propose a mediator from the roster under sub. (4).

24 3. If both parties consent to mediation but the party that requests mediation  
25 does not nominate a mediator, the nominated mediator is not available or the other



1 party does not consent to the appointment of the nominated mediator, the division  
2 shall propose a mediator from the roster under sub. (4).

3 (c) Whenever the division proposes a mediator under par. (b) 2. or 3., it shall  
4 send information about the mediator's training and experience to both parties.  
5 Within 3 business days after receiving the information, either party may request the  
6 division to propose a different mediator from the roster under sub. (4).

7 **(4) ROSTER OF MEDIATORS.** (a) In consultation with the council on special  
8 education, the division shall maintain a roster of mediators qualified to resolve  
9 disputes. The division may include a person on the roster if all of the following apply:

10 1. The division determines that the person has the appropriate skills and  
11 knowledge to act as a mediator under this section.

12 2. The person participates in a training program of at least 5 days' duration that  
13 has been approved by the division.

14 3. The person agrees to mediate, at the rate of compensation established by the  
15 division, the number of disputes required by the division each year.

16 4. The person consents to be observed by a division representative at any  
17 mediation session if the parties consent.

18 (b) The division may not maintain a person on the roster unless he or she  
19 participates in at least one day of additional training approved by the division each  
20 year.

21 (c) Subject to subch. II of ch. 111, the division may remove from the roster any  
22 person whom it believes cannot serve effectively as a mediator.

23 **(5) MEDIATION.** (a) Unless both parties agree otherwise, mediation shall  
24 commence within 21 days after the mediator is appointed and shall not delay

1 hearings or appeals related to the dispute. All mediation sessions shall be held in  
2 a location that is convenient to the parties.

3 (b) The parents of the child or adult pupil and 2 representatives of the local  
4 educational agency may participate in mediation. With the consent of both parties,  
5 other persons may participate in mediation. With the consent of both parties, a  
6 division representative may observe the mediation sessions.

7 (c) At the commencement of mediation, the mediator shall inform the parties  
8 of the information that is required to be reported to the division for the purpose of  
9 administering the mediation program. The division may not require a mediator to  
10 disclose the substance of any matter discussed or communication made during  
11 mediation.

12 (d) Either party may recess a mediation session to consult advisors, whether  
13 or not present, or to consult privately with the mediator. The mediator may recess  
14 a mediation session to consult privately with a party. If the mediator does so, he or  
15 she shall disclose the general purpose of the consultation but may not reveal other  
16 information about the consultation without the consent of the party consulted.

17 (e) Unless both parties and the mediator agree otherwise, no person may record  
18 a mediation session.

19 (f) Discussions that occur during mediation are confidential and may not be  
20 used as evidence in any subsequent hearing or civil proceeding. The mediator may  
21 require the parties to sign a confidentiality pledge before the commencement of  
22 mediation.

23 (g) The mediator and either party may withdraw from mediation at any time.

24 (h) No adverse inference may be drawn by any hearing officer or adjudicative  
25 body from the fact that a party did not consent to mediation, that a mediator or party

1       withdrew from mediation or that mediation did not result in settlement of the  
2       dispute.

3               **(6) AGREEMENTS.** If the parties resolve the dispute or a portion of the dispute,  
4       or agree to use another procedure to resolve the dispute, the mediator shall ensure  
5       that the resolution or agreement is reduced to writing, that it is signed by the parties  
6       and that a copy is given to each party. The resolution or agreement is legally binding  
7       upon the parties.

8               **(7) MEDIATOR COMPENSATION.** (a) The division shall establish a schedule for the  
9       compensation of mediators and the reimbursement of their expenses. The  
10       department shall pay mediators from the appropriation under s. 20.255 (1) (me).

11              (b) If the parties agree that the amount of compensation paid to a mediator  
12       should be greater than the schedule under par. (a) allows, the additional  
13       compensation is the responsibility of the parties.

14              (c) If the parties have agreed to mediation by a mediator who is not on the roster  
15       under sub. (4), the mediator's compensation is the responsibility of the parties.

16              **(8) PROGRAM EVALUATION.** The division may require that mediators, and may  
17       request that parties, participate in the evaluation of the mediation program. The  
18       division shall ensure that mediators and parties may participate in evaluating the  
19       program without being required to identify themselves or the other mediation  
20       participants. The division may not disclose a party's or mediator's evaluation to any  
21       other mediation participant without the party's or mediator's consent.

22              **(9) CONTRACT FOR SERVICES.** The department may contract with a private,  
23       nonprofit agency to administer the mediation program under this section or for  
24       mediator training or other services, including outreach and promotion, related to the  
25       administration of the program.

1           **115.80 Due process hearings.** (1) (a) 1. A parent, or the attorney  
2 representing the child, may file a written request with the division for a hearing  
3 whenever the local educational agency proposes or refuses to initiate or change his  
4 or her child's evaluation, individualized education program, educational placement  
5 or the provision of a free appropriate public education. The division shall develop a  
6 model form to assist parents in filing a request under this subdivision.

7           2. The parent, or the attorney representing the child, shall include in the  
8 request under subd. 1. the name of the child, the address of the residence of the child,  
9 the name of the school the child is attending, a description of the nature of the  
10 problem of the child relating to the proposed or refused initiation or change,  
11 including facts relating to the problem, and a proposed resolution of the problem to  
12 the extent known and available to the parents at the time.

13           (b) A local educational agency may file a written request with the division for  
14 a hearing to override a parent's refusal to grant consent for an initial evaluation, a  
15 reevaluation or an initial educational placement or to contest the payment of an  
16 independent educational evaluation.

17           (c) A parent, the attorney representing the child or a local educational agency  
18 may file a written request for a hearing as provided in 20 USC 1415 (k).

19           (d) Upon receiving a request for a hearing, the division shall give to the child's  
20 parents a copy of the procedural safeguards available to the parents under s. 115.792  
21 and under federal regulations.

22           **(2)** The division shall maintain a list of qualified hearing officers who are not  
23 employed by or under contract with the department or the local educational agency,  
24 other than being appointed under this subsection, to serve as hearing officers in

1 hearings under this section. Upon receipt of a written request for a hearing under  
2 sub. (1), the division shall appoint a hearing officer from the list.

3 **(3)** Any party to a hearing conducted under this section may be accompanied  
4 and advised by counsel and by individuals with special knowledge or training with  
5 respect to the problems of children with disabilities and may present evidence and  
6 confront, cross-examine and compel the attendance of witnesses. A party shall be  
7 provided with written or, at the option of the child's parents, electronic findings of  
8 facts and decisions, and, upon request, a written or, at the option of the child's  
9 parents, an electronic, verbatim record of the hearing.

10 **(4)** At least 5 business days before a hearing is conducted under this section,  
11 other than an expedited hearing under 20 USC 1415 (k), each party shall disclose to  
12 all other parties all evaluations completed by that date and recommendations based  
13 on the offering party's evaluations that the party intends to use at the hearing. The  
14 hearing officer may bar any party that fails to comply with this subsection from  
15 introducing the relevant evaluation or recommendation at the hearing without the  
16 consent of the other party.

17 **(5)** A hearing officer may administer oaths and affirmations, issue subpoenas  
18 and enforce subpoenas under ss. 885.01 (4) and 885.12, regulate the course of the  
19 hearing and hold conferences for the settlement or simplification of the issues. The  
20 hearing officer is not bound by common law or statutory rules of evidence. The  
21 hearing officer shall admit all testimony having reasonable probative value, but  
22 shall exclude immaterial, irrelevant or unduly repetitious testimony. The hearing  
23 officer shall give effect to the rules of privilege recognized by law. A hearing officer  
24 has the authority to issue an order consistent with this subchapter and 20 USC 1415  
25 (k) and to order whatever remedy is reasonably necessary to bring the parties into

1 compliance with this subchapter. The hearing officer's decision shall consist of  
2 findings of fact and conclusions of law and shall be based upon a preponderance of  
3 the evidence. The findings of fact shall be based solely upon the evidence received  
4 at the hearing.

5 (6) The hearing officer shall issue a decision within 45 days after the receipt  
6 of the request for the hearing under sub. (1). The hearing officer may order an  
7 independent educational evaluation of the child at local educational agency expense  
8 and grant specific extensions of time for cause at the request of either party. If the  
9 hearing officer grants an extension of time, he or she shall include that extension and  
10 the reason for the extension in the record of the proceedings. The local educational  
11 agency shall pay the cost of the hearing.

12 (7) Any party aggrieved by the decision of the hearing officer may bring a civil  
13 action in the circuit court for the county in which the child resides or in a U.S. district  
14 court. An action filed in circuit court shall be commenced within 45 days after service  
15 of the decision of the hearing officer. In any action brought under this subsection,  
16 the court shall receive the records of the administrative proceedings, shall hear  
17 additional evidence at the request of a party and, basing its decision on the  
18 preponderance of the evidence, shall grant such relief as the court determines is  
19 appropriate. Sections 227.52 to 227.58 do not apply to actions under this subsection.

20 (8) Except as provided in 20 USC 1415 (k), during the pendency of any  
21 proceedings under this section, the local educational agency may not change the  
22 educational placement of a child unless the child's parents agree to the change. If  
23 the child is applying for initial admission to a public school, the child shall, with the  
24 consent of the child's parents, be placed in the public school program until all  
25 proceedings under this section have been completed. In this subsection, "local

1 educational agency” includes the nonresident school district that a child is attending  
2 under s. 118.51.

3 (9) (a) Subject to par. (b), a circuit court may award reasonable attorney fees  
4 and actual costs to the parents of a child with a disability who is the prevailing party  
5 in any action or proceeding brought in circuit court under this section.

6 (b) 1. Fees and costs may not be awarded under par. (a) for services performed  
7 after a written offer of settlement to a parent if all of the following apply:

8 a. The offer is made within the time prescribed by s. 807.01 for actions in circuit  
9 court and at least 11 days before the hearing begins for administrative hearings.

10 b. The offer is not accepted within 10 days.

11 c. The court or hearing officer finds that the relief granted to the parents is not  
12 more favorable to the parents than the offer of settlement.

13 2. Fees and costs may not be awarded under par. (a) if they relate to any meeting  
14 of the individualized education program team unless the meeting is convened as a  
15 result of an administrative hearing or judicial action, or for mediation under s.  
16 115.797 that is conducted before filing a request for a hearing under sub. (1).

17 (c) Notwithstanding par. (b), fees and costs may be awarded under par. (a) to  
18 a parent who is the prevailing party and whose rejection of a settlement offer was  
19 substantially justified.

20 (d) 1. Except as provided in subd. 2., whenever the court finds any of the  
21 following it shall reduce the amount of the fees awarded under par. (a):

22 a. During the course of the action, the parent unreasonably protracted the final  
23 resolution of the controversy.

24 b. The attorney representing the parent did not provide to the division the  
25 information specified in sub. (1) (a) 2.

1           2. A court may not reduce the amount of the fees awarded under par. (a) if it  
2 finds that the state or a local educational agency unreasonably protracted the final  
3 resolution of the controversy or violated this subchapter.

4           **(10)** Sections 227.44 to 227.50 do not apply to hearings conducted under this  
5 section.

6           **115.807 Transfer of parental rights at age of majority.** When a child with  
7 a disability, other than a child with a disability who has been determined to be  
8 incompetent under ch. 880, reaches the age of 18, all of the following apply:

9           **(1)** The local educational agency shall provide any notice required by this  
10 subchapter to both the individual and the individual’s parents.

11           **(2)** All other rights accorded to the individual’s parents under this subchapter  
12 transfer to the individual.

13           **(3)** The local educational agency shall notify the individual and the individual’s  
14 parents of the transfer of rights.

15           **115.81 Children in child caring institutions. (1) DEFINITIONS.** In this  
16 section:

17           (a) “County department” means a county department under s. 46.215, 46.22 or  
18 46.23.

19           (b) “Originating local educational agency” means the local educational agency  
20 that was responsible for providing a free, appropriate public education to the child  
21 before the placement of the child in a child caring institution.

22           **(2) ESTABLISHMENT OF PROGRAM.** Subject to the approval of the division, a child  
23 caring institution may establish and maintain special education and related services  
24 for children with disabilities.



1           **(3) REFERRAL.** (a) Whenever a county department recommends to a court that  
2 a child be placed in a child caring institution or whenever a state agency anticipates  
3 placing a child in a child caring institution, the county department or state agency  
4 shall notify the originating local educational agency.

5           (b) For each child identified in a notice under par. (a), the originating local  
6 educational agency shall do all of the following:

7           1. If the child is a child with a disability, as soon as reasonably possible and after  
8 consulting with a county department or a state agency, as appropriate, appoint an  
9 individualized education program team to review and revise, if necessary, the child's  
10 individualized education program and develop an educational placement offer.

11           2. If the child has not been identified as a child with a disability:

12           a. Appoint staff to review the child's education records and develop a status  
13 report for the child and send a copy of the report to the county department or state  
14 agency, as appropriate, within 30 days after receiving the notice under par. (a).

15           b. If the originating local educational agency has reasonable cause to believe  
16 that the child is a child with a disability, appoint an individualized education  
17 program team to conduct an evaluation of the child under s. 115.782. The originating  
18 local educational agency may include appropriately licensed staff of the child caring  
19 institution in the team if that staff is available. The individualized education  
20 program team shall conduct the evaluation. If the individualized education program  
21 team determines that the child is a child with a disability, the individualized  
22 education program team, in consultation with a county department or a state agency,  
23 as appropriate, shall develop an individualized education program and an  
24 educational placement offer.

1           (4) RESPONSIBILITY FOR EDUCATIONAL PLACEMENT. Whenever the originating local  
2 educational agency offers an educational placement in a child caring institution  
3 under sub. (3) (b) 1. or 2. b., all of the following apply:

4           (a) The originating local educational agency shall do all of the following:

5           1. Ensure that the child receives a free appropriate public education.

6           2. Ensure that the child's treatment and security needs are considered when  
7 determining the least restrictive environment for the child.

8           3. While the child resides at a child caring institution, appoint an  
9 individualized education program team to conduct reevaluations of the child in the  
10 manner provided under s. 115.782 (4).

11           4. While the child resides at a child caring institution, after consulting with the  
12 child caring institution and a county department or a state agency, as appropriate,  
13 refer the child to another local educational agency if the originating local educational  
14 agency determines that the child's special education needs may be appropriately  
15 served in a less restrictive setting in the other local educational agency.

16           5. If the child is leaving the child caring institution, assign staff or an  
17 individualized education program team to develop a reintegration plan for the child  
18 in cooperation with a county department and staff of the child caring institution.

19           (b) The county department or state agency, as appropriate, shall do all of the  
20 following:

21           1. Consider the child's educational needs when selecting a child caring  
22 institution for the child.

23           2. In cooperation with the originating local educational agency and staff of the  
24 child caring institution, participate in the individualized education program team

1 evaluation of the child and the development of the individualized education program  
2 for the child.

3 3. Notify the local educational agency that will be responsible for providing a  
4 free, appropriate public education to the child whenever the county department or  
5 state agency anticipates removing the child from the child caring institution.

6 4. In cooperation with the originating local educational agency and staff of the  
7 child caring institution, develop a reintegration plan for the child if the child is  
8 leaving the child caring institution.

9 5. Pay all of the child caring institution related costs of educating the child  
10 while the child resides in the child caring institution.

11 (c) Whenever a local educational agency receives a referral under par. (a) 4., the  
12 local educational agency shall assign staff to determine whether the child can  
13 appropriately receive special education and related services provided in the local  
14 educational agency. If the assigned staff determine that the child can appropriately  
15 receive special education and related services in the local educational agency, the  
16 local educational agency shall provide such services for the child and is eligible for  
17 state tuition payments under s. 121.79 (1) (a). If the assigned staff determine that  
18 the child cannot appropriately receive special education and related services in the  
19 local educational agency, the local educational agency shall keep a written record of  
20 the reasons for that determination.

21 **115.812 Placement disputes; school board referrals; interagency**  
22 **cooperation.**

23 (1) **PLACEMENT DISPUTES.** If a dispute arises between a local educational agency  
24 and the department of health and family services, the department of corrections or  
25 a county department under s. 46.215, 46.22 or 46.23, or between local educational

1 agencies under s. 115.81 (4) (c), over the placement of a child, the state  
2 superintendent shall resolve the dispute. This subsection applies only to placements  
3 in nonresidential educational programs made under s. 48.57 (1) (c) and to placements  
4 in child caring institutions made under s. 115.81.

5 **(2) SCHOOL BOARD REFERRALS.** Annually on or before August 15, each local  
6 educational agency shall report to the appropriate county departments under ss.  
7 51.42 and 51.437 the names of children who reside in the local educational agency,  
8 are at least 16 years of age, are not expected to be enrolled in an educational program  
9 2 years from the date of the report and may require services described under s. 51.42  
10 or 51.437 (1). This subsection does not affect a local educational agency's  
11 responsibility to make services available to children with disabilities.

12 **(3) INTERAGENCY COOPERATION.** (a) A school board, cooperative educational  
13 service agency and county children with disabilities education board may enter into  
14 an agreement with a county administrative agency, as defined in s. HFS 90.03 (10),  
15 Wis. adm. code, to allow the employes of the school board, agency or county children  
16 with disabilities education board to participate in the performance of evaluations  
17 and the development of individualized family service plans under s. 51.44.

18 (b) 1. In this paragraph, "public agency" has the meaning given in s. 166.20 (1)  
19 (i), except that it excludes a local educational agency.

20 2. If a public agency that is required by federal or state law or by an interagency  
21 agreement to provide or pay for the location, identification or evaluation of a child  
22 with a disability, including a child with a disability who is not yet 3 years of age, or  
23 for assistive technology devices or services, supplementary aids or services,  
24 transition services or special education or related services for a child with a  
25 disability, and fails to do so, the local educational agency shall provide or pay for the

1 services. The public agency shall reimburse the local educational agency for the cost  
2 of providing the services.

3 **115.817 Children with disabilities education board. (1) DEFINITIONS.** In  
4 this section “board” means the county children with disabilities education board.

5 **(2) ESTABLISHMENT.** (a) A county board of supervisors may determine to  
6 establish a special education program, including the provision of related services for  
7 children with disabilities, for school districts in the county.

8 (b) The program may provide for one or more special schools, classes, treatment  
9 or instruction centers for children with one or more types of disabilities.

10 (c) A school district shall be included under the county program only to the  
11 extent approved by formal action of the school board.

12 **(3) ORGANIZATION.** (a) The board shall consist of 3 or more persons, as  
13 determined by the county board of supervisors, elected by the county board or  
14 appointed by the chairperson of the county board, as the rules of the county board  
15 direct. Board members shall be electors selected from that part of the county  
16 participating in the program and shall be representative of the area the board serves.  
17 The board may include school board members, members of the county board of  
18 supervisors and other electors. Board members shall hold office for a term of 3 years,  
19 except that the terms of office of members of the first board shall be 3 years, 2 years  
20 and one year. Board members shall receive compensation and reimbursement for  
21 mileage in an amount fixed by the county board of supervisors, but not more than  
22 that of county board members.

23 (b) The board annually shall select one member as chairperson and one as  
24 secretary. The county treasurer shall serve as board treasurer but shall not be a  
25 member of the board.

1 (c) The board shall appoint an advisory committee whose membership includes  
2 school district administrators representative of the area the board serves.

3 (4) APPLICATION. Upon authorization of the county board, the board shall apply  
4 to the division for the establishment of a program or part of a program to provide  
5 special education and related services. The application shall state whether the  
6 program or part will be available in the county at large or only to certain school  
7 districts.

8 (5) BOARD DUTIES. (a) The board shall have charge of all matters pertaining to  
9 the organization, equipment, operation and maintenance of such programs and may  
10 do all things necessary to perform its functions, including the authority to erect  
11 buildings subject to county board approval and employ teachers and other personnel.  
12 The board shall prepare an annual budget, which shall be subject to approval of the  
13 county board under s. 65.90 unless a resolution is adopted under sub. (9) (c), and shall  
14 include funds for the hiring of staff, the purchase of materials, supplies and  
15 equipment and the operation and maintenance of buildings or classrooms.

16 (b) 1. At the close of each fiscal year, the board shall employ a licensed  
17 accountant to audit its accounts and certify the audit. The cost of the audit shall be  
18 paid from board funds.

19 3. The department shall establish by rule a standard contract and minimum  
20 standards for audits performed under this paragraph.

21 (c) If the county board of supervisors establishes an integrated service program  
22 for children with severe disabilities under s. 59.53 (7), the county children with  
23 disabilities education board shall participate in an integrated service program for  
24 children with severe disabilities under s. 59.53 (7), and may enter into written  
25 interagency agreements or contracts under the program.

1 (d) Annually by October 1, the board and the school boards of the school  
2 districts participating in the county program shall submit a report to the state  
3 superintendent that specifies the portion of each school day that each pupil enrolled  
4 in the county program who is also enrolled in the school district of the pupil's  
5 residence spent in county program classes in the previous school year and the portion  
6 of the school day that the pupil spent in school district classes in the previous school  
7 year. The state superintendent shall develop guidelines for a full-time equivalency  
8 methodology. The state superintendent is not required to promulgate the guidelines  
9 as rules.

10 **(6) ASSIGNMENT OF FUNCTIONS.** (a) The board may not assign by resolution or  
11 by contract the full administrative or instructional services of the board.

12 (b) The ability of the board to contract with the board of control of a cooperative  
13 educational service agency, a school board or other public agency in the county for  
14 a portion of administrative or instructional services is not prohibited by par. (a). The  
15 board shall be responsible for all programs contracted under this paragraph.

16 **(7) WITHDRAWAL AND DISSOLUTION.** (a) The school board of any school district  
17 that is included under the administration of a board may withdraw from  
18 participation in any part of the program only with the approval of the state  
19 superintendent after conference with the board and a determination by the state  
20 superintendent that such withdrawal is in the interest of the program in the county  
21 and the school district affected. Such withdrawal shall be effective only if the school  
22 board has the approval of the division to establish an equivalent part of a program.  
23 Such withdrawal shall be effective either December 31 or June 30 provided that 12  
24 months' notice has been given to the board. The withdrawing school district shall  
25 be liable for its proportionate share of all operating costs until its withdrawal

1 becomes effective, shall continue to be liable for its share of debt incurred while it was  
2 a participant and shall receive no share in the assets.

3 (b) A program established under this section may be dissolved by action of the  
4 county board, but such dissolution shall not take place until the end of the school  
5 term in which the action was taken. When a program is dissolved, assets and  
6 liabilities shall be distributed under s. 66.03 to all units which participated in the  
7 program.

8 **(8) TRANSPORTATION.** The board may promulgate a plan for the transportation  
9 at county expense of children who are receiving special education and related  
10 services under this section, special education and related services provided at day  
11 care centers or special education and related services provided by a private  
12 organization within whose attendance area the child resides and which is situated  
13 not more than 5 miles beyond the boundaries of the area the board serves, as  
14 measured along the usually traveled route. The plan, upon approval of the state  
15 superintendent, shall govern the transportation of such children. Any such plan for  
16 transportation during the school term supersedes ss. 115.88 and 121.54 (3).

17 **(9) AREA TAXED.** (a) The tax for the operation and maintenance of each part of  
18 a special education program and for the transportation of children under sub. (8)  
19 shall be levied against the area of the county participating in the part of the program.

20 (b) Beginning July 1, 1981, no board, except a board that has constructed or  
21 acquired building facilities, may continue to operate under this section if the area  
22 taxed under par. (a) constitutes less than 50% of the full value of taxable property  
23 within the county.

24 (c) Upon the adoption of a resolution by a majority of the school boards that are  
25 located in whole or in part in the county and are participating in the county program



1 under sub. (2) (c), this subsection shall not apply commencing on the effective date  
2 of the resolution. A resolution adopted under this paragraph between January 1 and  
3 June 30 in any year shall be effective on January 1 of the year commencing after its  
4 adoption. A resolution adopted under this paragraph between July 1 and December  
5 31 in any year shall be effective on January 1 of the 2nd year commencing after its  
6 adoption. In the year in which the resolution is effective, the county budget under  
7 s. 59.60 or 65.90 shall include a line item for the special education program.

8 **(10) STATE AIDS.** (a) The board may apply for and receive the state aid under  
9 ss. 115.88 and 121.41 (1) for the transportation, board and lodging, treatment and  
10 instruction of children participating in programs under this section.

11 (b) The board may apply for and receive the state aid under ss. 121.135 and  
12 121.14. This paragraph does not apply beginning on the effective date of a resolution  
13 adopted under sub. (9) (c).

14 (c) All state aid shall be paid to the county treasurer and credited to the fund  
15 of the board.

16 **(11) VIOLATIONS.** The state superintendent shall withhold aid from any board  
17 that violates this section.

18 **115.82 Admission and transportation of nonresidents.** (1) A cooperative  
19 educational service agency, county children with disabilities education board or  
20 school district that provides special education and related services shall admit a  
21 nonresident if the program is appropriate for the child's disability. Refusal to admit  
22 a child does not relieve the local educational agency that is responsible for providing  
23 a free, appropriate public education to the child under this subchapter from that  
24 responsibility.

1           **(2)** In addition to the requirements of s. 121.54 (3), when board and lodging are  
2 not furnished to a nonresident child with a disability, the school district in which the  
3 child resides shall provide transportation, except as follows:

4           (a) If there is a plan of transportation under s. 115.817 (8), the county children  
5 with disabilities education board shall provide transportation.

6           (b) If the child is attending a public school in a nonresident school district under  
7 s. 118.51, the nonresident school district shall provide transportation.

8           **115.88 State aid. (1) PERSONNEL.** A school board, board of control of a  
9 cooperative educational service agency or, upon authorization of the county board,  
10 a county children with disabilities education board may employ, for a special  
11 education program, either full- or part-time licensed teachers, licensed coordinators  
12 of special education, licensed school social workers, licensed school psychologists,  
13 paraprofessionals, licensed consulting teachers to work with any teacher of regular  
14 education programs who has a child with a disability in a class and any other  
15 personnel approved by the department. The board may contract with private or  
16 public agencies for physical or occupational therapy services on the basis of  
17 demonstrated need.

18           **(1m) PROGRAM AID.** (a) If, upon receipt of the plan under s. 115.77 (4), the state  
19 superintendent is satisfied that the special education program has been maintained  
20 during the preceding school year in accordance with law, the state superintendent  
21 shall certify to the department of administration in favor of each county, cooperative  
22 educational service agency and school district maintaining such special education  
23 program a sum equal to 63% of the amount expended by the county, agency and  
24 school district during the preceding year for salaries of personnel enumerated in sub.  
25 (1), including the salary portion of any authorized contract for physical or

1 occupational therapy services, except as provided in par. (b), and other expenses  
2 approved by the state superintendent. The department of administration shall pay  
3 such amounts to the county, agency and school district from the appropriation under  
4 s. 20.255 (2) (b).

5 (b) Salaries of licensed school psychologists and licensed school social workers  
6 shall be reimbursed at 51% without regard to whether they are employed in a  
7 program for children with disabilities. The school district, county children with  
8 disabilities education board or cooperative educational service agency shall include  
9 in the plan under s. 115.77 (4) any information required by the state superintendent  
10 relating to use of a school psychologist or school social worker.

11 **(2) TRANSPORTATION AID.** If upon receipt of the plan under s. 115.77 (4) the state  
12 superintendent is satisfied that the transportation of children with disabilities has  
13 been maintained during the preceding year in accordance with the law, the state  
14 superintendent shall certify to the department of administration in favor of each  
15 county, cooperative educational service agency or school district transporting such  
16 pupils 63% of the amount expended for such transportation. Pupils for whom aid is  
17 paid under this subsection shall not be eligible for aid under s. 121.58 (2) or (4). The  
18 department of administration shall pay such amounts to the county, agency or school  
19 district from the appropriations under s. 20.255 (2) (b) and (br). This subsection  
20 applies to any child with a disability who requires special assistance in  
21 transportation, including any such child attending regular classes who requires  
22 special or additional transportation. This subsection does not apply to any child with  
23 a disability attending regular or special classes who does not require any special or  
24 additional transportation.

1           **(3) BOARD AND LODGING AID.** There shall be paid the amount expended for board  
2 and lodging and transportation between the boarding home and the special  
3 education program of nonresident children enrolled under s. 115.82 (1) in the special  
4 education program. The department shall certify the full amount to the department  
5 of administration which shall pay such amount from the appropriation under s.  
6 20.255 (2) (b) to the school district, cooperative educational service agency, county  
7 children with disabilities education board, state agency of another state or private,  
8 nonsectarian special education service which operates the special education  
9 program while providing board, lodging and transportation.

10           **(4) HOSPITALS AND CONVALESCENT HOME AID.** The full cost of special education for  
11 children in hospitals and convalescent homes for orthopedically disabled children  
12 shall be paid from the appropriation under s. 20.255 (2) (b). The supervision of such  
13 instruction shall be under the department and the school board of the school district  
14 in which the hospital or convalescent home is located. The school board of the district  
15 in which the hospital or convalescent home is located shall submit to the department  
16 an itemized statement of all revenues and expenditures for the actual cost of such  
17 instruction and any other information it requires.

18           **(6) AID FOR INSTRUCTION OUTSIDE OF DISTRICT.** From the appropriation under s.  
19 20.255 (2) (b) there shall be paid the full cost of salary and travel expenses, in  
20 amounts determined in advance by the state superintendent, to school districts for  
21 providing special education outside the school district of employment.

22           **(7) OFFSETTING RECEIPTS.** In any school year, the following revenues shall be  
23 deducted from costs aidable under this section before aids are calculated under this  
24 section:

1 (a) Any federal operational revenues expended on costs aidable under this  
2 section.

3 (b) That portion of state tuition payments attributable to the special annual  
4 tuition rate under s. 121.83 (1) (c), regardless of the school year in which the services  
5 were provided. The tuition revenues shall be allocated to the most appropriate part  
6 of a program.

7 **(8) ENROLLMENT OUT OF STATE.** If a child with a disability is enrolled in a public  
8 special education program located in another state and the state superintendent is  
9 satisfied that the program in which the child is enrolled complies with this  
10 subchapter, the state superintendent shall certify to the department of  
11 administration in favor of the school district in which the child resides or the school  
12 district attended by the child under s. 118.51 a sum equal to the percentage of the  
13 approved costs under subs. (1) and (2) of the amount expended by the school district  
14 during the preceding year for the additional costs associated with the child's special  
15 education program. The department of administration shall pay the amount to the  
16 school district from the appropriation under s. 20.255 (2) (b).

17 **(9) DISTRIBUTION SCHEDULE.** Each county, cooperative educational service  
18 agency and school district entitled to state aid under this section shall receive 15%  
19 of its total aid entitlement in each month from November to March and 25% of its  
20 total entitlement in June.

21 **115.882 Proration of state aid.** If the sum of the appropriations under s.  
22 20.255 (2) (b) and (br) in any one year is insufficient to pay the full amount of aid  
23 under ss. 115.88 and 118.255, funds in the appropriations shall be used first for the  
24 purpose of s. 115.88 (4) and any remaining funds shall be prorated among the

1 counties, school districts and cooperative educational service agencies entitled  
2 thereto.

3 **115.897 Exhaustion of remedies.** Before the filing of a civil action under any  
4 federal law seeking any relief that is also available under this subchapter, the  
5 procedures under s. 115.80 shall be exhausted to the same extent as would be  
6 required had the action been brought under this subchapter.

7 **115.898 Rule making.** Section 227.16 (2) (b) does not apply to a proposed rule  
8 if the proposed rule brings ch. PI 11, Wis. Adm. Code, into conformity with 1997  
9 Wisconsin Act .... (this act).

10 **115.90 Noncompliance; remedies.**

11 (1) If, as the result of a monitoring procedure or a complaint investigation, the  
12 state superintendent finds that a local educational agency has violated this  
13 subchapter, the state superintendent may require the local educational agency to  
14 submit a corrective plan addressing the violation.

15 (2) If the state superintendent, after reasonable notice and an opportunity for  
16 a hearing, finds that a local educational agency has failed to comply with any  
17 requirement in this subchapter, the state superintendent shall reduce or eliminate  
18 special education aid to the local educational agency until he or she is satisfied that  
19 the local educational agency is complying with that requirement.
