(a) (intro.) and shall obtain the information specified in subds. 6 1. and 4. with respect to a person specified in par. (ag) (intro.) who is under 18 years 7 of age, but not under 12 years of age, and who is an employe, prospective employe, 8 contractor, prospective contractor, nonclient resident or prospective nonclient 9 resident of a day care center that is licensed under s. 48.65 or established or 10 contracted for under s. 120.13 (14) or of a day care provider that is certified under s. 11 <u>48.651</u>:".
