4	11. Page 11, line 6: on that line and on line 7 delete "recorded <u>or</u> " and
5	substitute "recorded <u>and</u> ".
6	${f 12.}$ Page 11, line 14: delete "filed <u>or recorded</u> " and substitute " filed <u>recorded</u>
7	and filed".
8	13. Page 11, line 25: delete " <u>filed or</u> recorded" and substitute "recorded <u>and</u>
9	<u>filed</u> ".
10	14. Page 12, line 7: on that line and on lines 11 and 21 delete " <u>filed or</u> recorded"
11	and substitute "recorded <u>and filed</u> ".
12	15. Page 12, line 14: delete " <u>filed or</u> ".
13	16. Page 12, line 15: after "recorded" insert " <u>and filed</u> ".
14	17. Page 12, line 25: delete "or" and substitute "and".
15	18. Page 13, line 6: after " <u>lot</u> " insert " <u>or outlot</u> ".
16	19. Page 13, line 9: delete lines 9 to 11 and substitute: "in s. 706.01 (4).".
17	20. Page 13, line 14: delete " <u>or filed</u> " and substitute " <u>and filed</u> ".
18	21. Page 13, line 14: delete " <u>, whichever is appropriate</u> ,".
19	22. Page 14, line 4: delete " <u>filed</u> ".
20	23. Page 14, line 5: delete " <u>or</u> recorded" and substitute "recorded <u>and filed</u> ".
