**ASSEMBLY AMENDMENT 1,
TO 1999 ASSEMBLY BILL 769**

March 22, 2000 - Offered by Representatives WIECKERT, SHERMAN and HEBL.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 1: delete lines 1 to 7 and substitute:

3 “**SECTION 1g.** 343.237 (1) (a) of the statutes is renumbered 343.237 (1) (ar) and
4 amended to read:

5 343.237 (1) (ar) “Law enforcement agency of a ~~physically adjacent~~ another
6 state” ~~has the meaning given in s. 175.46 (1) (b)~~ means a governmental unit of one
7 or more persons employed by a state other than this state or by a political subdivision
8 of a state other than this state for the purpose of preventing and detecting crime and
9 enforcing laws or ordinances of that state or a political subdivision of that state,
10 employees of which unit are authorized to make arrests for crimes while acting within
11 the scope of their authority.

12 **SECTION 1r.** 343.237 (1) (ag) of the statutes is created to read:

1 343.237 (1) (ag) “Federal law enforcement agency” means a governmental unit
2 of one or more persons employed by the federal government for the purpose of
3 preventing and detecting crime and enforcing federal laws, employees of which unit
4 are authorized to make arrests for crimes while acting within the scope of their
5 authority.”.

6 **2.** Page 2, line 9: delete lines 9 and 13 and substitute:

7 “343.237 (3) (intro.) The department shall provide a Wisconsin law
8 enforcement agency or a federal law enforcement agency with a copy of a photograph
9 taken on or after September 1, 1997, of an applicant under s. 343.14 (3) or 343.50 (4)
10 if the department receives a written request on the ~~Wisconsin~~ law enforcement
11 agency’s letterhead that contains all of the following:”.

12 **3.** Page 3, line 3: delete “local, state or federal”.

13 **4.** Page 3, line 6: delete “local, state or federal”.

14 **5.** Page 3, line 8: delete lines 8 to 20 and substitute:

15 “**SECTION 5m.** 343.237 (4) (intro.) of the statutes is amended to read:

16 343.237 (4) (intro.) If a law enforcement agency of a ~~physically adjacent~~
17 another state makes a request meeting all the requirements specified for a request
18 by a Wisconsin law enforcement agency or federal law enforcement agency under
19 sub. (3), the department shall comply with the request if all of the following apply:

20 **SECTION 5t.** 343.237 (4) (a) of the statutes is amended to read:

21 343.237 (4) (a) The law enforcement agency of the ~~physically adjacent~~ other
22 state agrees to comply with all the requirements under this section.
