- "Section 1m. 20.143 (1) (c) of the statutes, as affected by 1999 Wisconsin Act 9, is amended to read:
- 20.143 (1) (c) Wisconsin development fund; grants, loans, reimbursements and assistance. Biennially, the amounts in the schedule for grants under ss. 560.145, 560.16, 560.175, 560.26; for grants and loans under ss. 560.62, 560.63 and 560.66; for loans under s. 560.147; for reimbursements under s. 560.167; for providing assistance under s. 560.06; for the costs specified in s. 560.607; for the loan under

- 1999 Wisconsin Act 9, section 9110 (4); for making payments under s. 93.75 of not more than \$3,000,000 in each fiscal year through fiscal year 2005–06; and for the grants under 1995 Wisconsin Act 27, section 9116 (7gg), 1995 Wisconsin Act 119, section 2 (1), 1997 Wisconsin Act 27, section 9110 (6g), and 1999 Wisconsin Act 9, section 9110 (5). Of the amounts in the schedule, \$50,000 shall be allocated in each of fiscal years 1997–98 and 1998–99 for providing the assistance under s. 560.06 (1). - **6.** Page 2, line 20: delete "payments" and substitute "awards".
  - **7.** Page 3, line 2: delete "payments" and substitute "awards".
- **8.** Page 3, line 3: before that line insert:
  - "(3e) PAYMENTS. At the request of the department of agriculture, trade and consumer protection, the department of commerce shall make a payment from the appropriation under s. 20.143 (1) (c) to a person equal to the amount of an award made under sub. (2).".
    - **9.** Page 4, line 3: delete "a payment" and substitute "an award".
