April 5, 2002 – Offered by Senators Chvala, Risser, Moen and Burke.

Unless election officials are selected under s. 7.30 8 (4) (c) without regard to party affiliation, the employees at the each central counting 9 location, other than any specially trained technicians who are required for the 10 operation of the automatic tabulating equipment, shall be equally divided between 11 members of the 2 major political parties under s. 7.30 (2) (a) and all duties performed by the employees shall be by teams consisting of an equal number of members of each 12political party whenever sufficient persons from each party are available. 13

(1) shall 16 check the container returned containing the ballots to determine that all seals are 17intact, and thereupon shall open the container, check the inspectors' slip and 18 compare the number of ballots so delivered against the total number of electors of 19 each ward served by the polling place who voted, remove the ballots or record of the 20votes cast and deliver them to the technicians operating the automatic tabulating 21equipment. Any discrepancies between the number of ballots and total number of 22electors shall be noted on a sheet furnished for that purpose and signed by the 23election officials.
