6 "(ad) "Cultural competency" means the ability of an individual or private 7 agency to understand and act respectfully toward, in a cultural context, the beliefs, 8 interpersonal styles, attitudes, and behaviors of persons and families of various 9 cultures, including persons and families of various cultures who participate in 10 services from the individual or private agency and persons of various cultures who 11 provide services for the individual or private agency.".

12 **3.** Page 3, line 9: delete "(a)" and substitute "(ag)".

13 **4.** Page 4, line 8: delete "(km)" and substitute "(f)".

**5.** Page 5, line 1: after "persons." insert "Those request-for-proposal procedures shall include a requirement that a private agency that applies for a grant under par. (a) include in its grant application proof that the private agency has the cultural competency to provide services under the grant to persons and families in the various cultures in the private agency's target population and that cultural competency is incorporated in the private agency's policies, administration, and practices.".
