**ASSEMBLY AMENDMENT 113,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2001 SENATE BILL 55**

June 29, 2001 – Offered by Representatives MORRIS-TATUM, COGGS, WILLIAMS and YOUNG.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 16, line 16: after that line insert:

3 **“SECTION 108m.** 13.48 (35) of the statutes is created to read:

4 13.48 **(35)** HOLY REDEEMER INSTITUTIONAL CHURCH OF GOD IN CHRIST, YOUTH AND
5 FAMILY CENTER. (a) The building commission may authorize up to \$1,500,000 in
6 general fund supported borrowing to aid in the construction of a youth and family
7 center for the Holy Redeemer Institutional Church of God in Christ in the city of
8 Milwaukee. The state funding commitment under this paragraph shall be in the
9 form of a grant to HR Academy, Inc. Before approving any such state funding
10 commitment, the building commission shall determine that the Holy Redeemer
11 Institutional Church of God in Christ has secured additional funding at least equal

1 to \$3,500,000 from nonstate donations for the purpose of constructing a youth and
2 family center.

3 (b) If the building commission authorizes a grant under par. (a) and if, for any
4 reason, the facility that is constructed with funds from the grant is not used as a
5 youth and family center, the state shall retain an ownership interest in the facility
6 equal to the amount of the state's grant.”.

7 **2.** Page 290, line 9: after that line insert:

8 “(bm) Principal repayment, interest,

9 and rebates; Holy Redeemer

10 Institutional Church of God in

11 Christ GPR S -0- -0-”.

12 **3.** Page 414, line 10: after “(3) (a), (b),” insert “(bm)”.

13 **4.** Page 421, line 18: after that line insert:

14 “**SECTION 973r.** 20.866 (2) (zbg) of the statutes is created to read:

15 20.866 (2) (zbg) *Holy Redeemer Institutional Church of God in Christ.* From
16 the capital improvement fund, a sum sufficient for the building commission to
17 provide a grant to the Holy Redeemer Institutional Church of God in Christ in the
18 city of Milwaukee to aid in the construction of a youth and family center in the city
19 of Milwaukee. The state may contract public debt in an amount not to exceed
20 \$1,500,000 for this purpose.”.

21 **5.** Page 423, line 23: after that line insert:

22 “**SECTION 978s.** 20.867 (3) (bm) of the statutes is created to read:

23 20.867 (3) (bm) *Principal repayment, interest, and rebates; Holy Redeemer*
24 *Institutional Church of God in Christ.* A sum sufficient to reimburse s. 20.866 (1) (u)

1 for the payment of principal and interest costs incurred in financing the construction
 2 of a youth and family center for the Holy Redeemer Institutional Church of God in
 3 Christ in the city of Milwaukee, and to make the payments determined by the
 4 building commission under s. 13.488 (1) (m) that are attributable to the proceeds of
 5 obligations incurred in financing the construction of a youth and family center for the
 6 Holy Redeemer Institutional Church of God in Christ.”.

7 **6.** Page 1315, line 6: after that line insert the following (and adjust the
 8 appropriate totals accordingly):

9 “(ob) HOLY REDEEMER INSTITUTIONAL CHURCH OF GOD IN
 10 CHRIST

11 1. *Projects financed by general fund supported borrowing:*

12 Youth and family center \$1,500,000

13 2. *Projects financed by gifts, grants and other receipts:*

Youth and family center 3,500,000

14 3. *Agency totals:*

15 General fund supported borrowing 1,500,000

16 Gifts, grants and other receipts 3,500,000

17 Total — All sources of funds \$ 5,000,000”.

18 **7.** Page 1321, line 15: after that line insert:

19 “(6r) HOLY REDEEMER INSTITUTIONAL CHURCH OF GOD IN CHRIST YOUTH AND FAMILY
 20 CENTER. Notwithstanding section 13.48 (35) of the statutes, as created by this act,
 21 the building commission shall not make a grant to the Holy Redeemer Institutional
 22 Church of God in Christ for the youth and family center project enumerated in

1 subsection (1) (ob) under section 13.48 (35) of the statutes, as created by this act,
2 unless the department of administration has reviewed and approved the plans for
3 the project. Notwithstanding sections 16.85 (1) and 16.855 (1) of the statutes, the
4 department of administration shall not supervise any services or work or let any
5 contract for the project. Section 16.87 of the statutes does not apply to the project.”.
