**ASSEMBLY AMENDMENT 80,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2001 SENATE BILL 55**

June 29, 2001 – Offered by Representative J. LEHMAN.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 16, line 16: after that line insert:

3 “**SECTION 108m.** 13.48 (32r) of the statutes is created to read:

4 13.48 (**32r**) DEBT INCREASE FOR CONSTRUCTION OF THE DISCOVERY PLACE MUSEUM.

5 (a) Subject to par. (b), the building commission may authorize \$1,000,000 of general
6 fund supported borrowing to aid in the construction of the Discovery Place museum
7 as part of the Heritage museum in the city of Racine. The state funding commitment
8 for the construction of the museum shall be in the form of a construction grant to the
9 city of Racine. Before approving any state funding commitment for the museum and
10 before awarding the construction grant under this paragraph, the building
11 commission shall determine that the city of Racine has secured additional funding
12 commitments of at least \$1,000,000 from nonstate revenue sources.

1 (b) If the building commission authorizes a grant to the city of Racine under par.
2 (a) and if, for any reason, the facility that is constructed with funds from the grant
3 is not used as a Discovery Place museum as part of the Heritage museum, the state
4 shall retain an ownership interest in the facility equal to the amount of the state's
5 grant."

6 **2.** Page 290, line 13: after that line insert:

7 "(bt) Principal repayment, interest,
8 and rebates; Racine Discovery
9 Place museum GPR S -0- -0-".

10 **3.** Page 332, line 19: after "(5e)," insert "for funding for a museum in Racine
11 under s. 23.0963,".

12 **4.** Page 332, line 22: after "act)," insert "section 605,".

13 **5.** Page 333, line 6: after "(5e)," insert "for funding for a museum in Racine
14 under s. 23.0963,".

15 **6.** Page 333, line 7: after that line insert:

16 "**SECTION 605c.** 20.370 (5) (cq) of the statutes, as affected by 2001 Wisconsin
17 Act (this act), section 605b, is amended to read:

18 20.370 (5) (cq) *Recreation aid — recreational boating and other projects.* As a
19 continuing appropriation, the amounts in the schedule for recreational boating aids
20 under s. 30.92, for the grant for Black Point Estate under s. 23.0962, for the Portage
21 levee system and the Portage canal under s. 31.309, for development of a state park
22 under s. 23.198, for funding for the Fox River Navigational System Authority under
23 s. 237.08 (2), ~~for funding for a museum in Racine under s. 23.0963,~~ and for the
24 engineering and environmental study under s. 31.307."

1 **7.** Page 414, line 10: after “(br),” insert “(bt),”.

2 **8.** Page 421, line 24: after that line insert:

3 “**SECTION 974r.** 20.866 (2) (zbq) of the statutes is created to read:

4 20.866 (2) (zbq) *City of Racine; Discovery Place museum.* From the capital
5 improvement fund, a sum sufficient to provide a grant to the city of Racine, to aid in
6 the construction of the Discovery Place museum as part of the Heritage museum.
7 The state may contract public debt in an amount not to exceed \$1,000,000 for this
8 purpose.”.

9 **9.** Page 423, line 23: after that line insert:

10 “**SECTION 978t.** 20.867 (3) (bt) of the statutes is created to read:

11 20.867 (3) (bt) *Principal repayment, interest, and rebates; Discovery Place*
12 *museum.* A sum sufficient to reimburse s. 20.866 (1) (u) for the payment of principal
13 and interest costs incurred in financing the construction grant under s. 13.48 (32r),
14 and to make the payments determined by the building commission under s. 13.488
15 (1) (m) that are attributable to the proceeds of obligations incurred in financing the
16 construction grant under s. 13.48 (32r).”.

17 **10.** Page 448, line 2: after that line insert:

18 “**SECTION 1036m.** 23.0963 of the statutes is created to read:

19 **23.0963 Discovery Place museum.** (1) From the appropriation under s.
20 20.370 (5) (cq), beginning with fiscal year 2001–02 and ending with 2004–05, the
21 department, subject to sub (2), shall provide \$500,000 in funding in each fiscal year
22 to the city of Racine for the construction of the Discovery Place museum as part of
23 the Heritage museum in the city of Racine.

1 **(2)** The department may not provide the funding for construction under sub.
 2 (1) unless the department of administration has reviewed and approved the
 3 applicable plans for the construction.”.

4 **11.** Page 1315, line 6: after that line insert (and adjust the appropriate totals
 5 accordingly):

6 “(p) OTHER PROJECTS

7 1. *Projects financed by general fund supported borrowing:*

17 **12.** Page 1322, line 12: after that line insert:

18 “(13r) DISCOVERY PLACE MUSEUM.

19 (a) Notwithstanding section 13.48 (32r) of the statutes, as created by this act,
 20 the building commission shall not make any grant to the city of Racine for the
 21 Discovery Place museum project enumerated in subsection (1) (p) under section
 22 13.48 (32r) of the statutes, as created by this act, unless the department of
 23 administration has reviewed and approved the plans for the project.

1 Notwithstanding sections 16.85 (1) and 16.855 (1) of the statutes, the department of
2 administration shall not supervise any services or work or let any contract for the
3 project. Section 16.87 of the statutes does not apply to the project.”.

4 **13.** Page 1422, line 3: after that line insert:

5 “(2r) RACINE MUSEUM. The treatment of section 20.370 (5) (cq) (by SECTION 605c)
6 of the statutes takes effect on July 1, 2005.”.
