TO 2003 ASSEMBLY BILL 111**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 16: delete the material beginning with “operator’s” and ending  
3 with “343.50” on line 18 and substitute “, current, laminated photo identification  
4 card issued to the person within the previous 8 years by a governmental entity,  
5 college, or university if the card contains the current address of the elector”

6 **2.** Page 6, line 15: delete the material beginning with “operator’s” and ending  
7 with “343.50” on line 16 and substitute “, current, laminated photo identification  
8 card issued to the person within the previous 8 years by a governmental entity,  
9 college, or university if the card contains the current address of the elector”.

10 **3.** Page 7, line 15: delete the material beginning with “operator’s” and ending  
11 with “343.50” on line 16 and substitute “, current, laminated photo identification  
12 card issued to the person within the previous 8 years by a governmental entity,  
13 college, or university if the card contains the current address of the elector”.

1           **4.** Page 9, line 10: delete the material beginning with “operator’s” and ending  
2 with “343.50” on line 11 and substitute “, current, laminated photo identification card  
3 issued to the person within the previous 8 years by a governmental entity, college,  
4 or university if the card contains the current address of the elector”.

5           **5.** Page 10, line 8: delete the material beginning with “operator’s” and ending  
6 with “343.50” on line 10 and substitute “, current, laminated photo identification  
7 card issued to the person within the previous 8 years by a governmental entity,  
8 college, or university if the card contains the current address of the elector”.

9           **6.** Page 10, line 20: delete the material beginning with “operator’s” and ending  
10 with “343.50” on line 22 and substitute “, current, laminated photo identification  
11 card issued to the person within the previous 8 years by a governmental entity,  
12 college, or university if the card contains the current address of the elector”.

13           **7.** Page 11, line 8: delete the material beginning with “operator’s” and ending  
14 with “343.50” on line 10 and substitute “, current, laminated photo identification  
15 card issued to the person within the previous 8 years by a governmental entity,  
16 college, or university if the card contains the current address of the elector”.

17           **8.** Page 14, line 9: delete the material beginning with “operator’s” and ending  
18 with “343.50” on line 11 and substitute “, current, laminated photo identification card  
19 issued to the person within the previous 8 years by a governmental entity, college,  
20 or university if the card contains the current address of the elector”.

21           **9.** Page 19, line 10: delete the material beginning with “operator’s” and ending  
22 with “343.50” on line 12 and substitute “, current, laminated photo identification

1 card issued to the person by a governmental entity, college, or university, if the card  
2 contains the current address of the elector”.
