 TO ASSEMBLY SUBSTITUTE AMENDMENT 1, TO 2003 ASSEMBLY BILL 67May 29, 2003 - Offered by Representatives Morris, Young, A Williams, Coggs and TAYLOR.

At the locations indicated, amend the substitute amendment as follows:

1. Page 3 , line 2 : before the colon insert ", unless the employee or prospective employee does not apply the refusal in the same manner to all patients and prospective patients".
2. Page 5, line 16: delete "No hospital" and substitute "No Except as provided in sub. (4m), no hospital".
3. Page 5 , line 18: delete that line and substitute "procedure or removing a human embryo or fetus. A any of the following:".
4. Page 5 , line 19: delete that line and substitute:
"(b) Except as provided in sub. (4m), a physician or any other person who is a member of or associated with the".
5. Page 6, line 1: delete "(c) A physician" and substitute "(c) Except as provided in sub. (4m), a physician".
6. Page 7, line 17: delete "No A hospital" and substitute " No Except as provided in sub. (4m), a hospital".
7. Page 7, line 23: delete "No hospital" and substitute "No Except as provided in sub. (4m), no hospital".
8. Page 8 , line 23 : after that line insert:
"Section 14m. $253.09(4 \mathrm{~m})$ of the statutes is created to read:
253.09 ( $4 \mathbf{m}$ ) (a) Subsections (1r) (b) and (c), (2), and (3) do not apply unless a physician, employee, or other person who refuses to participate in an activity specified in sub. (1r) (a) 1. to 8. makes the same refusal with respect to all patients and prospective patients.
(b) Subsection (1r) (a) does not apply unless a hospital that refuses to admit a patient or allow the use of the hospital facilities for a patient for the purpose of performing any activity specified in sub. (1r) (a) 1 to 8 . makes the same refusal for all patients and prospective patients.".
9. Page 9, line 14: delete "No A person" and substitute "No Except as provided in sub. (9), a person".
10. Page 11, line 6: delete "A person" and substitute "Except as provided in sub. (9), a person".
11. Page 11 , line 22 : after that line insert:
"Section 21m. 441.06 (9) of the statutes is created to read:
441.06 (9) Subsections (6) (b) and (7) do not apply to a person licensed as a registered nurse under this section or as a practical nurse under s. 441.10 unless he or she makes the same refusal for all patients and prospective patients.".
12. Page 12, line 3: delete "No $\underline{A}$ person" and substitute "No Except as provided in par. (au), a person".
13. Page 13, line 19: delete "A person" and substitute "Except as provided in par. (au), a person".
14. Page 14 , line 18 : after that line insert:
"SECTION 27m. 448.03 (5) (au) of the statutes is created to read:
448.03 (5) (au) Paragraphs (am) and (ao) do not apply to a person licensed or certified under this subchapter unless he or she makes the same refusal for all patients and prospective patients".
15. Page 15, line 9: delete "A person" and substitute "Except as provided in sub. (4), a person".
16. Page 16, line 8: delete "A person" and substitute "Except as provided in sub. (4), a person".
17. Page 16 , line 22 : after that line insert:
"(4) Subsections (2) and (3) (a) do not apply to a person licensed as a pharmacist under this chapter unless he or she makes the same refusal for all patients and prospective patients.".
18. Page 16, line 25: delete "and (5), 441.06 (title), (7), and" and substitute "(4m), and (5), 441.06 (title), (7),".
19. Page 17, line 1: delete "(8), 448.03 (5) (title), (a), (ag), (am) 1. to 8., (ao), and (ar)" and substitute "(8), and (9), 448.03 (5) (title), (a), (ag), (am) 1. to 8., (ao), (ar), and (au)".
