



**ASSEMBLY AMENDMENT 49,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2005 ASSEMBLY BILL 100**

June 21, 2005 – Offered by Representative YOUNG.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 174, line 4: increase the dollar amount for fiscal year 2005–06 by
3 \$75,000 to increase funding for the Walnut Way House neighborhood resource center.

4 **2.** Page 294, line 10: after that line insert:

5 “**SECTION 330c.** 20.435 (7) (bc) of the statutes is amended to read:

6 20.435 (7) (bc) *Grants for community programs.* The amounts in the schedule
7 for grants for community programs under s. 46.48 and for a grant under 2005
8 Wisconsin Act (this act), section 9121 (16q). Notwithstanding ss. 20.001 (3) (a) and
9 20.002 (1), the department may transfer funds between fiscal years under this
10 paragraph. Notwithstanding ss. 20.001 (3) (b) and 20.002 (1), the department of
11 health and family services may credit or deposit into this appropriation funds for the
12 purpose specified in s. 46.48 (13) that the department transfers from the

1 appropriation under par. (bL) that are allocated by the department under that
2 appropriation but unexpended or unencumbered on June 30 of each year. Except for
3 amounts authorized to be carried forward under s. 46.48 and as otherwise provided
4 in this paragraph, all funds allocated but not encumbered by December 31 of each
5 year lapse to the general fund on the next January 1 unless carried forward to the
6 next calendar year by the joint committee on finance. Notwithstanding ss. 20.001
7 (3) (a) and 20.002 (1), the department shall transfer from this appropriation account
8 to the appropriation account for the department of workforce development under s.
9 20.445 (3) (dz) funds allocated by the department under s. 46.48 (30) but unexpended
10 on June 30 of each year.

11 **SECTION 330d.** 20.435 (7) (bc) of the statutes, as affected by 2005 Wisconsin Act
12 (this act), is amended to read:

13 20.435 (7) (bc) *Grants for community programs.* The amounts in the schedule
14 for grants for community programs under s. 46.48 and for a grant under 2005
15 Wisconsin Act (this act), section 9121 (16q). Notwithstanding ss. 20.001 (3) (a) and
16 20.002 (1), the department may transfer funds between fiscal years under this
17 paragraph. Notwithstanding ss. 20.001 (3) (b) and 20.002 (1), the department of
18 health and family services may credit or deposit into this appropriation funds for the
19 purpose specified in s. 46.48 (13) that the department transfers from the
20 appropriation under par. (bL) that are allocated by the department under that
21 appropriation but unexpended or unencumbered on June 30 of each year. Except for
22 amounts authorized to be carried forward under s. 46.48 and as otherwise provided
23 in this paragraph, all funds allocated but not encumbered by December 31 of each
24 year lapse to the general fund on the next January 1 unless carried forward to the
25 next calendar year by the joint committee on finance. Notwithstanding ss. 20.001

1 (3) (a) and 20.002 (1), the department shall transfer from this appropriation account
2 to the appropriation account for the department of workforce development under s.
3 20.445 (3) (dz) funds allocated by the department under s. 46.48 (30) but unexpended
4 on June 30 of each year.”.

5 **3.** Page 980, line 9: after that line insert:

6 “(16q) WALNUT WAY HOUSE NEIGHBORHOOD RESOURCE CENTER. From the
7 appropriation account under section 20.435 (7) (bc) of the statutes, as affected by this
8 act, the department of health and family services shall award a grant of \$75,000 in
9 fiscal year 2005–06 for building improvements to create the Walnut Way House
10 neighborhood resource center.”.

11 **4.** Page 1045, line 21: after that line insert:

12 “(14q) WALNUT WAY HOUSE NEIGHBORHOOD RESOURCE CENTER. The treatment of
13 section 20.435 (7) (bc) (by SECTION 330d) of the statutes takes effect on June 30,
14 2006.”.
