## ASSEMBLY AMENDMENT 1, TO 2005 ASSEMBLY BILL 132

May 2, 2005 – Offered by Representative PRIDEMORE.

1	At the locations indicated, amend the bill as follows:
2	<b>1.</b> Page 1, line 2: delete that line and substitute "and opening of dams.".
3	<b>2.</b> Page 2, line 1: after "remove" insert " <u>or permanently open</u> ".
4	<b>3.</b> Page 2, line 1: after "removed" insert " <u>or permanently opened</u> ".
5	<b>4.</b> Page 2, line 3: after " <u>removal</u> " insert " <u>or opening</u> ".
6	<b>5.</b> Page 2, line 4: after " <u>removal</u> " insert " <u>or opening</u> ".
7	<b>6.</b> Page 2, line 5: substitute " <u>the removal or opening is started</u> " for " <u>beginning</u>
8	<u>the removal</u> ".
9	<b>7.</b> Page 2, line 6: substitute "therof <u>of the dam</u> " for "thereof".
10	8. Page 2, line 8: after that line insert:
11	"SECTION 1m. 31.253 (title) of the statutes is amended to read:

3	<b>9.</b> Page 2, line 11: after "removal" insert "or the permanent opening".
4	<b>10.</b> Page 2, line 12: after " <u>removal</u> " insert " <u>or opening</u> ".
5	<b>11.</b> Page 2, line 13: after " <u>removal</u> " insert " <u>or opening</u> ".
6	<b>12.</b> Page 2, line 14: after "removal" insert " <u>or opening</u> ".
7	<b>13.</b> Page 2, line 15: after "removal" insert " <u>or opening</u> ".
8	<b>14.</b> Page 2, line 18: substitute "deems <u>considers</u> " for "deems".
9	<b>15.</b> Page 2, line 18: after that line insert:
10	"SECTION 3m. 31.253 (2) of the statutes is amended to read:
11	31.253 (2) OPPORTUNITY FOR HEARING PRIOR TO COURT ACTION. Except as provided
12	under sub. (4), a court may not order or authorize the removal <u>or permanent opening</u>
13	of a dam in an enforcement action under this chapter unless a public informational
14	hearing or an opportunity for a public informational hearing was provided.
15	<b>SECTION 4m.</b> 31.253 (3) of the statutes is amended to read:
16	31.253 (3) PUBLIC INFORMATIONAL HEARING. If the department conducts a public
17	informational hearing under this section, the department shall explain the basis for
18	its decision to seek or cause the removal or permanent opening of the dam, the
19	procedures which will be followed and opportunities for citizen involvement in those
20	procedures and the department shall provide an opportunity for citizens to present
21	comments, testimony and evidence concerning the removal <u>or permanent opening</u> of

- 1 the dam. Notwithstanding s. 227.42, this hearing may not be converted or treated
- 2 as a contested case.".
