## ASSEMBLY AMENDMENT 2, TO 2005 ASSEMBLY BILL 670

January 6, 2006 – Offered by Representative SHERMAN.

1	At the locations indicated, amend the bill as follows:
<b>2</b>	<b>1.</b> Page 2, line 1: delete "The" and substitute " <del>The</del> <u>Except as provided in par.</u>
3	<u>(c), the</u> ".
4	<b>2.</b> Page 2, line 3: delete that line and substitute:
5	"2. <del>The town, village or city <u>Except</u> as provided in par. (c), the county</del> treasurer
6	shall settle for the amounts".
7	<b>3.</b> Page 2, line 10: delete "The" and substitute " <del>The <u>Except</u> as provided in par.</del>
8	<u>(c), the</u> ".
9	<b>4.</b> Page 2, line 15: delete that line and substitute:
10	"2. <del>The town, village or city <u>Except</u> as provided in par. (c), the county</del> treasurer
11	shall settle for the amounts".
12	${f 5.}$ Page 2, line 23: delete the material beginning with that line and ending with
13	page 3, line 4, and substitute:

1	"SECTION 1m. 79.10 (7m) (c) of the statutes is created to read:								
2	79.10 (7m) (c) Distribution to certain municipalities. 1. If, in any year, the total								
3	of the amounts determined under subs. (4) and (5) for any municipality is \$3,000,000								
4	or more, the municipality, with the approval of the majority of the members of the								
5	municipality's governing body, may notify the department of administration to								
6	distribute the amounts directly to the municipality and the department of								
7	administration shall distribute the amounts at the time and in the manner provided								
8	under pars. (a) 1. and (b) 1.								
9	2. The treasurer of the municipality shall settle for the amounts distributed								
10	under par. (a) 1. on the 4th Monday in July with the appropriate county treasurer								
11	not later than August 20. Failure to settle timely under this subdivision subjects the								
12	treasurer of the municipality to the penalties under s. 74.31. On or before August								
13	20, the county treasurer shall settle with each taxing jurisdiction, including towns,								
14	villages, and cities, except 1st class cities, in the county.								
15	3. The treasurer of the municipality shall settle for the amounts distributed								
16	under par. (b) 1. on the 4th Monday in March with each taxing jurisdiction within								
17	the taxation district not later than April 15. Failure to settle timely under this								
18	subdivision subjects the treasurer of the municipality to the penalties under s. 74.31.								
19	On or before August 20, the county treasurer shall settle with each taxing								
20	jurisdiction, including towns, villages, and cities, except 1st class cities, in the								
21	county.								
22	<b>SECTION 2m.</b> 79.10 (8) of the statutes is renumbered 79.10 (8) (b).								
23	SECTION 2n. 79.10 (8) (a) of the statutes is created to read:								
24	79.10 (8) (a) If a county receives a payment under this section that, under s.
