6	under subch. III of ch. 149 for deposit in the Health Insurance Risk–Sharing Plan
7	fund under s. 149.11 (2).".

5	6. Page 42, line 9: delete that line and substitute "sufficient to cover the
6	portion of plan costs specified in s. 149.143 (1) (a).".

8	"SECTION 127m. 149.143 (1) (a) of the statutes, as affected by 2005 Wisconsin
9	Act (this act), is repealed and recreated to read:

"(5) GENERAL PURPOSE REVENUE FUNDING FOR PLAN. The treatment of sections
20.145 (5) (a) (by SECTION 37m), 149.11 (2) (a) 7., and 149.143 (1) (a) (by SECTION
