Page 7, line 5: delete "(r)" and substitute "(ut)". 3 **3.** Page 7, line 21: after that line insert: 4 5 "SECTION 20m. 153.05 (2r) (intro.) of the statutes, as created by 2005 Wisconsin 6 Act (this act). is amended to read: 7 153.05 (2r) (intro.) Notwithstanding s. 16.75 (1), (2), and (3m), from the 8 appropriation account under s. 20.515 (1) (ut) the department of employee trust 9 funds may expend up to \$150,000, and from the appropriation accounts under s. 10 20.435 (1) (hg) and (hi) the department of health and family services, in its capacity 11 as a public health authority, may expend moneys, to contract jointly with a data 12organization to perform services under this chapter that are specified for the data organization under sub. (1) (c) or, if s. 153.455 (4) applies, for the department of 13health and family services to perform or contract for the performance of these 14services. "SECTION 72m. Appropriation changes.

(1) CONTRACT WITH DATA ORGANIZATION. In the schedule under section 20.005 (3)
of the statutes for the appropriation to the department of employee trust funds under
section 20.515 (1) (ut) of the statutes, as affected by the acts of 2005, the dollar
amount is increased by \$150,000 for fiscal year 2006–07 to provide one-time funding
for the costs of contracting for data collection, analysis, and reporting of health care
claims information by a data organization.".

1	5. Page 22, line 3: after that line insert:
2	"(5) FUNDING BY THE DEPARTMENT OF EMPLOYEE TRUST FUNDS. The treatment of
3	sections 20.515 (1) (ut) (by Section 10n) and 153.05 (2r) (intro.) (by Section 20m) of
4	the statutes takes effect on June 30, 2007.".
