**SENATE AMENDMENT 1,
TO 2005 SENATE BILL 42**

February 17, 2005 – Offered by JOINT COMMITTEE ON FINANCE.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 1: before that line insert:

3 “**SECTION 1g.** 5.35 (6) (a) 2. of the statutes is amended to read:

4 5.35 (6) (a) 2. A copy of the election fraud laws provided in s. 12.13 (1) and (3)
5 (intro), (d), (f), (g), (k), (L), (o), (q), (r), (u), (v) and (x), together with the applicable
6 penalties provided in s. 12.60 (1).”.

7 **2.** Page 3, line 1: delete “**SECTION 1**” and substitute “**SECTION 1r**”.

8 **3.** Page 3, line 10: after “343.50.” insert “If any document presented by the
9 applicant is not acceptable proof of residence under s. 6.55 (7), the applicant shall
10 also present acceptable proof of residence under s. 6.55 (7).”.

11 **4.** Page 6, line 6: after that line insert:

12 “**SECTION 8g.** 6.29 (2) (a) of the statutes is amended to read:

1 6.29 (2) (a) Any qualified elector of a municipality who has not previously filed
2 a registration form or whose name does not appear on the registration list of the
3 municipality may register after the close of registration but not later than 5 p.m. or
4 the close of business, whichever is later, on the day before an election at the office of
5 the municipal clerk and at the office of the clerk’s agent if the clerk delegates
6 responsibility for electronic maintenance of the registration list to an agent under
7 s. 6.33 (5) (b). The elector shall complete, in the manner provided under s. 6.33 (2),
8 a registration form containing all information required under s. 6.33 (1). The elector
9 shall also provide acceptable proof of residence under s. 6.55 (7). ~~Alternatively, if the~~
10 ~~elector is unable to provide acceptable proof of residence under s. 6.55 (7), the~~
11 ~~information contained in the registration form shall be corroborated in a statement~~
12 ~~that is signed by any other elector of the municipality and that contains the current~~
13 ~~street address of the corroborating elector. The corroborating elector shall then~~
14 ~~provide acceptable proof of residence under s. 6.55 (7).~~

15 **SECTION 8r.** 6.33 (2) (b) of the statutes is amended to read:

16 6.33 (2) (b) Except as provided in s. 6.86 (3) (a) 2., the registration form shall
17 be signed by the registering elector ~~and any corroborating elector under s. 6.29 (2)~~
18 ~~(a) or 6.55 (2)~~ before the clerk, issuing officer or registration deputy. The form shall
19 contain a certification by the registering elector that all statements are true and
20 correct.”.

21 **5.** Page 7, line 12: delete “elector” and substitute “person”.

22 **6.** Page 7, line 13: delete “elector” and substitute “person”.

23 **7.** Page 7, line 14: delete “elector” and substitute “person”.

24 **8.** Page 7, line 18: delete “elector” and substitute “elector person”.

- 1 **9.** Page 7, line 23: delete “elector” and substitute “elector person”.
- 2 **10.** Page 7, line 23: delete “elector’s” and substitute “elector’s person’s”.
- 3 **11.** Page 9, line 23: delete “provided” and substitute “provided stated”.
- 4 **12.** Page 10, line 10: delete lines 10 and 11 and substitute:
- 5 “6.79 (3) (title) REFUSAL TO ~~GIVE NAME AND ADDRESS~~ PROVIDE NAME, ADDRESS,
- 6 LICENSE, OR IDENTIFICATION CARD.”.
- 7 **13.** Page 12, line 9: after “by a” insert “U.S.”.
- 8 **14.** Page 13, line 23: delete “elector” and substitute “agent”.
- 9 **15.** Page 16, line 6: delete “subs.” and substitute “subds.”.
- 10 **16.** Page 16, line 8: delete the material beginning with “, as” and ending with
- 11 “(a),” on line 9.
- 12 **17.** Page 16, line 14: delete the material beginning with “overseas elector,”
- 13 and ending with “(c),” on line 15 and substitute “overseas elector, ~~as defined in s. 6.36~~
- 14 ~~(2)~~ (e),”.
- 15 **18.** Page 17, line 1: delete “paragraph” and substitute “subsection”.
- 16 **19.** Page 17, line 2: before “uniformed” insert “U.S.”.
- 17 **20.** Page 25, line 17: before “current” insert “valid”.
- 18 **21.** Page 25, line 24: after that line insert:
- 19 “**SECTION 37m.** 12.13 (3) (v) of the statutes is repealed.”.
- 20 **22.** Page 27, line 21: before “6.86 (3) (a) 1.” insert “and”.
- 21 **23.** Page 27, line 21: delete “, and 6.87 (6)”.
