1 **AN ACT to repeal** 60.23 (24), 66.0419 (title), (1), (2) and (3), 66.0419 (4) and (5),
2 66.0421 (1) (a), 66.0421 (1) (b), 66.0422 (1) (a), 100.209, 196.04 (4) (a) 1. and
3 196.204 (7); **to renumber** 196.04 (4) (a) 2. a. to e.; **to renumber and amend**
4 66.0419 (3m), 182.017 (1) and 943.46 (1) (a); **to consolidate, renumber and**
5 **amend** 196.04 (4) (a) (intro.) and 2. (intro.); **to amend** 11.01 (17g), 20.395 (3)
6 (jh), 25.40 (1) (a) 4m., 66.0421 (title), 66.0421 (2), 66.0421 (3), 66.0421 (4),

3 (12g), 196.01 (12r), 196.85 (1m) (d), 943.46 (1) (d) and 943.46 (1) (e) of the
4 statutes; **relating to:** regulation of cable television and video service providers
5 and granting rule-making authority.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

6 **SECTION 1.** 11.01 (17g) of the statutes is amended to read:

7 11.01 (17g) “Public access channel” means a PEG channel ~~that is required~~
8 ~~under a franchise granted under s. 66.0419 (3) (b) by a city, village, or town to a cable~~
9 ~~operator, as defined in s. 66.0419 (2) (b), and, as defined in s. 66.0420 (2) (s), that is~~
10 used for public access purposes, but does not include a PEG channel that is used for
11 governmental or educational purposes.

12 **SECTION 2.** 20.395 (3) (jh) of the statutes is amended to read:

13 20.395 (3) (jh) *Utility facilities within highway rights-of-way, state funds.*
14 From the general fund, all moneys received from telecommunications providers, as
15 defined in s. 196.01 (8p), or cable television telecommunications service providers,
16 as defined in s. 196.01 (1r), for activities related to locating, accommodating,
17 operating, or maintaining utility facilities within highway rights-of-way, for such
18 purposes.

19 **SECTION 3.** 25.40 (1) (a) 4m. of the statutes is amended to read:

20 25.40 (1) (a) 4m. Moneys received from telecommunications providers or cable
21 television telecommunications service providers that are deposited in the general
22 fund and credited to the appropriation account under s. 20.395 (3) (jh).

23 **SECTION 4.** 60.23 (24) of the statutes is repealed.

1 **SECTION 5.** 66.0419 (title), (1), (2) and (3) of the statutes are repealed.

2 **SECTION 6.** 66.0419 (3m) of the statutes is renumbered 66.0420 (12), and
3 66.0420 (12) (title), (a) and (b) 2., as renumbered, are amended to read:

4 66.0420 **(12)** (title) ~~MUNICIPAL CABLE TELEVISION SYSTEM COSTS.~~ (a) Except for
5 costs for any of the following, a municipality that owns and operates a cable television
6 system, or an entity owned or operated, in whole or in part, by such a municipality,
7 may not require nonsubscribers of the cable television system to pay any of the costs
8 of the cable television system:

- 9 1. ~~Public, educational, and governmental access~~ PEG channels.
- 10 2. Debt service on bonds issued under s. 66.0619 to finance the construction,
11 renovation, or expansion of a cable television system.
- 12 3. The provision of broadband service by the cable television system, if the
13 requirements of s. 66.0422 (3d) (a), (b), or (c) are satisfied.

14 (b) 2. A majority of the governing board of the municipality votes to submit the
15 question of supporting the operation of a cable television system by the municipality
16 to the electors in an advisory referendum and a majority of the voters in the
17 municipality voting at the advisory referendum vote to support the operation of a
18 cable television system by the municipality.

19 **SECTION 7.** 66.0419 (4) and (5) of the statutes are repealed.

20 **SECTION 8.** 66.0420 of the statutes is created to read:

21 **66.0420 Video service. (1) LEGISLATIVE FINDINGS.** The legislature finds all
22 of the following:

23 (a) Video service brings important daily benefits to state residents by providing
24 news, education, and entertainment.

1 (b) Uniform regulation of all video service providers by this state is necessary
2 to ensure that state residents receive adequate and efficient video service and to
3 protect and promote the public health, safety, and welfare.

4 (c) Fair competition in the provision of video service will result in new and more
5 video programming choices for consumers in this state, and a number of providers
6 have stated their desire to provide that service.

7 (d) Timely entry into the market is critical for new entrants seeking to compete
8 with existing providers.

9 (e) This state's economy would be enhanced by additional investment in
10 communications and video programming infrastructure by existing and new
11 providers of video service.

12 (f) Minimal regulation of all providers of video service within a uniform
13 framework will promote the investment described in par. (e).

14 (g) Ensuring that existing providers of video service are subject to the same
15 regulatory requirements and procedures as new entrants will ensure fair
16 competition among all providers.

17 (h) This section is an enactment of statewide concern for the purpose of
18 providing uniform regulation of video service that promotes investment in
19 communications and video infrastructures and the continued development of this
20 state's video service marketplace within a framework that is fair and equitable to all
21 providers.

22 **(2) DEFINITIONS.** In this section:

23 (a) "Affiliate", when used in relation to any person, means another person who
24 owns or controls, is owned or controlled by, or is under common ownership or control
25 with such person.

1 (b) "Basic local exchange service area" means the area on file with the public
2 service commission in which a telecommunications video service provider provides
3 basic local exchange service, as defined in s. 196.01 (1g).

4 (c) "Cable franchise" means a franchise granted under s. 66.0419 (3) (b), 2005
5 stats.

6 (d) "Cable operator" has the meaning given in 47 USC 522 (5).

7 (e) "Cable service" has the meaning given in 47 USC 522 (6).

8 (f) "Cable system" has the meaning given in 47 USC 522 (7).

9 (g) "Department" means the department of financial institutions.

10 (h) "FCC" means the federal communications commission.

11 (i) "Franchise fee" has the meaning given in 47 USC 542 (g), and includes any
12 compensation required under s. 66.0425.

13 (j) 1. "Gross receipts" means all revenues received by and paid to a video service
14 provider by subscribers residing within a municipality for video service, including
15 all of the following:

16 a. Recurring charges for video service.

17 b. Event-based charges for video service, including pay-per-view and
18 video-on-demand charges.

19 c. Rental of set top boxes and other video service equipment.

20 d. Service charges related to the provision of video service, including activation,
21 installation, repair, and maintenance charges.

22 e. Administrative charges related to the provision of video service, including
23 service order and service termination charges.

24 2. Notwithstanding subd. 1., "gross receipts" does not include any of the
25 following:

1 a. Discounts, refunds, and other price adjustments that reduce the amount of
2 compensation received by a video service provider.

3 b. Uncollectible fees, except that any uncollectible fees that are written off as
4 bad debt but subsequently collected shall be included as gross receipts in the period
5 collected, less the expenses of collection.

6 c. Late payment charges.

7 d. Maintenance charges.

8 e. Amounts billed to video service subscribers to recover taxes, fees, surcharges
9 or assessments of general applicability or otherwise collected by a video service
10 provider from video service subscribers for pass through to any federal, state, or local
11 government agency, including video service provider fees and regulatory fees paid to
12 the FCC under 47 USC 159.

13 f. Revenue from the sale of capital assets or surplus equipment not used by the
14 purchaser to receive video service from the seller of those assets or surplus
15 equipment.

16 g. Charges, other than those described in subd. 1., that are aggregated or
17 bundled with amounts described in subd. 1. and billed to video service subscribers,
18 including but not limited to any revenues received by a video service provider or its
19 affiliates for telecommunications services, information services, or the provision of
20 directory or Internet advertising, including yellow pages, white pages, banner
21 advertisement, and electronic publishing, if a video service provider can reasonably
22 identify such charges on books and records kept in the regular course of business or
23 by other reasonable means.

24 h. Reimbursement by programmers of marketing costs actually incurred by a
25 video service provider.

1 (k) "Household" means a house, apartment, mobile home, group of rooms, or
2 single room that is intended for occupancy as separate living quarters. For purposes
3 of this paragraph, "separate living quarters" are those in which the occupants live
4 and eat separately from any other persons in the building and which have direct
5 access from the outside of the building or through a common hall.

6 (L) "Incumbent cable operator" means a person who, immediately before the
7 effective date of this paragraph, was providing cable service under a cable franchise,
8 expired cable franchise, or cable franchise extension, or under an ordinance or
9 resolution adopted or enacted by a municipality.

10 (m) "Institutional network" means a network that connects governmental,
11 educational, and community institutions.

12 (n) "Interim cable operator" means an incumbent cable operator that elects to
13 continue to provide cable service under a cable franchise as specified in sub. (3) (b)
14 2. a.

15 (o) "Issued" means, with respect to a video service franchise, issued or
16 considered to be issued by the department under sub. (3) (f) 2.

17 (p) "Large telecommunications video service provider" means a
18 telecommunications video service provider that, on January 1, 2007, had more than
19 500,000 basic local exchange access lines in this state or an affiliate of such a
20 telecommunication video service provider.

21 (q) "Low-income household" means any individual or group of individuals
22 living together as one economic unit in a household whose aggregate annual income
23 is not more than \$35,000, as identified by the United States Census Bureau as of
24 January 1, 2007.

25 (r) "Municipality" means a city, village, or town.

1 (s) “PEG channel” means a channel designated for noncommercial public,
2 educational, or governmental use.

3 (sm) “Qualified cable operator” means any of the following:

4 1. A cable operator that has provided cable service in this state for at least 3
5 years prior to applying for a video service franchise and that has never had a cable
6 franchise revoked by a municipality.

7 2. An affiliate of a cable operator specified in subd. 1.

8 3. A cable operator that, on the date that it applies for a video service franchise,
9 is one of the 10 largest video service providers in the United States as measured by
10 the total number of video service subscribers nationally.

11 4. A parent corporation of a cable operator specified in subd. 3.

12 (t) “Service tier” means a category of video service for which a separate rate is
13 charged.

14 (u) “State agency” means any board, commission, department, or office in the
15 state government.

16 (um) “Telecommunications utility” has the meaning given in s. 196.01 (10).

17 (v) “Telecommunications video service provider” means a video service provider
18 that uses facilities for providing telecommunications service, as defined in s. 196.01
19 (9m), also to provide video service.

20 (w) “Video franchise area” means the area or areas described in an application
21 for a video service franchise under sub. (3) (d) 2., as modified, if applicable, in a
22 notification made under sub. (3) (j).

23 (x) “Video programming” means programming provided by, or generally
24 considered comparable to programming provided by, a television broadcast station.

1 (y) “Video service” means any video programming service, cable service, or
2 service provided via an open video system that complies with 47 USC 573, that is
3 provided through facilities located at least in part in public rights-of-way, without
4 regard to delivery technology, including Internet protocol technology or any other
5 technology. “Video service” does not include any of the following:

6 1. Video programming provided by a commercial mobile radio service provider,
7 as defined in s. 196.01 (2g).

8 2. Video programming provided solely as part of and via a service that enables
9 users to access content, information, electronic mail, or any other service offered over
10 the public Internet.

11 (z) “Video service franchise” means a franchise issued under sub. (3) (f) 2.

12 (zb) “Video service network” means wireline facilities, or any component
13 thereof, located at least in part in the public right-of-way that deliver video service,
14 without regard to delivery technology, including Internet protocol technology or any
15 other technology. “Video service network” includes a cable system.

16 (zg) “Video service provider” means a person, including an incumbent cable
17 operator, who is issued a video service franchise or a successor or assign of such a
18 person.

19 (zm) “Video service provider fee” means the fee paid by a video service provider
20 under sub. (7).

21 **(3) AUTHORITY TO PROVIDE VIDEO SERVICE.** (a) *In general.* Except for an interim
22 cable operator, and except as provided in par. (c), no person may provide video service
23 in this state unless the department has issued a video service franchise to the person
24 and the person has provided the notice required under par. (h).

1 (b) *Incumbent cable operators.* 1. A municipality may not renew or extend the
2 cable franchise of an incumbent cable operator that expires after the effective date
3 of this subdivision [revisor inserts date].

4 2. An incumbent cable operator may do one of the following:

5 a. Continue to provide cable service as an interim cable operator until the cable
6 franchise expires.

7 b. Apply for a video service franchise. If an incumbent cable operator applies
8 for a video service franchise, the cable franchise shall terminate and have no effect
9 upon issuance of the video service franchise. Upon termination of the cable
10 franchise, the municipality that granted the franchise shall, at the request of the
11 incumbent cable operator, surrender, return, or take such other action as may be
12 necessary to nullify any bond, letter of credit, or similar instrument intended to
13 secure the performance of the incumbent cable operator under the cable franchise.

14 3. An incumbent cable operator whose cable franchise expires after the
15 effective date of this subdivision [revisor inserts date], may not, after expiration
16 of the cable franchise, provide video service in this state unless the incumbent cable
17 operator applies for a video service franchise under subd. 2. b. and, upon issuance
18 of the video service franchise, provides the notice required under par. (h). An
19 incumbent cable operator whose cable franchise expired before the effective date of
20 this subdivision [revisor inserts date], and who was providing cable service
21 immediately before the effective date of this act, may continue to provide cable
22 service if, no later than the first day of the 2nd month beginning after the effective
23 date of this subdivision [revisor inserts date], the incumbent cable operator
24 applies for a video service franchise under subd. 2. b.

1 (c) *Other providers.* A person, other than an incumbent cable operator, who was
2 providing video service immediately before the effective date of this paragraph
3 [revisor inserts date], may provide video service without a video service franchise
4 issued by the department. This paragraph ceases to apply to such a person if the
5 person does not apply for a video service franchise no later than the first day of the
6 2nd month beginning after the effective date of this paragraph [revisor inserts
7 date].

8 (d) *Application.* An applicant for a video service franchise shall submit an
9 application to the department that consists of all of the following:

10 1. The location and telephone number of the applicant's principal place of
11 business, the names of the principal executive officers of the applicant, and the
12 names of any persons authorized to represent the applicant before the department.

13 2. A description of the area or areas of the state in which the applicant intends
14 to provide video service.

15 3. The date on which the applicant intends to begin providing video service in
16 the video franchise area.

17 4. An affidavit signed by an officer or general partner of the applicant that
18 affirms all of the following:

19 a. That the applicant has filed or will timely file with the FCC all forms required
20 by the FCC in advance of offering video service.

21 b. That the applicant agrees to comply with this section and all applicable
22 federal statutes and regulations.

23 c. That the applicant is legally, financially, and technically qualified to provide
24 video service.

25 5. A description of the services that the applicant proposes to provide.

1 6. An application fee of \$1,000.

2 (e) *Service upon municipalities.* 1. At the time that an applicant submits an
3 application under par. (d), or a video service provider submits a notification
4 regarding a modification to an application under par. (j), to the department, the
5 applicant or video service provider shall serve a copy of the application or notification
6 on each municipality in the video franchise area.

7 2. a. This subdivision applies only to a municipality that, under subd. 1., is
8 served a copy of an application or that, under subd. 1., is served a copy of a
9 notification relating to an expansion of the area or areas of the state in which a video
10 service provider intends to provide video service, if the municipality has not
11 previously been served a copy of an application under subd. 1. by that video service
12 provider.

13 b. If a municipality specified in subd. 2. a. has granted any cable franchise that
14 is in effect immediately before the effective date of this subdivision [revisor inserts
15 date], the municipality shall, no later than 10 business days after receipt of the copy,
16 notify the applicant in writing of the number of PEG channels for which incumbent
17 cable operators are required to provide channel capacity in the municipality and the
18 percentage of revenues that incumbent cable operators are required to pay the
19 municipality as franchise fees.

20 (f) *Department duties.* 1. No later than 15 business days after the filing of an
21 application, the department shall notify the applicant in writing as to whether the
22 application is complete and, if the department has determined that the application
23 is not complete, the department shall state the reasons for the determination.

24 2. No later than 15 business days after the filing of an application that the
25 department has determined is complete, the department shall determine whether

1 an applicant is legally, financially, and technically qualified to provide video service.
2 If the department determines that an applicant is legally, financially, and technically
3 qualified to provide video service, the department shall issue a video service
4 franchise to the applicant. If the department determines that an applicant is not
5 legally, financially, and technically qualified to provide video service, the department
6 shall reject the application and shall state the reasons for the determination. If the
7 department fails to make the determination, the department shall be considered to
8 have issued a video service franchise to the applicant, unless the applicant
9 withdraws the application or agrees with the department to an extension of time.

10 3. Notwithstanding subd. 2., if an applicant is a telecommunications utility or
11 qualified cable operator, the department shall determine that the applicant is legally,
12 financially, and technically qualified to provide video service.

13 4. The department shall promulgate rules for determining whether an
14 applicant that is not a telecommunications utility or qualified cable operator is
15 legally, financially, and technically qualified to provide video service.

16 (g) *Effect of video service franchise.* A video service franchise issued by the
17 department authorizes a video service provider to occupy the public rights-of-way
18 and to construct, operate, maintain, and repair a video service network to provide
19 video service in the video franchise area.

20 (h) *Notice before providing service.* No later than 10 business days before
21 providing video service in a municipality in a video franchise area, a video service
22 provider shall provide notice to the department and the municipality.

23 (i) *Expiration and revocation of video service franchise.* 1. Except as provided
24 in subd. 2., a video service franchise issued to a video service provider does not expire,
25 unless the video service provider gives 30 days' advance notice to the department

1 that the video service provider intends to terminate the video service franchise. If
2 a video service provider gives such notice, the video service franchise shall expire on
3 the termination date stated in the notice.

4 2. The department may revoke a video service franchise issued to a video
5 service provider if the department determines that the video service provider has
6 willfully and knowingly repeatedly failed to substantially meet a material
7 requirement imposed upon it by this section and the department has not otherwise
8 acquiesced in such noncompliance through a waiver. Before commencing a
9 revocation proceeding, the department shall provide the video service provider
10 written notice of the department's intention to revoke the franchise and the
11 department's reasons for the revocation and afford the video service provider a
12 reasonable opportunity to cure any alleged violation. A revocation proceeding under
13 this subdivision is a contested case under ch. 227.

14 (j) *Modifications.* If there is any change in the information included in an
15 application filed by a video service provider under this subsection, the video service
16 provider shall notify the department and update the information within 10 business
17 days after the change, except that if the video service provider determines to expand
18 the area or areas of the state in which the video service provider intends to provide
19 video service, the video service provider shall notify the department as soon as
20 practicable after making such a determination but no later than 10 business days
21 before providing video service in the expansion area or areas. A video service
22 provider that makes a notification regarding a change in the information specified
23 in par. (d) 2., 3., 4., or 5., shall include with the notification a fee of \$100. No fee is
24 required for a notification regarding a change in the information specified in par. (d)
25 1.

1 **(4) FRANCHISING AUTHORITY.** For purposes of 47 USC 521 to 573, the state is the
2 exclusive franchising authority for video service providers in this state.
3 Notwithstanding s. 66.0425 and except as provided in s. 182.017, no municipality
4 may require a video service provider to obtain a franchise to provide video service or
5 impose on a video service provider any fee or requirement relating to the construction
6 of a video service network or the provision of video service, including any
7 requirement to deploy facilities or equipment or any requirement regarding rates for
8 video service, except as specifically authorized under this section.

9 **(5) PEG CHANNELS.** (a) *Maximum number of PEG channels.* 1. If an incumbent
10 cable operator is providing channel capacity for PEG channels to a municipality
11 under a cable franchise in effect immediately before the effective date of this
12 subdivision [revisor inserts date], the municipality shall require each interim
13 cable operator or video service provider that provides video service in the
14 municipality to provide channel capacity for the same number of PEG channels for
15 which channel capacity is provided immediately before the effective date of this
16 subdivision [revisor inserts date].

17 2. a. Except as provided in subd. 2. b. and c., if no incumbent cable operator is
18 providing channel capacity for PEG channels to a municipality under a cable
19 franchise that is in effect immediately before the effective date of this subd. 2. a.
20 [revisor inserts date], then, if the municipality has a population of 50,000 or more,
21 the municipality may require each interim cable operator and video service provider
22 that provides video service in the municipality to provide channel capacity for up to
23 3 PEG channels, and, if the municipality has a population of less than 50,000, the
24 municipality may require each interim cable operator and video service provider that

1 provides video service in the municipality to provide channel capacity for no more
2 than 2 PEG channels.

3 b. If an interim cable operator or video service provider distributes video
4 programming to more than one municipality through a single headend or video hub
5 office and the aggregate population of the municipalities is 50,000 or more, the
6 municipalities may not require the interim cable operator or video service provider
7 to provide, in the aggregate, channel capacity for more than 3 PEG channels under
8 subd. 2. a.

9 c. If an interim cable operator or video service provider distributes video
10 programming to more than one municipality through a single headend or video hub
11 office and the aggregate population of the municipalities is less than 50,000, the
12 municipalities may not require the interim cable operator or video service provider
13 to provide, in the aggregate, channel capacity for more than 2 PEG channels under
14 subd. 2. a.

15 3. An interim cable operator or video service provider shall provide any channel
16 capacity for PEG channels required under this paragraph on any service tier that is
17 viewed by more than 50 percent of the interim cable operator's or video service
18 provider's customers.

19 4. If a municipality is not required to provide notice to a video service provider
20 under sub. (3) (e) 2., the video service provider's duty to provide any additional
21 channel capacity for PEG channels that is required by the municipality under this
22 paragraph first applies on the date that the video service provider begins to provide
23 service in the municipality, and, if the municipality is required to provide notice
24 under sub. (3) (e) 2., the video service provider's duty to provide any such additional
25 channel capacity first applies on the date that the video service provider begins to

1 provide video service in the municipality or on the 90th day after the video service
2 provider receives the municipality's notice, whichever is later.

3 (b) *Exceptions.* 1. a. Notwithstanding par. (a), an interim cable operator or
4 video service provider may reprogram for any other purpose any channel capacity
5 provided for a PEG channel required by a municipality under par. (a) if the PEG
6 channel is not substantially utilized by the municipality. If the municipality certifies
7 to the interim cable operator or video service provider that reprogrammed channel
8 capacity for a PEG channel will be substantially utilized by the municipality, the
9 interim cable operator or video service provider shall, no later than 120 days after
10 receipt of the certification, restore the channel capacity for the PEG channel.
11 Notwithstanding par. (a) 3., an interim cable operator or video service provider may
12 provide restored channel capacity for a PEG channel on any service tier.

13 b. For purposes of this subdivision, a PEG channel is substantially utilized by
14 a municipality if the municipality provides 40 hours or more of programming on the
15 PEG channel each week and at least 60 percent of that programming is locally
16 produced.

17 2. Notwithstanding par. (a), if a municipality fails to provide the notice
18 specified in sub. (3) (e) 2. before the deadline specified in sub. (3) (e) 2., no interim
19 cable operator or video service provider is required to provide channel capacity for
20 any PEG channel until the 90th day after the municipality provides such notice.

21 (c) *Powers and duties of municipalities.* 1. Except as otherwise required under
22 par. (a), a municipality may not require an interim cable operator or video service
23 provider to provide any funds, services, programming, facilities, or equipment
24 related to public, educational, or governmental use of channel capacity.

1 2. The operation of any PEG channel for which a municipality requires an
2 interim cable operator or video service provider to provide channel capacity under
3 par. (a), and the production of any programming appearing on such a PEG channel,
4 shall be the sole responsibility of the municipality and, except as provided in par. (d)
5 1., the interim cable operator or video service provider shall bear only the
6 responsibility to transmit programming appearing on the PEG channel.

7 3. A municipality that requires an interim cable operator or video service
8 provider to provide channel capacity for a PEG channel under par. (a) shall do all of
9 the following:

10 a. Ensure that all content and programming that the municipality provides or
11 arranges to provide for transmission on the PEG channel is submitted to the interim
12 cable operator or video service provider in a manner and form that is capable of being
13 accepted and transmitted by the interim cable operator or video service provider over
14 its video service network without changing the content or transmission signal and
15 that is compatible with the technology or protocol, including Internet protocol
16 television, utilized by the interim cable operator or video service provider to deliver
17 video service.

18 b. Make the content and programming that the municipality provides or
19 arranges to provide for transmission on a PEG channel available in a
20 nondiscriminatory manner to all interim cable operators and video service providers
21 that provide video service in the municipality.

22 (d) *Duties of interim cable providers and video service provider.* 1. If a
23 municipality requires an interim cable operator or video service provider to provide
24 channel capacity for a PEG channel under par. (a), the interim cable operator or video
25 service provider shall be required to provide only the first 200 feet of transmission

1 line that is necessary to connect the interim cable operator's or video service
2 provider's video service network to one distribution point used by the municipality
3 to transmit programming for the PEG channel.

4 2. If the interconnection of the video service networks of interim cable operators
5 or video service providers is technically necessary and feasible for the transmission
6 of programming for any PEG channel for which channel capacity is required by a
7 municipality under par. (a), the interim cable operators and video service providers
8 shall negotiate in good faith for interconnection on mutually acceptable rates, terms,
9 and conditions, except that an interim cable operator or video service provider who
10 requests interconnection is responsible for interconnection costs, including the cost
11 of transmitting programming from its origination point to the interconnection point.
12 Interconnection may be accomplished by direct cable, microwave link, satellite, or
13 any other reasonable method.

14 **(6) INSTITUTIONAL NETWORKS.** Notwithstanding any franchise, ordinance, or
15 resolution in effect on the effective date of this subsection [revisor inserts date],
16 no state agency or municipality may require an interim cable operator or video
17 service provider to provide any institutional network or equivalent capacity on its
18 video service network.

19 **(7) VIDEO SERVICE PROVIDER FEE.** (a) *Duty to pay fee.* 1. Notwithstanding s.
20 66.0611 and except as provided in subd. 2., a video service provider shall, on a

13 (b) *Amount of fee.* The percentage applied to a video service provider's gross
14 receipts under par. (a) 1. for each municipality shall be 5 percent or one of the
15 following percentages, whichever is less:

16 1. If no incumbent cable operator was required to pay a franchise fee equal to
17 a percentage of gross revenues to the municipality immediately before the effective
18 date of this subdivision [revisor inserts date], the municipality may specify a
19 percentage of no more than 5 percent. The duty of a video service provider to pay the
20 municipality a video service fee equal to such percentage shall first apply to the
21 quarter that includes the 45th day after the municipality provides notice of the
22 percentage to the video service provider.

23 2. If an incumbent cable operator was required to pay a franchise fee equal to
24 a percentage of gross revenues to the municipality immediately before the effective

2 fee equal to a percentage of gross revenues to the municipality immediately before
3 the effective date of this subdivision [revisor inserts date], the lowest such

5 (c) *Generally accepted accounting principles.* All determinations and
6 computations made under this subsection shall be made pursuant to generally
7 accepted accounting principles.

8 (d) *Record review.* A municipality may, upon reasonable written request but
9 no more than once in any 3-year period, for the purpose of ensuring proper and
10 accurate payment of a video service provider fee, review the business records of a
11 video service provider that is required to pay the municipality a video service
12 provider fee.

13 (e) *Actions to enforce payment.* 1. A municipality or a video service provider
14 may not bring an action concerning the amount of a video service provider fee
15 allegedly due to the municipality unless the parties have first participated in and
16 completed good faith settlement discussions. For purposes of any future litigation,
17 all negotiations pursuant to this paragraph shall be treated as compromise
18 negotiations under s. 904.08.

19 2. An action regarding a dispute over the amount of a video service provider fee
20 paid or allegedly due under this subsection shall be commenced within 3 years
21 following the end of the calendar quarter to which the disputed amount relates or be
