1	AN ACT to create 20.292 (1) (bn) of the statutes; relating to: making
2	appropriations for nanoscience positions and equipment at the University of
3	Wisconsin-Eau Claire, the University of Wisconsin-Stout, and Chippewa
4	Valley Technical College.
	The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
5	SECTION 1. 20.005 (3) (schedule) of the statutes: at the appropriate place, insert
6	the following amounts for the purposes indicated:

9	(1) TECHNICAL COLLEGE SYSTEM

11	SECTION 2. 20.292 (1) (bn) of the statutes is created to read:

2007 – 2008 Legislature

20.292 (1) (bn) Nanotechnology. The amounts in the schedule for payments to
 Chippewa Valley Technical College under 2007 Wisconsin Act (this act), section
 3 (2), for positions and equipment related to nanotechnology. No money may be
 encumbered from this appropriation after June 30, 2009.

SECTION 3. Nonstatutory provisions.

6 (1) POSITIONS. The Board of Regents of the University of Wisconsin System 7 shall ensure that the positions authorized under SECTION 4 (1) and (3) of this act 8 support nanoscience education and training at the University of Wisconsin-Eau 9 Claire and nanoscale science and engineering education and training at the 10 University of Wisconsin-Stout.

(2) CHIPPEWA VALLEY TECHNICAL COLLEGE. In the 2007-08 and 2008-09 fiscal
years, the technical college system board shall pay the amounts specified in section
20.292 (1) (bn) of the statutes, as created by this act, to the Chippewa Valley
Technical College for nanotechnology positions and equipment.

SECTION 4. Fiscal changes.

16 (1) UNIVERSITY OF WISCONSIN-EAU CLAIRE; POSITIONS. In the schedule under 17section 20.005 (3) of the statutes for the appropriation to the Board of Regents of the 18 University of Wisconsin System under section 20.285 (1) (a) of the statutes, as 19 affected by the acts of 2007, the dollar amount is increased by \$731,250 for fiscal year 202007-08 to increase the authorized FTE positions by 4.0 GPR positions for faculty 21and staff at the University of Wisconsin-Eau Claire, and the dollar amount is 22increased by \$1,183,250 for fiscal year 2008-09 to increase the authorized FTE 23positions by 8.0 GPR positions for faculty and staff at the University of Wisconsin-Eau Claire. $\mathbf{24}$

(2) UNIVERSITY OF WISCONSIN-EAU CLAIRE; EQUIPMENT. In the schedule under 1 2 section 20.005 (3) of the statutes for the appropriation to the Board of Regents of the 3 University of Wisconsin System under section 20.285 (1) (a) of the statutes, as 4 affected by the acts of 2007, the dollar amount is increased by \$365,625 for fiscal year 5 2007-08 and the dollar amount is increased by \$365,625 for fiscal year 2008-09 to 6 acquire new nanoscience instrumentation and sample preparation equipment, and 7 to support instrumentation and laboratory maintenance and rotation, at the 8 University of Wisconsin-Eau Claire.

9 (3) UNIVERSITY OF WISCONSIN-STOUT; POSITIONS. In the schedule under section 10 20.005 (3) of the statutes for the appropriation to the Board of Regents of the 11 University of Wisconsin System under section 20.285 (1) (a) of the statutes, as 12affected by the acts of 2007, the dollar amount is increased by \$905,625 for fiscal year 13 2007-08 to increase the authorized FTE positions by 6.0 GPR positions for faculty 14and staff at the University of Wisconsin-Stout, and the dollar amount is increased 15by \$306,375 for fiscal year 2008–09 to increase the authorized FTE positions by 3.0 16 GPR positions for faculty and staff at the University of Wisconsin–Stout.

17(4) UNIVERSITY OF WISCONSIN-STOUT; EQUIPMENT. In the schedule under section 18 20.005 (3) of the statutes for the appropriation to the Board of Regents of the 19 University of Wisconsin System under section 20.285 (1) (a) of the statutes, as 20 affected by the acts of 2007, the dollar amount is increased by \$452,813 for fiscal year 212007-08 and the dollar amount is increased by \$452,812 for fiscal year 2008-09 to 22instrumentation needed acquire equipment and for advanced study. 23characterization, fabrication, and processing in nanoscale engineering at the 24University of Wisconsin-Stout.
