SENATE AMENDMENT 1, TO SENATE SUBSTITUTE AMENDMENT 1, TO 2007 SENATE BILL 308

1	At the locations indicated, amend the substitute amendment as follows:
2	1. Page 3, line 11: after that line insert:
3	"SECTION 2g. 173.13 (1) (a) 8. of the statutes is amended to read:
4	173.13 (1) (a) 8. An animal mistreated in violation of ch. 951 or of the rules
5	promulgated under s. 173.35 (6).
6	SECTION 2r. 173.21 (1) (a) of the statutes is amended to read:
7	173.21 (1) (a) There are reasonable grounds to believe that the owner has
8	mistreated the animal in violation of ch. 951 <u>or of the rules promulgated under s.</u>
9	<u>173.35 (6)</u> .".
10	2. Page 4, line 7: after that line insert:

1	"(bg) "Broker" means a person who buys a dog for the purpose of reselling the
2	dog, except that "broker" does not include a person who operates a retail store at
3	which dogs are sold.".
4	3. Page 4, line 9: after "who" insert ", at any location or locations,".
5	4. Page 4, line 13: after that line insert:
6	"(1m) DETERMINATION. The number of dogs sold or offered for sale by a person
7	for the purposes of determining whether the person is a commercial dog breeder
8	includes all dogs sold or offered for sale by related persons who engage in the business
9	of breeding dogs at the same locations as the person.".
10	5. Page 4, line 22: after that line insert:
11	"(c) 1. The department shall request a criminal history search from the records
12	maintained by the department of justice for a person who submits an application for
13	a license under this subsection. If the person is not a resident of this state, or if at
14	any time within the 3 years preceding the date of the application the person has not
15	been a resident of this state, or if the department determines that the person's
16	employment, licensing, or state court records provide a reasonable basis for further
17	investigation, the department shall make a good faith effort to obtain from any state
18	or other United States jurisdiction in which the person is a resident or was a resident
19	within the 3 years preceding the date of the application information that is relevant
20	to the determination under subd. 2.
21	2. The department may not issue a license to a person under this subsection
22	if the department determines that the person has been convicted of a violation of ch.
23	951 or of an offense that would have been a violation of ch. 951 if it had been
