ASSEMBLY AMENDMENT 2, TO 2009 ASSEMBLY BILL 21

October 29, 2009 - Offered by Representative Schneider.

At the locations indicated, amend the bill as follows:

- **1.** Page 2, line 13: delete "accident." and substitute "accident, unless at the time of the accident the operator was driving or operating a motor vehicle as follows:
- (a) While under the influence of alcohol, a controlled substance, a controlled substance analog, or any combination of alcohol, a controlled substance, or a controlled substance analog.
- (b) While under the influence of any other drug, or under the combined influence of alcohol and any other drug, to a degree that rendered the operator incapable of safely driving.
 - (c) While having a restricted controlled substance in his or her blood.
- (d) While having a prohibited alcohol concentration, as defined in s. 340.01 (46m), or, if the operator was driving or operating a commercial motor vehicle, an alcohol concentration of 0.04 or more.".
