



**ASSEMBLY AMENDMENT 69,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2009 ASSEMBLY BILL 75**

June 11, 2009 – Offered by Representatives MURSAU and FRISKE.

- 1 At the locations indicated, amend the substitute amendment as follows:
- 2 **1.** Page 146, line 16: increase the dollar amount for fiscal year 2009–10 by
\$370,000 for the purpose of state trunk highway system bridge maintenance and
repair.
- 3 **2.** Page 148, line 16: delete lines 16 to 19.
- 4 **3.** Page 294, line 3: delete lines 3 to 12.
- 5 **4.** Page 1828, line 16: delete lines 16 to 20.
- 6 **5.** Page 1829, line 5: delete lines 5 to 15.
- 7 **6.** Page 1829, line 23: delete the material beginning with that line and ending
with page 1830, line 3.

1 **7. Page 1830, line 18:** delete the material beginning with that line and ending
with page 1831, line 10.

2 **8. Page 1832, line 10:** delete lines 10 to 14.

3 **9. Page 1834, line 5:** after that line insert:

4 “(10f) STATE TRUNK HIGHWAY SYSTEM BRIDGE MAINTENANCE AND REPAIR.

5 (a) Except as provided in paragraph (b), from the appropriation accounts under
6 section 20.395 (3) (eq) and (ex) of the statutes, the department of transportation shall
7 allocate \$2,950,000 for the maintenance and repair of the 57 bridges on or crossing
8 the state trunk highway system that the department has identified as having
9 structure numbers B060013, B060016, B060017, B060019, B090078, B110025,
10 B110070, B120170, B120831, B130100, B130101, B130479, B17040, B170041,
11 B170043, B170049, B180031, B180067, B260002, B270047, B270052, B270808,
12 B280046, B290024, B290026, B290031, B290039, B290041, B290042, B290055,
13 B380513, B380902, B400125, B410068, B410389, B450056, B470982, B490028,
14 B520856, B530145, B530945, B550041, B550610, B560034, B610035, B610948,
15 B640008, B640027, B640039, B640210, B640665, B680427, B680739, B700034,
16 B700061, B700065, and B700066.

17 (b) The department of transportation may not allocate any federal funds under
18 paragraph (a) for the maintenance or repair of any bridge if the expenditure of those
19 federal funds for this purpose would violate any condition imposed by the federal
20 government on the expenditure of those federal funds.”.

21 **10. Page 1901, line 9:** delete lines 9 to 12.
