**SENATE AMENDMENT 1,
TO 2009 SENATE BILL 17**

September 25, 2009 – Offered by Senator HANSEN.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 3: after “guard” insert “, providing an exemption from
emergency rule procedures, granting rule-making authority,”.
- 3 **2.** Page 2, line 4: delete the material beginning with “the 32nd” and ending
with “Refueling Wing.” on line 5 and substitute “a Wisconsin national guard unit
identified by the department of military affairs under s. 341.14 (6m) (d) 5.”.
- 4 **3.** Page 2, line 9: delete the material beginning with “the 32nd” and ending
with “Refueling Wing,” on line 10 and substitute “a Wisconsin national guard unit
identified by the department of military affairs under subd. 5.”.
- 5 **4.** Page 2, line 17: delete the material beginning with “of the” and ending with
“Refueling Wing” on line 19 and substitute “of a Wisconsin national guard unit
identified by the department of military affairs under subd. 5.”.

1 **5.** Page 2, line 21: delete “free of charge,”.

2 **6.** Page 3, line 1: delete the material beginning with “the 32nd” and ending
with “Refueling Wing” on line 3 and substitute “a Wisconsin national guard unit
identified by the department of military affairs under subd. 5.”.

3 **7.** Page 3, line 8: after that line insert:

4 “5. The department of military affairs shall, by rule, identify each Wisconsin
5 national guard unit for which a decal is available under this paragraph.

6 6. The department shall charge a fee of \$20 for each decal provided to an
7 applicant under this paragraph.”.

8 **8.** Page 3, line 17: after that line insert:

9 “(2) The department of military affairs shall submit in proposed form the rules
10 required under section 341.14 (6m) (d) 5. of the statutes, as created by this act, to the
11 legislative council staff under section 227.15 (1) of the statutes no later than the first
12 day of the 4th month beginning after the effective date of this subsection.

13 (3) Using the emergency rules procedure under section 227.24 of the statutes,
14 the department of military affairs shall promulgate the rules required under section
15 341.14 (6m) (d) 5. of the statutes, as created by this act, for the period before the
16 effective date of the rules submitted under subsection (2). The department shall
17 promulgate these emergency rules no later than the first day of the 4th month
18 beginning after the effective date of this subsection. Notwithstanding section 227.24
19 (1) (c) and (2) of the statutes, these emergency rules may remain in effect until July
20 1, 2011, or the date on which permanent rules take effect, whichever is sooner.
21 Notwithstanding section 227.24 (1) (a) and (3) of the statutes, the department is not
22 required to provide evidence that promulgating a rule under this subsection as an

1 emergency rule is necessary for the preservation of the public peace, health, safety,
2 or welfare and is not required to provide a finding of emergency for a rule
3 promulgated under this subsection.”.

4 **9.** Page 4, line 4: delete lines 4 to 6 and substitute:

5 **“SECTION 6m. Effective dates.** This act takes effect on the first day of the 4th
6 month beginning after publication, except as follows:

7 (1) SECTION 3 (2) and (3) of this act takes effect on the day after publication.”.
