SENATE AMENDMENT 6, TO ASSEMBLY BILL 8

February 10, 2011 – Offered by Senators Taylor, Hansen, Lassa, Miller, Risser, Carpenter, T. Cullen, C. Larson, Holperin and Vinehout.

1	At the locations indicated, amend the bill, as shown by assembly substitute
2	amendment 1, as follows:
3	1. Page 9, line 7: delete " <u>An</u> " and substitute " <u>Except as provided in sub. (2m)</u> ,
4	<u>an</u> ".
5	2. Page 9, line 22: after " <u>rule</u> " insert " <u>to which this subsection applies</u> ".
6	3. Page 9, line 25: after that line insert:
7	"SECTION 4g. 227.135 (2m) of the statutes is created to read:
8	227.135 (2m) If the educational communications board, the employment
9	relations commission, the government accountability board, the higher educational
10	aids board, the office of the commissioner of insurance, the public service
11	commission, the state historical society, the investment board, the public defender
12	board, the technical college system board, or the Board of Regents of the University
13	of Wisconsin System prepares a statement of the scope of a proposed rule, that agency

1	shall present the statement to the individual or body with policy-making powers
2	over the subject matter of the proposed rule for approval. The individual or body with
3	policy-making powers may not approve the statement until at least 10 days after
4	publication of the statement under sub. (3). No state employee or official may
5	perform any activity in connection with the drafting of a proposed rule to which this
6	subsection applies except for an activity necessary to prepare the statement of the
7	scope of the proposed rule until the individual or body with policy-making powers
8	approves the statement.".
9	4. Page 10, line 4: after "register." insert "If a statement of the scope of a
10	proposed rule is presented to the individual or body with policy-making powers over
11	the subject matter of the proposed rule under sub. (2m), the agency presenting the
12	statement shall send the statement to the legislative reference bureau for
13	<u>publication in the register.</u> ".
14	5. Page 10, line 9: after "(2)" insert "or (2m)".
15	6. Page 10, line 15: after "(2)" insert "or under subs. (1) and (2m)".
16	7. Page 16, line 1: delete "After" and substitute "Except as provided in this
17	section, after".
18	8. Page 16, line 8: after "writing." insert "This section does not apply to a
19	proposed rule drafted by the educational communications board, the employment
20	relations commission, the government accountability board, the higher educational
21	aids board, the office of the commissioner of insurance, the public service
22	commission, the state historical society, the investment board, the public defender
23	board, the technical college system board, or the Board of Regents of the University
24	of Wisconsin System.".
