**ASSEMBLY AMENDMENT 4,
TO 2011 ASSEMBLY BILL 232**

October 20, 2011 – Offered by Representative MOLEPSKE JR.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 3: after “witnesses” insert “and making an appropriation”.

3 **2.** Page 2, line 21: after that line insert:

4 **“SECTION 4m. Fiscal changes.**

5 (1) AWARDS FOR VICTIMS OF CRIMES. In the schedule under section 20.005 (3) of
6 the statutes for the appropriation to the department of justice under section 20.455
7 (5) (b) of the statutes, as affected by the acts of 2011, the dollar amount is increased
8 by \$124,500 for the first fiscal year of the fiscal biennium in which this subsection
9 takes effect to increase funding for awards for victims of crimes. In the schedule
10 under section 20.005 (3) of the statutes for the appropriation to the department of
11 justice under section 20.455 (5) (b) of the statutes, as affected by the acts of 2011, the
12 dollar amount is increased by \$124,500 for the second fiscal year of the fiscal

1 biennium in which this subsection takes effect to increase funding for awards for
2 victims of crimes.

3 (2) CRIME VICTIM RESTITUTION. In the schedule under section 20.005 (3) of the
4 statutes for the appropriation to the department of justice under section 20.455 (5)
5 (hh) of the statutes, as affected by the acts of 2011, the dollar amount is increased
6 by \$29,700 for the first fiscal year of the fiscal biennium in which this subsection
7 takes effect to increase funding for awards for crime victim restitution. In the
8 schedule under section 20.005 (3) of the statutes for the appropriation to the
9 department of justice under section 20.455 (5) (hh) of the statutes, as affected by the
10 acts of 2011, the dollar amount is increased by \$29,700 for the second fiscal year of
11 the fiscal biennium in which this subsection takes effect to increase funding for crime
12 victim restitution.

13 (3) VICTIM PAYMENTS. In the schedule under section 20.005 (3) of the statutes
14 for the appropriation to the department of justice under section 20.455 (5) (kj) of the
15 statutes, as affected by the acts of 2011, the dollar amount is increased by \$99,300
16 for the first fiscal year of the fiscal biennium in which this subsection takes effect to
17 increase funding for awards for victim payments. In the schedule under section
18 20.005 (3) of the statutes for the appropriation to the department of justice under
19 section 20.455 (5) (kj) of the statutes, as affected by the acts of 2011, the dollar
20 amount is increased by \$99,300 for the second fiscal year of the fiscal biennium in
21 which this subsection takes effect to increase funding for victim payments.”.
