3	recreational cards; hunting of waterfowl by holders of Class A hunting permits for
4	the disabled;".
5	<b>2.</b> Page 3, line 20: after that line insert:
6	"SECTION 3g. 27.01 (7) (c) 6. of the statutes is amended to read:
7	27.01 (7) (c) 6. Any vehicle, except a motor bus, occupied by a person holding
8	a senior citizen recreation card issued under s. 29.624 or a disabled veteran
9	recreation card issued under s. 29.236.
10	<b>SECTION 3m.</b> 27.01 (8) (b) 2. of the statutes is amended to read:
11	27.01 (8) (b) 2. Any person holding a senior citizen recreation card issued under
12	s. 29.624 or a disabled veteran recreation card issued under s. 29.236; or".

2	"SECTION 5g. 29.193 (2) (cr) 2m. of the statutes is created to read:
3	29.193 (2) (cr) 2m. a. In this subdivision, "open water" means any portion of a
4	navigable water body that does not contain a naturally occurring growth of emergent
5	vegetation that is rooted to the bottom and that is of sufficient height and density to
6	conceal at least 50 percent of a person who is hunting waterfowl from a boat or from
7	a waterfowl blind.
8	b. A Class A permit authorizes the holder to hunt waterfowl from a boat or from
9	a waterfowl blind in open water. The holder of the Class A permit may be
10	accompanied by up to 2 persons who may hunt waterfowl with the Class A permit
11	holder only if they hold the appropriate approvals.".
12	<b>4.</b> Page 6, line 3: after that line insert:
13	"SECTION 6m. 29.236 of the statutes is created to read:
14	<b>29.236 Disabled veteran recreation card. (1)</b> The department, subject to
15	ss. 29.024 and 54.25 (2) (c) 1. d., shall issue a disabled veteran recreation card to any
16	resident who produces evidence that shows that he or she is a veteran, as defined in
17	$38 \ \mathrm{USC} \ 101,$ and is receiving disability compensation benefits under $38 \ \mathrm{USC} \ 1101$
18	to 1163 for disabilities that result in a disability rating that is 50 percent or greater
19	under 38 USC 1114 or 1134, or is receiving disability compensation benefits due to
20	being individually unemployable under 38 CFR 4.16 as authorized under 38 USC
21	501.
22	(2) A disabled veteran recreation card entitles the holder to exercise all of the
23	combined rights and privileges conferred by a resident small game bunting license

A person may operate any motor vehicle, except a motor 2 bus, as defined in s. 340.01 (31), subject to the admission requirements under s. 27.01 3 (7) in any vehicle admission area under s. 27.01 (7) without having an admission 4 receipt affixed to the vehicle or otherwise displayed and without paying a fee if the 5 vehicle has as an occupant a card holder who can present the card upon demand in 6 the vehicle admission area. The card permits a card holder to enter Heritage Hill 7 state park or a state trail without paying an admission fee. 8 Except as provided in this section, possession of a disabled veteran (3) 9 recreation card shall not entitle the holder to obtain any other privileges or services 10 for free if the privileges or services may be obtained only through payment of a fee.". **5.** Page 6, line 14: after that line insert: 11 12**"SECTION 9g.** 29.563 (4) (a) 3. of the statutes is created to read: 29.563 (4) (a) 3.
