**ASSEMBLY AMENDMENT 31,  
TO ASSEMBLY SUBSTITUTE AMENDMENT 2,  
TO 2011 ASSEMBLY BILL 7**

May 11, 2011 – Offered by Representatives ROYS, YOUNG and E. COGGS.

1           At the locations indicated, amend the substitute amendment as follows:

2           **1.** Page 9, line 15: delete lines 15 to 18.

3           **2.** Page 14, line 2: delete “6.34.” and substitute “6.34 or have his or her  
4 residence corroborated by another elector of the municipality in the manner provided  
5 in par. (d) 1r.”.

6           **3.** Page 14, line 8: delete the material beginning with “require” and ending  
7 with “6.34” on line 13 and substitute “require the elector to provide proof of residence  
8 under s. 6.34. If the elector cannot provide proof of residence, the elector may have  
9 his or her residence corroborated in a statement that is signed by another elector of  
10 the municipality and that contains the current street address of the corroborating  
11 elector. If the residence is corroborated by another elector, that elector shall then

1 provide proof of residence under s. 6.34. If the elector provides proof of residence or  
2 a corroborator corroborates the elector's residence, the clerk shall".

3 **4.** Page 15, line 4: after "residence" insert "or corroboration of residence".

4 **5.** Page 20, line 6: delete the material beginning with "Alternatively" and  
5 ending with "6.34." on line 10 and substitute "Alternatively, if the elector is unable  
6 to provide proof of residence under s. 6.34, the information contained in the  
7 registration form shall be corroborated in a statement that is signed by any other  
8 elector of the municipality and that contains the current street address of the  
9 corroborating elector. The corroborating elector shall then provide proof of residence  
10 under s. 6.34."

11 **6.** Page 21, line 5: delete "~~and the signature of any corroborating elector~~" and  
12 substitute "and the signature of any corroborating elector".

13 **7.** Page 21, line 23: delete the material beginning with that line and ending  
14 with page 22, line 3.

15 **8.** Page 25, line 18: delete the material beginning with "If" and ending with  
16 "6.34." on line 23 and substitute "If the elector cannot provide proof of residence, the  
17 information contained in the registration form shall be corroborated in a statement  
18 that is signed by any elector who resides in the same municipality as the registering  
19 elector and that contains the current street address of the corroborating elector. The  
20 corroborator shall then provide proof of residence as provided in s. 6.34."

21 **9.** Page 26, line 2: delete "~~and by any corroborator~~" and substitute "and by any  
22 corroborator".

1           **10.** Page 26, line 19: delete the material beginning with “If” and ending with  
2           “(b).” on line 21 and substitute “If the elector cannot provide proof of residence, the  
3           information contained in the registration form shall be corroborated in the manner  
4           provided in par. (b).”.

5           **11.** Page 27, line 1: delete “and by any corroborator” and substitute “and by  
6           any corroborator”.

7           **12.** Page 27, line 19: delete that line.

8           **13.** Page 30, line 14: delete the material beginning with “When” and ending  
9           with “(e).” on line 19, and substitute “When any elector corroborates the registration  
10          identity or residence of any person offering to vote under s. 6.55 (2) (b) or (c), or the  
11          registration identity or residence of any person registering on election day under s.  
12          6.86 (3) (a) 2., the election officials shall also enter the name and address of the  
13          corroborator next to the name of the elector whose information is being corroborated  
14          on the poll list, or the separate list maintained under sub. (2) (c).”.

15          **14.** Page 35, line 25: delete the material beginning with “and” and ending with  
16          “address” on page 36, line 2, and substitute “and any other elector residing in the  
17          same municipality as the hospitalized elector, corroborating the information  
18          contained therein. The corroborating elector shall state on the form his or her full  
19          name and address”.

20          **15.** Page 37, line 5: delete the material beginning with “If” and ending with  
21          “6.34.” on line 10 and substitute “If the agent cannot present proof of residence, the  
22          registration form shall be signed and substantiated by another elector residing in the  
23          elector’s municipality of residence, corroborating the information in the form. The

1 form shall contain the full name and address of the corroborating elector. The agent  
2 shall then present proof of the corroborating elector's residence under s. 6.34.”.

3 **16.** Page 62, line 24: delete that line.
