## ASSEMBLY AMENDMENT 2, TO 2011 ASSEMBLY BILL 86

May 17, 2011 – Offered by Representative RADCLIFFE.

1	At the locations indicated, amend the bill as follows:
2	<b>1.</b> Page 11, line 3: after that line insert:
3	"SECTION 29m. 302.075 of the statutes is created to read:
4	<b>302.075 Meals for inmates. (1)</b> Except as provided in sub. (2), wardens and
5	superintendents may provide no more than 2 meals daily to each inmate.
6	(2) A warden or superintendent may provide more than 2 meals daily to an
7	inmate if a physician notifies the warden or superintendent that the inmate has a
8	medical need for more than 2 meals daily.".
9	<b>2.</b> Page 19, line 21: after that line insert:
10	"SECTION 49m. 302.37 (1) (a) of the statutes is amended to read:
11	302.37 (1) (a) The sheriff or other keeper of a jail shall constantly keep it clean
12	and in a healthful condition and pay strict attention to the personal cleanliness of
13	the prisoners and shall cause the clothing of each prisoner to be properly laundered.

2011 – 2012 Legislature – 2 –

1	The sheriff or keeper shall furnish each prisoner with clean water, towels, and
2	bedding. The sheriff or keeper shall serve each prisoner <del>3 times daily</del> with enough
3	well-cooked, wholesome food. The county board shall prescribe an adequate diet for
4	the prisoners in the county jail and may allow, at the discretion of the sheriff or
5	keeper, the sheriff or keeper to provide each prisoner with no more than 2 meals daily
6	<u>unless a physician notifies the sheriff or keeper that an inmate has a medical need</u>
7	for more than 2 meals daily.".
8	<b>3.</b> Page 33, line 24: delete that line and substitute:
9	"(1) Except as provided in subsection (2), this act first applies to a person
10	sentenced on December 31, 1999.".
11	<b>4.</b> Page 33, line 25: delete that line and substitute:
12	"(2)
13	(a) The treatment of sections $302.113(1)$ and $(2)(a)$ and $(b)$ and $304.06(1)(bg)$
14	of the statutes does not".
15	5. Page 34, line 2: on lines 2 and 3, delete "subsection" and substitute
16	"paragraph".
17	<b>6.</b> Page 34, line 3: after that line insert:
18	"(b) The treatment of sections 302.075 and 302.37 (1) (a) of the statutes first
19	applies to meals served on the effective date of this paragraph.".
