



**ASSEMBLY AMENDMENT 1,
TO 2011 SENATE BILL 275**

March 15, 2012 – Offered by Representative C. TAYLOR.

1 At the locations indicated, amend the bill, as shown by senate substitute
2 amendment 2, as follows:

3 **1.** Page 1, line 5: delete “Milwaukee area”.

4 **2.** Page 1, line 5: substitute “boards” for “board”.

5 **3.** Page 1, line 6: delete the material beginning with that line and ending with
6 page 2, line 11, as affected by senate amendment 1, and substitute:

7 “**SECTION 1m.** 38.08 (1) (a) 1. of the statutes is repealed and recreated to read:

8 38.08 (1) (a) 1. A district board shall administer the district and shall be
9 composed of 9 members who are residents of the district, consisting”.

10 **4.** Page 2, line 21: delete lines 21 to 24.

11 **5.** Page 2, line 25: delete the material beginning with that line and ending with
12 page 3, line 4, and substitute:

1 **“SECTION 4m.** 38.10 (1) of the statutes is repealed and recreated to read:

2 38.10 (1) District board members shall be appointed by an appointment
3 committee consisting of the chairpersons of the boards of supervisors of the counties
4 located in whole or in part in the district and the county executive of the county
5 having the largest population in the district or, if that county does not have a county
6 executive, the county administrator or administrative coordinator of that county.”.

7 **6.** Page 3, line 16: delete lines 16 to 20 and substitute:

8 “38.10 (2) (b) ~~The appointment committee member from the appropriate~~
9 ~~governmental unit specified under sub. (1) (a), (b) or (c) county executive, county~~
10 administrator, or administrative coordinator, whichever is appropriate, of the county
11 having the largest population in the district shall act as chairperson of the
12 appointment committee.”.

13 **7.** Page 5, line 7: delete lines 7 to 10 and substitute:

14 **“SECTION 10m.** 38.10 (2) (g) of the statutes is repealed and recreated to read:

15 38.10 (2) (g) A majority of the members of an appointment committee
16 constitutes a quorum to do business except that, if an appointment committee
17 consists of an even number of members, a majority of the members plus one member
18 constitutes a quorum to do business.”.

19 **8.** Page 5, line 15: delete the material beginning with that line and ending with
20 page 6, line 20, and substitute:

21 “(2) Notwithstanding section 38.08 (1) (b) of the statutes, the initial members
22 of technical college district boards, as specified in section 38.08 (1) (a) 1., as affected
23 by this act, shall be appointed as follows:

1 (a) Two of the members specified in section 38.08 (1) (a) 1. a. of the statutes, as
2 affected by this act, and the member specified in section 38.08 (1) (a) 1. b. of the
3 statutes, as affected by this act, shall have terms expiring on June 30, 2014. Of the
4 members specified in section 38.08 (1) (a) 1. a. of the statutes, as affected by this act,
5 who are appointed under this paragraph, one member shall represent employers
6 with 15 or more employees and one member shall represent employers with 100 or
7 more employees and one of those members shall represent employers who are
8 manufacturing businesses. The members appointed under this paragraph shall
9 replace the members of the district board appointed under section 38.08 (1) (a) 1.,
10 2009 stats., whose terms were scheduled to expire on June 30, 2012.

11 (b) Two of the members specified in section 38.08 (1) (a) 1. a. of the statutes, as
12 affected by this act, and one of the members specified in section 38.08 (1) (a) 1. d. of
13 the statutes, as affected by this act, shall have terms expiring on June 30, 2015. Of
14 the members specified in section 38.08 (1) (a) 1. a. of the statutes, as affected by this
15 act, who are appointed under this paragraph, one member shall represent employers
16 with 15 or more employees and one member shall represent employers with 100 or
17 more employees and one of those members shall represent employers who are
18 manufacturing businesses. The members appointed under this paragraph shall
19 replace the members of the district board appointed under section 38.08 (1) (a) 1.,
20 2009 stats., whose terms were scheduled to expire on June 30, 2013.

21 (c) One of the members specified in section 38.08 (1) (a) 1. a. of the statutes, as
22 affected by this act, the member specified in section 38.08 (1) (a) 1. c. of the statutes,
23 as affected by this act, and one of the members specified in section 38.08 (1) (a) 1. d.
24 of the statutes, as affected by this act, shall have terms expiring on June 30, 2016.
25 The members appointed under this paragraph shall replace the members of the

1 district board appointed under section 38.08 (1) (a) 1., 2009 stats., whose terms were
2 scheduled to expire on June 30, 2014.”.
