**ASSEMBLY SUBSTITUTE AMENDMENT 2,
TO 2013 SENATE BILL 1**

October 17, 2013 – Offered by Representative HULSEY.

1 **AN ACT to create** 20.255 (2) (ag), 121.107 and 121.90 (2) (am) 6. of the statutes;
2 **relating to:** per pupil adjustment aid, school district budgets, and making an
3 appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 20.005 (3) (schedule) of the statutes: at the appropriate place, insert
5 the following amounts for the purposes indicated:

6 **2013-14** **2014-15**

7 **20.255 Public instruction, department of**

8 (2) AID FOR LOCAL EDUCATIONAL PROGRAMMING

9 (ag) Per pupil adjustment aid GPR A 100,000,000 100,000,000

10 **SECTION 2.** 20.255 (2) (ag) of the statutes is created to read:

1 20.255 (2) (ag) *Per pupil adjustment aid*. The amounts in the schedule for per
2 pupil adjustment aid under s. 121.107.

3 **SECTION 3.** 121.107 of the statutes is created to read:

4 **121.107 Per pupil adjustment aid.** Annually, the department shall pay to
5 each school district, from the appropriation under s. 20.255 (2) (ag), the amount
6 determined as follows:

7 (1) Divide the amount appropriated under s. 20.255 (2) (ag) in the current
8 school year by the statewide membership in the previous school year.

9 (2) Multiply the result under sub. (1) by the school district's membership in the
10 previous school year.

11 **SECTION 4.** 121.90 (2) (am) 6. of the statutes is created to read:

12 121.90 (2) (am) 6. Amounts received under s. 121.107.

13 **SECTION 5. Nonstatutory provisions.**

14 (1) (a) Notwithstanding section 121.15 (4) (b) of the statutes, the state
15 superintendent of public instruction shall calculate the total amount of state aid that
16 each school district will receive in the 2013–14 school year by October 31, 2013,
17 instead of on October 15, 2013.

18 (b) Notwithstanding section 120.12 (3) and (4) of the statutes, for 2013 the
19 references to November 1 in those sections are changed to November 6.

20 (c) Notwithstanding section 119.16 (8) (b) of the statutes, for 2013 the reference
21 in that section to the first Monday in August is changed to November 6.

22 (d) Notwithstanding section 121.90 (2) (am) 1. of the statutes, for 2013 the
23 reference to October 15 in that section is changed to October 31.
