June 12, 2013 – Offered by Representatives BERNIER and BERCEAU.

3	the residence location entered by an elector is not the same as the elector's address
4	in the records of the department of transportation, the elector's information is not
5	verified and the elector's registration is not complete.".

7	<b>3.</b> Page 45, line 1: delete "or individual and substitute " <del>or individual</del> ".
