23	"(3i) VETERANS ASSISTANCE PROGRAMS; POSITIONS. The authorized FTE positions				
24	for the department of veterans affairs are decreased by 4.0 SEG positions that are				

in the veterans assistance program under section 45.43 of the statutes, as affected
by this act, and that are funded from the appropriation under section 20.485 (2) (rm)
of the statutes, as affected by this act. The authorized FTE positions for the
department of veterans affairs are increased by 4.0 GPR positions, to be funded from
the appropriation under section 20.485 (2) (ac) of the statutes, as affected by this act,
for the veterans assistance program under section 45.43 of the statutes, as affected
by this act.".
