No other 23information from the individual's court records may be disclosed to the department $\mathbf{24}$ of justice except by order of the court. information under sub. (2) from the department or from a law enforcement agency
or law enforcement officer as provided in sub. (4) (d)".

5	7. Page 6, line 10: delete the material beginning with " <u>provided by</u> " and ending
6	with " <u>165.63 (2)</u> " on line 11 and substitute " <u>provided under s. 165.63</u> ".
7	8. Page 9, line 8: delete the material beginning with "provided by" and ending
8	with "165.63 (2)" on line 9 and substitute "provided under s. 165.63".
9	9. Page 10, line 15: delete the material beginning with " <u>provided by</u> " and
10	ending with " <u>165.63 (2)</u> " on line 16 and substitute " <u>provided under s. 165.63</u> ".
