SENATE AMENDMENT 1, TO SENATE BILL 335

October 10, 2013 – Offered by Senator Harsdorf.

1	At the locations indicated, amend the bill as follows:
2	${f l.}$ Page 1, line 1: delete the material beginning with "a tuition" and ending
3	with "employers," on line 2 and substitute "an apprenticeship completion award
4	program,".
5	${f 2.}$ Page 2, line 6: delete the material beginning with "Tuition" and ending with
6	"employers" on line 7 and substitute "Apprenticeship completion award program".
7	3. Page 2, line 9: delete the material beginning with <i>"Tuition"</i> and ending with
8	"employers" on line 10 and substitute "Apprenticeship completion award program.
9	The amounts in the schedule for the apprenticeship completion award program".
10	4. Page 2, line 13: delete the material beginning with that line and ending with
11	page 4, line 3, and substitute:
12	"106.05 Apprenticeship completion award program. (1) The department
13	shall administer an apprenticeship completion award program as provided in this

section to partially reimburse the tuition costs paid by apprentices who have
 successfully completed part or all of their apprenticeship requirements or paid by the
 sponsors of those apprentices.

4 (2) Subject to subs. (3) and (4), the department shall provide a completion
5 award equal to 25 percent of the cost of tuition incurred by an apprentice who has
6 successfully completed an apprenticeship program and who is employed in the trade,
7 craft, or business in which the apprentice was trained under the apprenticeship
8 program or by a sponsor of such an apprentice or in the amount of \$1,000, whichever
9 is less.

(3) The completion award may be paid in 2 parts as follows:

(a) The first payment may be made upon the successful completion of the first
year of an apprenticeship contract. The amount of the first payment may not exceed
\$250.

(b) The remainder of the award may be paid upon the final completion of allapprenticeship requirements.

- 16 (4) The department shall reduce the amount of a completion award when the
 17 apprentice has incurred a reduced amount of tuition costs or when the sponsor is a
 18 unit of state or local government.".
- 19 **5.** Page 4, line 4: delete "(d) *Limitations*. 1." and substitute:
 20 "(5) (a)".
- 21 **6.** Page 4, line 10: delete "2." and substitute:
- 22 "(b)".

23 **7.** Page 4, line 15: delete "a." and substitute:
