1246.18 (14) INCENTIVE PAYMENTS TO PATIENTS IN MENTAL HOSPITALS. The county 13 board or, in Milwaukee County, the Milwaukee County mental health district board 14may authorize the board of trustees of any county mental hospital to establish a 15program of incentive payments so as to provide incentive and encouragement to 16 patients by the disbursement of small weekly payments but not restricted to work 17allowances. Incentive payments paid to inmates shall not be included as costs in 18 arriving at the per capita rate for state aids or charges to other counties and the state 19 for care of inmates. 
