SENATE SUBSTITUTE AMENDMENT 1, TO SENATE BILL 575

February 18, 2014 - Offered by Senator TIFFANY.

1	AN ACT to renumber and amend 28.11 (8) (a); to amend 74.25 (1) (a) 6. and
2	74.30 (1) (f); and <i>to create</i> 28.11 (8) (a) 2. of the statutes; relating to: payments
3	to counties for designated county forest lands and distribution of amounts paid
4	to municipalities by owners of closed managed forest lands.
	The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
5	SECTION 1. 28.11 (8) (a) of the statutes is renumbered 28.11 (8) (a) 1. and
6	amended to read:
7	28.11 (8) (a) 1. As Except as provided in subd. 2., as soon after April 20 of each
8	year as feasible, the department shall pay to each town treasurer 30 cents per acre,
9	based on the acreage of such lands as of the preceding June 30, as a grant out of the
10	appropriation made by s. 20.370 (5) (bv) on each acre of county lands entered under
11	this section. <u>This subdivision does not apply to payments required to be paid by the</u>
12	<u>department after 2013.</u>

1	SECTION 2. 28.11 (8) (a) 2. of the statutes is created to read:
2	28.11 (8) (a) 2. As soon after April 20, 2014, as feasible, and as soon after April
3	20 of each year thereafter as feasible, the department shall pay to each town
4	treasurer 55 cents per acre, based on the acreage of such lands as of the preceding
5	June 30, as a grant out of the appropriation made by s. 20.370 (5) (bv) on each acre
6	of county lands entered under this section.
7	SECTION 3. 74.25 (1) (a) 6. of the statutes, as affected by 2013 Wisconsin Act 81,
8	is amended to read:
9	74.25 (1) (a) 6. Pay to the county treasurer 20% of collections of occupational
10	taxes on coal docks, 20% of collections of the taxes imposed under ss. 77.04 and 77.84
11	(2) (a) and, (am), and (bp), and all collections of payments for lands under s. 77.84 (2)
12	(b) , <u>and</u> (bm) , and (bp) .
13	SECTION 4. 74.30 (1) (f) of the statutes, as affected by 2013 Wisconsin Act 81,
14	is amended to read:
15	74.30 (1) (f) Pay to the county treasurer 20% of collections of occupational taxes
16	on coal docks, 20% of collections of the taxes imposed under ss. 77.04 and 77.84 $\left(2\right)$
17	(a) and, (am), and (bp), and all collections of payments for lands under s. 77.84 (2) (b),
18	and (bm) , and (bp) .
19	SECTION 5. Nonstatutory provisions.
20	(1) Notwithstanding section 77.89 (2) (b) of the statutes, of the amounts
21	received by the county treasurer under section $77.89(2)(b)$ of the statutes in 2014,
22	the county treasurer shall do all of the following:
23	(a) Pay to the department of natural resources, by June 30, 2014, 75 percent
24	of the amounts received under section 77.89 (2) (b) of the statutes. All amounts
25	received by the department of natural resources under this paragraph shall be

credited to the conservation fund and shall be reserved for land acquisition and
 resource management activities.

3 (b) Refund to the municipal treasurer, by June 30, 2014, 20 percent of the
4 amounts received from the municipal treasurer under section 77.89 (2) (b) of the
5 statutes.
