1	At the locations indicated, amend the bill as follows:
2	<b>1.</b> Page 1, line 4: before that line insert:
3	"SECTION 1g. 33.28 (2) (intro.) of the statutes, as affected by 2015 Wisconsin Act
4	25, is amended to read:
5	33.28 (2) (intro.) The Except as provided in sub. (2m) (c), the board of
6	commissioners shall consist of all of the following:".
7	<b>2.</b> Page 2, line 7: after that line insert:
8	"SECTION 2m. 33.28 (2) (d) of the statutes is created to read:
9	33.28 (2) (d) If the district includes a lake that is controlled by a dam, if the dam
10	is not located in the town, village, or city within which the largest portion by
11	valuation of the district lies, and if the governing body of the town, village, or city
12	within which the largest portion by valuation of the district lies elects not to make
13	an appointment under par. (b), as provided in sub. (2m) (c), one person who is

appointed by the governing body of the town, village, or city within which the dam
is located. The person appointed under this paragraph shall be a resident of the
district who owns property within the district if possible or shall be a member of the
governing body of the town, village, or city within which the dam is located.
SECTION 2r. 33.28 (2m) (c) of the statutes is created to read:

6 33.28 (2m) (c) If the district includes a lake that is controlled by a dam and if 7 the dam is not located in the town, village, or city within which the largest portion 8 by valuation of the district lies, the governing body of the town, village, or city within 9 which the largest portion by valuation of the district lies may elect not to make an 10 appointment under sub. (2) (b).

**SECTION 3m.** 33.28 (7) of the statutes is amended to read:

1233.28 (7) If a vacancy occurs in the membership of the board under sub. (2) (a) 13or (b) (d), the appointing authority shall appoint a person to fill the vacancy. If a 14vacancy occurs in the membership of the board under sub. (2) (b) that is not a result of the appointing body electing not to make an appointment under sub. (2m) (c), the 1516 appointing authority shall appoint a person to fill the vacancy. If a vacancy occurs 17in the membership of the board under sub. (2) (c), the chairperson of the board shall 18 appoint a person to fill the remainder of the unexpired term, subject to approval by 19 a majority vote of the board.".
