**ASSEMBLY AMENDMENT 2,
TO ASSEMBLY BILL 51**

February 16, 2016 – Offered by Representatives MURSAU and GOYKE.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 3: after “counties” insert “and Indian tribes”.

3 **2.** Page 2, line 14: after “county” insert “or Indian tribe”.

4 **3.** Page 3, line 10: after “county” insert “or Indian tribe”.

5 **4.** Page 3, line 12: after “county” insert “or Indian tribe”.

6 **5.** Page 3, line 17: after “county” insert “or Indian tribe”.

7 **6.** Page 3, line 18: after “county” insert “or Indian tribe”.

8 **7.** Page 3, line 20: after “county” insert “or Indian tribe”.

9 **8.** Page 4, line 7: delete lines 7 to 12 and substitute:

10 “(8m) A county or Indian tribe may, together with one or more other counties
11 or Indian tribes, jointly apply for and receive a grant under this section. Upon
12 submitting a joint application, each county or Indian tribe shall include with the

1 application a written agreement specifying the role of each county or Indian tribe in
2 developing, administering, and evaluating the program. The oversight committee
3 established under sub. (4) shall consist of a representative from each county and
4 Indian tribe operating a joint program.”.

5 **9.** Page 4, line 13: after “county” insert “or Indian tribe”.

6 **10.** Page 4, line 17: after “counties” insert “and Indian tribes”.

7 **11.** Page 5, line 6: after “county” insert “or Indian tribe”.

8 **12.** Page 5, line 17: after “county” insert “or Indian tribe”.

9 **13.** Page 5, line 19: after “county” insert “or Indian tribe”.

10 **14.** Page 6, line 1: after “county” insert “or Indian tribe”.

11 **15.** Page 6, line 2: after “county” insert “or Indian tribe”.

12 **16.** Page 6, line 4: after “county” insert “or Indian tribe”.

13 **17.** Page 6, line 17: delete lines 17 to 22 and substitute:

14 **“(8m)** A county or Indian tribe may, together with one or more other counties
15 or Indian tribes, jointly apply for and receive a grant under this section. Upon
16 submitting a joint application, each county or Indian tribe shall include with the
17 application a written agreement specifying the role of each county or Indian tribe in
18 developing, administering, and evaluating the program. The oversight committee
19 established under sub. (4) shall consist of a representative from each county and
20 Indian tribe operating a joint program.”.

21 **18.** Page 6, line 23: after “county” insert “or Indian tribe”.
