**ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 522**

January 20, 2016 - Offered by Representative STEFFEN.

1 **AN ACT to amend** 20.410 (1) (gf), 302.33 (2) (a) 3. and 304.074 (2) of the statutes;
2 **relating to:** reimbursement of counties and tribal governing bodies for
3 probationers, parolees, and persons on extended supervision who are placed
4 with the county or body pending disposition of revocation proceedings.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5 **SECTION 1.** 20.410 (1) (gf) of the statutes is amended to read:
6 20.410 (1) (gf) *Probation, parole, and extended supervision.* The amounts in the
7 schedule for probation, parole, and extended supervision and, as provided in s.
8 302.33 (2) (a) 3., for the reimbursement of counties and tribal governing bodies for
9 the maintenance of persons placed in jails or facilities pending disposition of
10 revocation proceedings. All moneys received from vendors under s. 301.08 (1) (c) 4.
11 and from fees charged under s. 304.074 (2) shall be credited to this appropriation
12 account.

1 **SECTION 2.** 302.33 (2) (a) 3. of the statutes is amended to read:

2 302.33 (2) (a) 3. After verification by the department, it shall reimburse the
3 county or tribal governing body at a rate of ~~\$36 per person per day prior to January~~
4 ~~1, 1993, and \$40 per person per day thereafter~~, subject to the conditions in subds. 1.
5 and 2. Any amount not paid under s. 20.410 (1) (bn) shall be paid under s. 20.410
6 (1) (gf) using any amount remaining in that appropriation account after the
7 department pays all costs incurred for probation, parole, and extended supervision.
8 If the amount amounts provided under s. 20.410 (1) (bn) and (gf) for any fiscal year
9 is are insufficient to provide complete reimbursement at that rate, the department
10 shall prorate the payments under this subdivision to counties or tribal governing
11 bodies for that fiscal year. The department shall not reimburse a county or tribal
12 governing body unless that county or tribal governing body informs the department
13 of the amount of reimbursement to which it is entitled under this subsection no later
14 than September 1 of the fiscal year following the fiscal year for which reimbursement
15 is requested.

16 **SECTION 3.** 304.074 (2) of the statutes, as affected by 2015 Wisconsin Act 55,
17 is amended to read:

18 304.074 (2) The department shall charge a reasonable fee as determined by the
19 department to probationers, parolees, and persons on extended supervision to
20 partially reimburse the department for the costs of providing supervision and
21 services and, as provided under s. 302.33 (2) (a) 3., to reimburse counties and tribal
22 governing bodies. The department shall collect moneys for the fees charged under
23 this subsection and credit those moneys to the appropriation account under s. 20.410
24 (1) (gf).

25 **SECTION 4. Effective date.**

1 (1) This act takes effect on the first day of the 5th month beginning after
2 publication.
