## **SENATE AMENDMENT 3, TO SENATE BILL 434**

February 1, 2016 - Offered by Senator TIFFANY.

1	At the locations indicated, amend the bill as follows:
<b>2</b>	${f 1.}$ Page 2, line 9: delete "and granting rule-making authority" and substitute
3	"granting rule-making authority, and making an appropriation".
4	<b>2.</b> Page 6, line 1: before that line insert:
5	"SECTION 1c. 20.005 (3) (schedule) of the statutes: at the appropriate place,
6	insert the following amounts for the purposes indicated:
7	2015-16 2016-17
8	20.370 Natural resources, department of
9	(5) CONSERVATION AIDS
10	(dy) Resource aids — distribution of
11	closed acreage fees SEG A -0- 6,000,000".
12	<b>3.</b> Page 6, line 4: after that line insert:

1	<b>"SECTION 1m.</b> 20.370 (5) (dy) of the statutes is created to read:
2	20.370 (5) (dy) Resource aids — distribution of closed acreage fees. The
3	amounts in the schedule for the payments to municipalities under s. $77.89(1)(c)$ and
4	the payments to counties and municipalities under 2015 Wisconsin Act (this act),
5	section 89 (2m).".
6	<b>4.</b> Page 25, line 14: delete lines 14 to 21 and substitute:
7	"SECTION 84m. 77.89 (1) (c) of the statutes is created to read:
8	77.89 (1) (c) The department shall distribute from the appropriation under s.
9	20.370 (5) (dy) \$4,600,000 in fiscal year 2016-17, \$6,000,000 in fiscal year 2017-18,
10	and \$7,000,000 in fiscal year 2018–19 among treasurers of each municipality in
11	which is located land subject to a managed forest land order that is designated as
12	closed to public access under s. 77.83 (1). The department shall distribute to each
13	municipal treasurer an amount in proportion to the number of acres of closed land
14	in that municipality.
15	<b>SECTION 84q.</b> 77.89 (2) (a) of the statutes is amended to read:
16	77.89 (2) (a) Each municipal treasurer shall pay 20% of each payment received
17	under sub. (1) (a) and, (b), and (c) and under ss. 77.84 (2) (a), (am), and (bp), 77.85,
18	and 77.876 to the county treasurer and shall deposit the remainder in the municipal
19	treasury. The payment to the county treasurer for money received before November
20	1 of any year shall be made on or before the November 15 after its receipt. For money
21	received on or after November 1 of any year, the payment to the county treasurer
22	shall be made on or before November 15 of the following year.".
23	<b>5.</b> Page 27, line 6: after that line insert:

1 "(2m) PAYMENTS TO COUNTIES AND MUNICIPALITIES. The department of natural  $\mathbf{2}$ resources shall determine whether the amount payable to each county and 3 municipality in 2016 under section 77.89 (2) of the statutes, as affected by this act, is less than the amount received by the respective counties and municipalities in 4  $\mathbf{5}$ 2015 under section 77.07, 2013 stats., and section 77.87, 2013 stats. For each county 6 and municipality for which the department of natural resources determines that the 7 amount payable in 2016 is less than the amount received in 2015, the department 8 of natural resources shall pay to each of those counties and municipalities an amount 9 equal to the difference between the amount payable in 2016 and the amount received 10 in 2015. The department of natural resources shall pay the amounts required under 11 this subsection not later than December 1, 2016.". 12 (END)
