**ASSEMBLY AMENDMENT 2,
TO ASSEMBLY BILL 236**

May 2, 2017 - Offered by Representative SUBECK.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: before that line insert:

3 “SECTION 1v. 234.66 of the statutes is created to read:

4 **234.66 State housing voucher program. (1) VOUCHERS.** (a) The authority
5 shall develop policies and procedures for and administer a state housing voucher
6 program to provide housing vouchers to individuals and families that are on a
7 waiting list that the authority or a public housing agency that contracts with the
8 authority maintains for vouchers under the federal Housing Choice Voucher
9 Program.

10 (am) The authority shall make grants directly to housing authorities under s.
11 59.53 (22), 61.73, 66.1201, or 66.1213 for the purpose of funding vouchers under this
12 section, subject to the policies and procedures developed under par. (a) and the
13 requirements of this section.

1 (b) Vouchers provided under this section shall be distributed in proportion to
2 the number of vouchers distributed by the authority, public housing agencies that
3 contract with the authority to provide vouchers under the federal Housing Choice
4 Voucher Program, and housing authorities under s. 59.53 (22), 61.73, 66.1201, or
5 66.1213 that provide vouchers under the federal Housing Choice Voucher Program.

6 (c) The authority shall issue its negotiable bonds in such principal amount and
7 length of maturity as to provide sufficient funds, not to exceed \$2,750,000, to fund
8 the voucher program under par. (a).

9 **(2) CONDITIONS.** (a) The housing vouchers provided under this section shall be
10 provided to recipients under the same terms and conditions as vouchers under the
11 federal Housing Choice Voucher Program.

12 (b) A person who receives a federal Housing Choice Voucher may not receive
13 a voucher under this section.”.

14 **2.** Page 2, line 2: before “or a” insert “a housing authority under s. 59.53 (22),
15 61.73, 66.1201, or 66.1213,”.

16 **3.** Page 2, line 3: delete “may” and substitute “shall”.

17 **4.** Page 2, line 4: after “services” insert “, including assistance funding and
18 maintaining housing,”.

19 **5.** Page 2, line 5: after “list.” insert “The authority shall issue its negotiable
20 bonds in such principal amount and length of maturity as to provide sufficient funds,
21 not to exceed \$500,000, to fund the provision of case management services under this
22 subsection. Of the funding available under this subsection, the authority shall
23 provide \$75,000 to fund case management services for recipients of vouchers
24 distributed by the authority and public housing agencies that contract with the

1 authority to provide vouchers under the federal Housing Choice Voucher Program
2 and \$425,000 to fund case management services for recipients of vouchers
3 distributed by local housing authorities under ss. 59.53 (22), 61.73, 66.1201, and
4 66.1213 that provide vouchers under the federal Housing Choice Voucher Program.”.
