**SENATE AMENDMENT 1,
TO SENATE BILL 106**

March 23, 2017 - Offered by Senator SHILLING.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 7: after that line insert:

3 “1m. “Mattress” means any resilient material or combination of materials that
4 is enclosed by ticking, used alone or in combination with other products, and that is
5 intended for or promoted for sleeping upon and includes box springs. “Mattress” does
6 not include any mattress pad, mattress topper, sleeping bag, pillow, crib mattress,
7 car bed, carriage, basket, dressing table, stroller, playpen, infant carrier, lounge pad,
8 crib bumper, liquid-filled or gas-filled ticking, water bed or air mattress that does
9 not contain upholstery material between the ticking and the mattress core, and
10 upholstered furniture that does not otherwise contain a detachable mattress.

11 1r. “Recycle” means the process by which a mattress is mechanically or
12 manually dismantled into separate component parts for further sorting and
13 processing, such as baling or boxing, and the storage and movement of the materials

1 to end markets to be used in making usable or marketable materials. “Recycle” does
2 not include incinerating mattress materials for energy recovery purposes or
3 refurbishing or renovating a mattress for use as a mattress for humans.”.

4 **2.** Page 3, line 17: after that line insert:

5 “1m. “Mattress” means any resilient material or combination of materials that
6 is enclosed by ticking, used alone or in combination with other products, and that is
7 intended for or promoted for sleeping upon and includes box springs. “Mattress” does
8 not include any mattress pad, mattress topper, sleeping bag, pillow, crib mattress,
9 car bed, carriage, basket, dressing table, stroller, playpen, infant carrier, lounge pad,
10 crib bumper, liquid-filled or gas-filled ticking, water bed or air mattress that does
11 not contain upholstery material between the ticking and the mattress core, and
12 upholstered furniture that does not otherwise contain a detachable mattress.

23 not include any mattress pad, mattress topper, sleeping bag, pillow, crib mattress,
24 car bed, carriage, basket, dressing table, stroller, playpen, infant carrier, lounge pad,

1 crib bumper, liquid-filled or gas-filled filled ticking, water bed or air mattress that
2 does not contain upholstery material between the ticking and the mattress core, and
3 upholstered furniture that does not otherwise contain a detachable mattress.

4 1r. "Recycle" means the process by which a mattress is mechanically or
5 manually dismantled into separate component parts for further sorting and
6 processing, such as baling or boxing, and the storage and movement of the materials
