## SENATE AMENDMENT 10, TO SENATE BILL 109

June 14, 2017 - Offered by Senators Larson, Johnson, Vinehout, Carpenter, Wirch and Hansen.

1	At the locations indicated, amend the bill as follows:
2	<b>1</b> . Page 2, line 4: after "professions" insert "and granting rule-making
3	authority".
4	<b>2.</b> Page 9, line 1: delete lines 1 to 5 and substitute:
5	"SECTION 45g. 454.08 (1) (ag) of the statutes is created to read:
6	454.08 (1) (ag) The examining board shall promulgate rules specifying the
7	chemicals that may be used in the practice of cosmetology, aesthetics, electrology, or
8	manicuring outside of a licensed establishment under par. (ar).
9	<b>SECTION 45r.</b> 454.08 (1) (ar) of the statutes is created to read:
10	454.08 (1) (ar) A person may practice cosmetology, aesthetics, electrology, or
11	manicuring outside of a licensed establishment if all of the following apply:
12	1. The person owns, manages, is employed by, or is affiliated with an
13	establishment that is licensed to provide that service under sub. (2).

1	2. The person obtains a mobile practice permit under s. 454.085 and displays
2	that permit at the location where cosmetology, aesthetics, electrology, or manicuring
3	is practiced.
4	3. The person displays the certificate furnished to the person under s. 454.06
5	(7) at the location where cosmetology, aesthetics, electrology, or manicuring is
6	practiced.".
7	<b>3.</b> Page 9, line 7: delete " <u>(am)</u> " and substitute " <u>(ar)</u> ".
8	<b>4.</b> Page 10, line 3: after that line insert:
9	<b>"SECTION 48m.</b> 454.085 of the statutes is created to read:
10	<b>454.085 Mobile practice permits. (1)</b> No person may practice cosmetology,
11	aesthetics, electrology, or manicuring outside of a licensed establishment unless the
12	person is granted a permit under this section.
13	(2) An application for a permit under this section shall be submitted to the
14	examining board on a form provided by the examining board and shall include an
15	annual fee determined by the examining board.
16	(3) The examining board shall grant a permit under this section to each person
17	who submits an application and pays the fee under sub. (2).
18	(4) A permit granted under this section is valid from the date on which the
19	examining board grants the permit to the first December 31 following the date of
20	issuance.".
21	<b>5.</b> Page 12, line 22: delete the material beginning with that line and ending
22	with page 13, line 2, and substitute:
23	<b>"SECTION 66g.</b> 454.25 (1) (ag) of the statutes is created to read:

4	<b>SECTION 66r.</b> $454.25(1)(ar)$ of the statutes is created to read:
5	454.25 (1) (ar) A person may practice barbering outside of a licensed
6	establishment if all of the following apply:
7	1. The person owns, manages, is employed by, or is affiliated with a barbering
8	establishment licensed under sub. (2) or a cosmetology establishment licensed under
9	s. 454.08 (2).
10	2. The person obtains a mobile practice permit under s. 454.255 and displays
11	that permit at the location where barbering is practiced.
12	3. The person displays the certificate issued to the person under s. $454.23$ (4)
13	at the location where barbering is practiced.".
14	<b>6.</b> Page 13, line 4: delete " <u>(am)</u> " and substitute " <u>(ar)</u> ".
15	<b>7.</b> Page 13, line 8: delete the material beginning with that line and ending with
16	page 15, line 10, and substitute:
17	"SECTION 69m. 454.255 of the statutes is created to read:
18	454.255 Mobile practice permits. (1) No person may practice barbering
19	outside of a licensed establishment unless the person is granted a permit under this
20	section.
21	(2) An application for a permit under this section shall be submitted to the
22	department on a form provided by the department and shall include an annual fee
23	determined by the department.

(3) The department shall grant a permit under this section to each person who
 submits an application and pays the fee under sub. (2).

3 (4) A permit granted under this section is valid from the date on which the
4 department grants the permit to the first December 31 following the date of
5 issuance.".
