(c) "Veteran" has the meaning given in s. 45.01(12)(a) to (f).

5 (2) (a) Subject to par. (b), an employer shall grant to each employee who is a 6 veteran a paid leave of absence on November 11 or, if November 11 falls on a Saturday 7 or Sunday and the employee is not scheduled to work on November 11, on the 8 following Monday. The leave of absence shall be for the entire workday. If an 9 employee intends to take a leave of absence under this paragraph, the employee 10 shall, in a reasonable and practicable manner, give the employer advance notice of 11 the leave of absence.

(b) For employees whose wages, hours, and conditions of employment are
determined under a collective bargaining agreement, par. (a) applies only if the paid
leave of absence described in par. (a) is provided under the collective bargaining
agreement.

16 (3) An employer may not discharge or discriminate against an employee in 17 promotion, in compensation, or in the terms, conditions, or privileges of employment 18 for taking a paid leave of absence as provided in sub. (2), opposing a practice 19 prohibited under this section, filing a complaint or attempting to enforce any right 20 under this section, or testifying or assisting in any action or proceeding to enforce any 21 right under this section.

(4) An employee who is discharged or discriminated against in violation of sub.
(3) may file a complaint with the department, and the department shall process the
complaint in the same manner that employment discrimination complaints are
processed under s. 111.39. If the department finds that an employer has violated sub.

(3), it may order the employer to take such action under s. 111.39 as will effectuate 1 $\mathbf{2}$ the purpose of this section. (c) and 4 $\mathbf{5}$ except as provided in the compensation plan under s. 230.12, all employees except 6 limited term employees shall earn 3.5 paid personal holidays each calendar year, plus one additional paid personal holiday each calendar year in recognition of 7 8 Veterans Day.
