**ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY BILL 648**

January 9, 2020 - Offered by Representative NYGREN.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 7: after “benefit” insert “under”.

3 **2.** Page 2, line 14: delete the material beginning with that line and ending with  
4 page 3, line 2, and substitute:

5 “(a) The amounts described under SECTION (4) (1) of this act shall be allocated  
6 for all of the following under the Medical Assistance program:

7 1. \$300,000 in each fiscal year of the biennium for reimbursement for  
8 acupuncture services under s. 49.46 (2) (b) 21.

9 2. \$350,000 in each fiscal year of the biennium to increase reimbursement rates  
10 for physical therapy.

11 3. \$350,000 in each fiscal year of the biennium to increase reimbursement rates  
12 for chiropractic services as described in par. (d).

1 (b) To obtain the supplemental funding described in par. (a) 1., the department,  
2 after consulting with acupuncturists, shall submit under s. 13.10 to the joint  
3 committee on finance a proposal to provide reimbursement for acupuncture services  
4 under s. 49.46 (2) (b) 21.

5 (c) To obtain the supplemental funding described in par. (a) 2., the department  
6 of health services, after consulting with physical therapists, shall submit under s.  
7 13.10 to the joint committee on finance a proposal to increase reimbursement rates  
8 for physical therapy under the Medical Assistance program.

9 (d) To obtain the supplemental funding described in par. (a) 3., the department  
10 of health services shall submit under s. 13.10 to the joint committee on finance a  
11 proposal to increase Medical Assistance reimbursement rates for current procedural  
12 technology codes for radiology and office visit services performed by chiropractic  
13 providers to the same rates at which those codes are reimbursed for physicians and,  
14 if any of the amount specified in par. (a) 3. remains after that increase, to increase  
15 Medical Assistance reimbursements for spinal manipulation performed by  
16 chiropractic providers.

17 (e) The joint committee on finance may supplement the appropriation under  
18 s. 20.435 (4) (b) from the appropriation under s. 20.865 (4) (a) if the joint committee  
19 on finance approves a proposal submitted under par. (b), (c), or (d). If the joint  
20 committee on finance approves a proposal submitted under par. (b), (c), or (d), the  
21 department of health services shall provide reimbursement or increase  
22 reimbursement rates in accordance with that approval.

23 (f) Notwithstanding s. 13.101 (3), the joint committee on finance may make a  
24 supplementation under this subsection without finding that an emergency exists.”.
