5 risk”.
- 6 **4.** Page 5, line 19: after that line insert:
- 7 “**SECTION 9m.** 813.12 (1) (ac) of the statutes is created to read:
- 8 813.12 (1) (ac) “Adult at risk” has the meaning given in s. 55.01 (1e).”.
- 9 **5.** Page 6, line 1: delete “ELDER PERSON PETITIONER. If the petitioner is an elder
10 person, the” and substitute “ELDER PERSON OR ADULT AT RISK PETITIONER. If the
11 petitioner is an elder person or an adult at risk, the”.

- 1 **6.** Page 6, line 7: delete “ELDER ADULT-AT-RISK” and substitute “ELDER ADULT AT
2 RISK OR ADULT AT RISK”.
- 3 **7.** Page 6, line 8: after “risk” insert “or adult at risk”.
- 4 **8.** Page 6, line 16: after that line insert:
5 “**SECTION 16m.** 813.125 (1) (am) 2m. of the statutes is created to read:
6 813.125 (1) (am) 2m. “Adult at risk” has the meaning given in s. 55.01 (1e).”.
- 7 **9.** Page 6, line 23: delete “ELDER PERSON PETITIONER. If the petitioner is an elder
8 person, the” and substitute “ELDER PERSON OR ADULT AT RISK PETITIONER. If the
9 petitioner is an elder person or an adult at risk, the”.
- 10 **10.** Page 8, line 12: after “**person**” insert “**or adult at risk**”.
- 11 **11.** Page 8, line 12: delete “section,” and substitute “section:”.
- 12 **12.** Page 8, line 12: after that line insert:
13 “(a) “Adult at risk” has the meaning given in s. 55.01 (1e).”.
- 14 **13.** Page 8, line 13: delete ““elder person” means” and substitute:
15 “(b) “Elder person” means”.
- 16 **14.** Page 8, line 14: after “person” insert “or an adult at risk”.
- 17 **15.** Page 12, line 18: after “**person**” insert “**or an adult at risk**”.
- 18 **16.** Page 12, line 18: after that line insert:
19 “(a) “Adult at risk” has the meaning given in s. 55.01 (1e).”.
- 20 **17.** Page 12, line 19: delete “(a)” and substitute “(b)”.
- 21 **18.** Page 12, line 20: delete “(b)” and substitute “(c)”.
- 22 **19.** Page 12, line 23: after “person” insert “or an adult at risk”.
